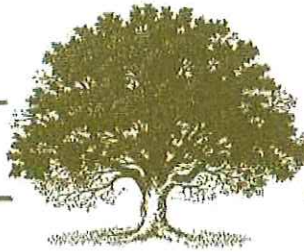


**PUBLIC HEARING NOTICE
TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM**

The City of Newark will hold a public hearing at 5:05 PM on October 23, 2018, at City Hall, 209 Hudson Street, Newark, TX regarding the submission of an application to the Texas Department of Agriculture for a Texas Community Development Block Grant Program (TxCDBG) grant. The purpose of this meeting is to allow citizens an opportunity to discuss the citizen participation plan, the development of local housing and community development needs, the amount of TxCDBG funding available, all eligible TxCDBG activities, and the use of past TxCDBG funds. The City encourages citizens to participate in the development of this TxCDBG application and to make their views known at this public hearing. Citizens unable to attend this meeting may submit their views and proposals to the City Secretary at City Hall. Persons with disabilities that wish to attend this meeting should contact the City Hall to arrange for assistance.
