Current Michigan Driver's License, If you have a temporary paper license-

You must have a GOVERNMENT ISSUED PHOTO ID

Current Temporary Instructional Permit- Eligibility Date is indicated on the permit

Deposit is good for 30 days only

Using your vehicle Current Registration for truck (and trailer) and Current Proof of Insurance

Equipment Failure- If the vehicle does NOT meet the standard requirements and can not be used for testing purposes, you will be charged a \$50 fee.

Banked Test Portions: If an applicant passes the vehicle inspection or basic skills test it will be considered banked for the duration of the Temporary Instruction Permit.

1. Cancellation Fee: Test must be canceled 2 business days prior to test the date.
2. Equipment Fee: Trucks and/or Trailers can NOT have a load
3. Late Fee: 15 min late or more, the test will be cancelled and charged
4. Using our vehicle is under all rental agreement for insurance purposes.

Class A CDL – Semi Tractor Trailer – 10 speed manual – air brakes – 53 foot trailer

Class A CDL – Semi Tractor Trailer – 10 speed automatic – 53 foot trailer

Class B CDL – Straight Box Truck – Freightliner – 6 speed manual transmission – air brakes

Manual Transmission – (E) Drivers who test in an automatic transmission will be restricted from driving a manual transmission vehicle.

Tractor/Trailer- (O) Drivers who test in a combination vehicle that is not a fifth-wheel tractor trailer will be restricted from driving one.

Air Brake – (L) Drivers who test in a CMV without air brakes will be restricted from air brake vehicles.
