November 1, 2022

6:00 p.m.

HYBRID MEETING- The regular meeting was called to order at 6:00 p.m. by Mayor Willey. C.M. Speer, C.M. Milanowski, C.M. McRoberts, C.M. Nichols, C.M. Dodd, Mayor Willey, Clerk/Treasurer Oster, and Attorney Unzelman. There were 11 citizens present.

A motion was made by C.M. Nichols and seconded by C.M. Speer to approve the agenda. Motion passed unanimously.

A motion was made by C.M. Speer and seconded by C.M. Milanowski to approve the minutes from the previous meeting. Motion passed unanimously.

A motion was made by C.M. Milanowski and seconded by C.M. McRoberts to Approve Blanket Voucher #202221 for Claim #'s 20730-20733 and 20744-20761 in the amount of \$201,149.20 and for Payroll #'s 20734-20737 and 20739-20743 in the amount of \$13,409.12 for a Grand Total of \$214,558.32. Motion passed unanimously.

A motion was made by C.M. Dodd and seconded by C.M. Milanowski to approve the purchase orders for \$821.19 including tax for service and repair of the Gravely zero-turn mower at the Powershop and for \$2350.00 plus tax for Motor Disconnect replacement at the WWTP by Advance Electrical. Motion passed unanimously.

A motion was made by C.M. Milanowski and seconded by C.M. Speer to approve the utility bill adjustments for Acct# 1249 a refund of \$142.50 for overpayment on the final bill and Acct# 1369 a credit of \$30.00 to waive a late fee due to the original bill not being received. Motion passed unanimously.

PUBLIC HEARING- The public hearing for the 2023 Preliminary Budget was called to order at 6:04 p.m. Clerk/Treasurer Oster explained the significant changes in the 2023 Budget. Danny Cox stated that he would appreciate new water lines by his home (Hill St. & Olive St). There were no other citizen questions or comments. The Public Hearing was closed at 6:09.
