



Minutes of the Regular Board Meeting  
October 15, 2019, 7:00 PM  
Held at Maple Lake Township Hall

The regular meeting of the Maple Lake Township Board was called to order by Chairman Tom Neumann at 7:00 PM.

Supervisor Greg Gindele, Treasurer Judy Neumann, Clerk Orin Manuel were present. Supervisor Ron Wolff was absent.

The minutes from the September 17, 2019 regular board meeting were read by Chairman Neumann. A motion was made by Gindele, seconded by Neumann to accept the minutes, as read. Motion carried 2 to 0.

Lacy Shrode of 4688 Culver Ave NW was present to discuss the plowing and maintenance of Culver Ave NW. The Supervisors discussed whether the road was a minimum maintenance road due to the fact that it is not wide enough to allow the Township's plow equipment to turn around at the end of the road. A motion was made by Gindele and seconded by Neumann to table further discussion on the matter until the Board could do additional research regarding the status of the road. Motion carried 2 to 0.

The Maple Lake Ice Fishing Derby applied for a liquor license for their ice fishing derby to be held in February 2020. A motion was made by Gindele and seconded by Neumann to approve the license for the Maple Lake Ice Fishing Derby and submit the necessary paperwork to Wright County. Motion carried 2 to 0.

Maple Lake Township was named in a court case brought by Mark S. Buss and Roberta J. Buss. Neumann offered a motion, seconded by Gindele to refer the case to the Township's attorney. Motion carried 2 to 0.

Troy Bremer's conditional use permit was presented by the county for review. After discussion regarding the business operated by Mr. Bremer on County Road 8, a motion was made by Neumann and seconded by Gindele to approve the conditional use permit without condition and set the date for the next review to be October 2020. Motion carried 2 to 0.

Steve Pederson of 4833 Crofoot Ave (Lake Sullivan) presented the Board with plans for a garage he would like to build on his property. The Board had discussion with Mr. Pederson, specifically, that the garage would be under the ground covering requirement and he responded that it would. Mr. Pederson also noted that he would be asking for Wright County for a setback variance on the garage. Neuman offered a motion, seconded by Gindele to refer the plan on to Wright County Planning and Zoning. Motion carried 2 to 0.

Don Nolan of 2631 62nd St NW is looking to get help with a drainage issue coming off the road surface onto his driveway. He asked the Board if the road surface can be adjusted so that the road drains to the ditch located on the opposite side of the road as his driveway. A motion was offered by Gindele and seconded by Neumann to table the issue and discuss options for correction the issue with the road surface. Motion carried 2 to 0.

Claims 934-963 and regular payroll claims were presented to the Board for approval and payment. A motion was offered by Neumann and seconded by Gindele to approve and pay the claims as presented. Motion carried 2 to 0.

As no additional business was brought before the Board, motion was offered by Neumann and seconded by Gindele to adjourn the meeting at 8:15 PM. Motion carried 2 to 0.
