

Minutes of the Regular Board Meeting March 15th, 2022 7:00 PM Held at Maple Lake Township Hall

The regular meeting of the Maple Lake Township Board was called to order by Chairman Tom Neumann at 7:00 PM.

Supervisor John Pederson, Clerk Esther Doran and Treasurer Judy Neumann were present.

The minutes from the February 15th, 2022 regular board minutes were read by Chairman Neumann. A motion was made by Pederson, seconded by Neumann to accept the minutes as read. Motion carried 2-0.

Checks 4096-4136 were presented to the Board for approval and payment. A motion was offered by Neumann and seconded by Pederson to approve and pay the checks as presented. Motion carried 2-0.

Jeremy Jurmu (106th St & Baker) came to discuss with the board about making a new road and if the township would take the new road over. The board felt at this time they wouldn't be able to make a decision since there aren't any definite plan yet for this project. The Supervisors recommended he call Wright County Planning and Zoning and see what all needs to be done.

Gayle Murray (5185 Clementa Ave NW) came to ask the board for a variance for her to be able to have more animals on her property. The board said since she doesn't have enough acres for more animals on her property, they declined her variance. Neumann and Pederson do not approve the request for additional animal units on this property.

Maxine Hedlund (7933 County Rd 8 NW). There was a motion made by Pederson, seconded by Neumann to approve the variance for the road frontage for parcel A to 289 feet. With the stipulation that there be no residential home built on parcel A. Also, for parcel B to allow one residential home on a 32-acre lot. Motion carried 2-0.

Dan Jarvis (Ames Ave) a new design for a driveway is being proposed for new parcels that are being sold on Ames Ave. There was a motion made by Neumann, seconded by Pederson to approve the new survey for parcel A & B to have a shared driveway. Motion carried 2-0.

Gravel bids were discussed. There was a motion made by Neumann, seconded by Pederson to approve Bjorklund's gravel hauling bid for the spreading and loading of 10,000 yards of gravel with belly dump trucks. To have it applied by June 3rd. The low bid was \$5.75 per yard. Motion carried 2-0.

Dust control bids were discussed. There was a motion made by Pederson, seconded by Neumann to approve Central Minnesota's dust control bid at .95 a gallon for 80,000 gallons at the rate of 30% of magnesium chloride. Motion carried 2-0.

There was a motion made by Neumann and seconded by Pederson to adjourn the meeting at 8:45 PM. Motion carried 2-0.
