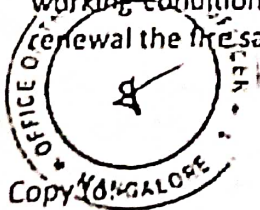

With reference to subject above cited, 'Fire Safety Recommendation' was issued vide reference (1) to the premises of St. Lawrence Indian School, CBSE School & Hostel building constructed at Sy.No.48/8 & 48/12, Mennabettu Village, Mulki Taluk, Dakshina Kannada District with a condition to fulfill the recommendations and compliance the same within 3 months.

With reference to the letter cited (2) above, the Management of St. Lawrence Indian School, CBSE School had requested for the compliance certificate from our department. In this regard District Fire Officer, Kadri, Mangaluru has inspected the school & hostel building on 16-04-2024 and 20-04-2024. The applicant has compiled all the recommendations communicated in our fire safety recommendation vide ref.(1) except training.

Under the above circumstances the Karnataka Fire & Emergency Services Department is issuing the 'Fire Safety Compliance Certificate' to St. Lawrence Indian School, CBSE School building, & Hostel building, subject to proper maintenance of fire fighting installations in good working conditions and to arrange the training of 40% of employees within 3 months and to renew the fire safety Recommendation report for every two year.
