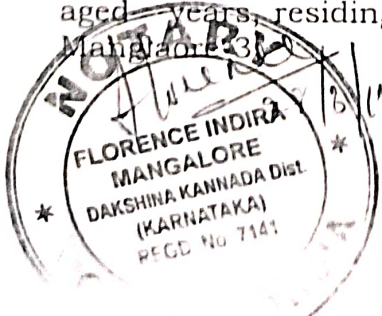
**SUPPLEMENTAL TRUST DEED OF BHARATH MATHA

Walter Stephen Mendes**, son of Basil Mendes, aged 43 years, residing at Mendes Plaza, Bunts Hostel Road, Mangalore-3, in his capacity as the authorised representative and Managing Trustee of the registered Trust namely the **Bharath Matha Educational & Charitable Trust (R) for Religious and linguistic Minorities** constituted as per the terms of a Trust Deed dated 18.07.2007 registered as document No.MGT-4-00054-2007-08 and as CD No.MGTD59 and entered in Book No.4 on the file of the Sub-Registrar of Mangalore Taluk and for the sake of convenience the same has been hereinafter referred to as the **Principal Trust**, as per the resolution approved in the meeting of the Board of Trustees held on 22-3-2014 at St.lawrence Indian School, Kinnigoli, Mangalore Taluk,

And Whereas the author of the Trust is also getting old and has not been working upto the satisfaction of the decision of the majority of the trustees,

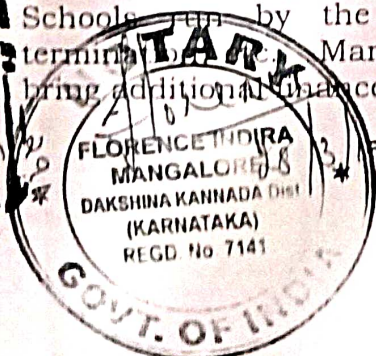
And whereas to better achieve the objects, to improve the quality of education and also to open additional educational courses, heavy financial arrangements are required and for that purpose the board of trustees in their meeting held on 10-10-2013 have appointed **Sri.Walter Stephen Mendes**, as the **Managing Trustee** of the Principal Trust,

And Whereas in view of some serious mis-deeds and irregularities committed by the author of the trust, the Board of Trustees in their meeting unanimously resolved to initiate legal actions against the author of the Trust,

And whereas in view of these and other developments in the trust, the board of trustees, in their meeting held on 22-3-2014 resolved to register this supplemental trust deed, with regard to the powers conferred upon the Managing Trustee namely Sri.Walter Stephen Mendes, and also appointment of a new correspondent for the two schools being run by the Principal trust and for this purpose the board has authorized Sri.Walter Stephen Mendes, the Managing Trustee, to sign and register this supplemental Trust Deed, now therefore, this Supplemental Trust Deed is executed and the same witnesseth as follows:-

1. Powers of the Managing Trustee:

That the Managing Trustee shall have all the powers to deal with the teaching and non-teaching staff members of the Schools run by the Trust, their appointments, their termination. The Managing Trustee is also empowered to bring additional finance into the Trust to achieve the objects

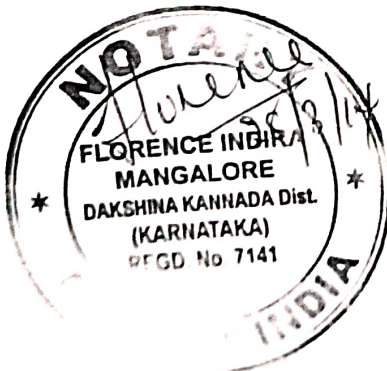

of the Trust. The Managing Trustee is also empowered to buy properties, construct buildings, open additional educational courses and also to apply for and obtain permissions to run and manage professional educational courses and for this purpose sign and execute the necessary applications, deeds, forms, bonds or do whatever that is required to be done so as to run, open and manage the educational institutions.

2. Bank Accounts:

It is the Managing Trustee and Life Trustee Florence Mendes jointly shall have all the powers to close the existing Bank Accounts standing in the name of the trust and open new bank accounts at any of the branches of the Nationalized Banks. All the cheques to be drawn in the name of the Trust shall hence forth be drawn/signed by Sri.Walter Stephen Mendes, the Managing Trustee and Florence Mendes the life trustee of the Trust only. Powers to sign and operate the Bank accounts previously vested with the Chairman of the Trust namely Sri.John Basil Sequeira have already been withdrawn.

3. Remuneration to the Trustees.

None of the Trustees are entitled to any remuneration from the Trust.

4. That clause no.4(a) of the Principal Trust deed dated 18-7-2007 is hereby deleted and the same is substituted by the following clause.

4a. That the Trust can have a maximum of 9 number of trustees with a minimum of 7 (seven) as it's trustees.

5. Mrs.Florence Mendes, the life Trustee of the Trust shall be the correspondent of the two schools run by the above Trust and hence forth, she shall discharge her duties as the correspondent of the Schools of the Trust and represent

the schools run by the Trust in all correspondences with the public.

6. The Managing Trustee shall preside over all the board meetings of the Trust. However for any reasons if the Managing Trustee is not available or remains absent, the correspondent shall preside over the Trust meetings."

7. In all other aspects the clauses in the original Trust Deed dated 18-7-2007 shall remain in full force with all it's effects.
