
open for discussion at our Sept meeting and a vote may be taken in Oct. If you want your voice heard, now is the time.

## Montford Point Marine who served in World War 2, Vietnam dies at 108

One of the first Black Marines - who served in the military during three wars - died Aug. 15 at the age of 108.

Cosmas D. Eaglin Sr. joined the Marine Corps at age 27 and served two years in the Solomon Islands campaign of World War II, according to Monday news release by the <u>North Carolina Department of Military and Veterans Affairs.</u>

North Carolina Gov. Roy Cooper said in the release, "He and his fellow Montford Point Marines defended our freedom against fascism in World War II and set an example at home that helped lead the progress toward racial equality that our country has made over the last 80 years."

The <u>Marines who trained at Montford Point</u>, North Carolina, were the first to break the color barrier in the Marine Corps following President Franklin D. Roosevelt's June 1941 executive order opening all of the military services to Black men. The men who came to the segregated post near Camp Lejeune, North Carolina, in 1942 endured racism and harsh treatment, the National <u>Museum of the Marine Corps</u> recounts.

By the time Montford Point was decommissioned in 1949, 20,000 Marines had trained there, according to the museum. Eaglin was one of the first 300 of those 20,000, according to a January news release from the North Carolina Department of Military and Veterans Affairs. After World War II, he exited the Corps, but during the Korean War he joined the Army and earned his paratrooper wings.

Eaglin lived in Fayetteville, North Carolina, starting in 1951. He served two tours in the Vietnam War in the 1960s, according to the release.

<u>For his 108th birthday in January</u>, Eaglin was presented with a certificate of appreciation and a challenge coin from the North Carolina Department of Military and Veterans Affairs, Marine Corps Times previously reported.

Retired Lt. Gen. Walter Gaskin, the department's secretary, said at the time, "Because he was a Marine, I am able to be a Marine."

"His contributions to the nation and the Marine Corps will be remembered and his legacy will live on for generations to come."

Eaglin had six children, seven grand-children and 12 great-grandchildren, according to the news release about his death.

### Do you need to apply for VA benefits? What to know before you file.

The Maryland Department of Veterans Affairs Service and Benefits Program provides assistance to the men and women who served in the Uniformed Services of the United States, their dependents, and survivors in obtaining benefits from the U.S. Department of Veterans Affairs, Department of Defense, State of Maryland and other programs for veterans and their families. In FY22, MDVA had a 90% approval rating for claims presented to the VA on behalf of veterans and family members. **All of our veteran benefits specialists are accredited by the VA.** 

#### WHAT DOES VA ACCREDITED MEAN?

The Department of Veterans Affairs (VA) accredits three types of representatives—Veterans Service Organization (VSO) representatives, attorneys, and agents—to help ensure that claimants have access to responsible and qualified representation on their VA benefits claims.

The VA Office of General Counsel maintains a list of VA-recognized organizations and VA-accredited individuals that are authorized to assist in the preparation, presentation, and prosecution of VA benefit claims at <a href="https://www.va.gov/ogc/apps/accreditation/index.asp">https://www.va.gov/ogc/apps/accreditation/index.asp</a>.

#### IS THERE A COST FOR ASSISTANCE?

It is important to know that VA-recognized VSOs, and their representatives, always provide their services on benefit claims free-of-charge. Unlike VSOs, VA-accredited attorneys and agents may charge you a fee for their representation in appealing or requesting additional review of an adverse VA decision. Only VA-accredited attorneys and claims agents may charge you fees for assisting in a claim for VA benefits, and only after VA has issued an initial decision on the claim and they have complied with the power-of-attorney and the fee agreement requirements.

MDVA veterans benefits specialists **DO NOT CHARGE** for services.

Unless otherwise noted, all MDVA Service Program offices are open Monday-Friday, 8:00-4:00, by appointment only. Please call an office near you to schedule an appointment in advance of visiting.

### 44 Attorneys General Agree with VFW to Pass GUARD Act:

The National Association of Attorneys General issued a letter on behalf of a bipartisan coalition of 44 attorneys general expressing support for the passage of the Governing Unaccredited Representatives Defrauding (GUARD) VA Benefits Act. The letter to congressional leaders stated, "The GUARD VA Benefits Act would remove the ability of unaccredited, unregulated, and often unscrupulous actors to target and prey upon those veterans with impunity. It holds them accountable not just to the law but also to the veterans and their families by giving them options for redress when they find themselves victims of those same actors."




#### **MIA UPDATE**

The Defense POW/MIA Accounting Agency announced six burial updates for service members who have been missing and unaccounted for from World War II, the Korean War, and the Vietnam War. Among those returning home for burial with full military honors is:

Marine Corps Capt Ralph J. Chipman, was assigned to Marine All-Weather Attack Squadron 533, Marine Attack Group 12, 1st Marine Air Wing. He went missing in action on Dec. 27, 1972, and was reported killed in action in July 1974. His burial date and location are to be determined

## The Red Dress Uniform



To differentiate themselves from the infantry, musicians—at that time, buglers and signal callers—would reverse the traditional colors. Today members of the ten Marine Corps field bands wear the standard Blue Dress uniforms, while the members of the <u>United States Marine Band</u> (The President's Own) and the <u>United States Marine Drum and Bugle Corps</u> (The Commandant's Own), both based in <u>Washington</u>, <u>D.C.</u>, carry on this tradition by wearing the Red Dress uniform, which features a scarlet blouse with blue trim. The Marine Band also wears blue trousers that have a white line bisecting 2 scarlet stripes on each leg.

Like the Blue-White Dress uniform, musicians are not authorized to wear the khaki shirts with the Red-Dress uniform. Should the condition warrant (e.g., summer heat), the band will wear a white shirt with the Blue Dress uniform trousers.
