Platoon level gender-integration 'critical' for Marines, committee says By Todd Smith Marine Corps Times, Mar 19

<u>A Pentagon committee</u> has recommended to the secretary of defense that the Marine Corps should train male and female recruits in gender-integrated platoons at both recruit depots.

The recommendations were part of the <u>Defense Advisory Committee on Women in the Services</u>, DACOWITS, which was released March 15.

The report also recommends mixed-gender drill instructor teams for all integrated companies at recruit training. "Maximizing integration, at the platoon level, develops the foundation of a successfully integrated force," according to the report.

The report noted that gender-integration at the platoon level is, "critical to dismantling negative stereotypes and fostering positive inclusion across an organization."

"Training separated by gender appears to have unintentional consequences to include perpetuating feelings that men are superior to women and promoting fear and suspicion of women," according to the report.



The Marine Corps is the only military service that does not integrate female and male recruits at the platoon level. It also has the <u>lowest percentage of female members</u>. Nine percent of the Corps is female, as compared to 23% of the Air Force, 22% of the Navy, 19% of both the Army and Space Force and 16% of the Coast Guard, according to the report.

Report authors commended the service for recent efforts to integrate at the company level. "However, the committee feels more integration is necessary to better prepare male and female recruits as they become Marines, to operate within an integrated operational force and to better align the Marine Corps with its service counterparts."

The report said that using segregated platoons, "reduces the opportunity for recruits to develop mutual respect and cohesion for one another during this formative training process."

The report quotes Brig. Gen. Walker Field, then-head of Marine Corps Recruit Depot-Parris Island, South Carolina, from a 2023 Associated Press report.

"We have established a tried-and-true manner by which we train Marines that proves effective in transforming young Americans," Walker said. "We break down their individuality and grow them as a team. We're adamant about that outcome. Having the platoon model is absolutely part of that."

But, the committee said, that means that the recruits remain largely separated by gender because most of the training activities are conducted at the platoon or squad level, which continues to physically separate the recruits by gender. The committee noted "vast differences in the level of integration" due to this setup during key events such as obstacle course runs and the Crucible, the culminating field event near the end of the 13-week recruit training.

The 2020 National Defense Authorization Act mandated that the Corps integrate recruit training at the platoon level. Congress gave the service's East Coast location five years to complete the integration and the West Cost facility eight years.

Governor Moore's Statement on Proposed Cyber Wing for Maryland Air National Guard

Governor Wes Moore released the following statement regarding the proposed cyber wing for the Maryland Air National Guard: "Maryland is home to the nation's most advanced cyber assets, and the expansion of the National Guard's mission is further testament to the vital work our men and women do for our national security as our country prepares to confront future challenges and adversaries.

The Maryland Air National Guard has flown A-10s since 1979, making it one of the most experienced A-10 units in the Air Force. Through innovative service, the men and women of the 175th Wing have more than 60,000 hours of combined flying experience, 12,000 hours of combat flying experience, and provide support for combat airpower, cyber warfare capacity, partner nations, home communities and the State of Maryland. Any new cyber wing must be fully resourced in order to build the facilities and train personnel.

In partnership with our congressional delegation, we are advocating vigorously to maintain Maryland's flying mission, both in the interest of national security and the hundreds of jobs and families that will be affected by this transition. We are disappointed to learn of the Air Force's decision to hurriedly retire the A-10 mission across the nation, including the mission at Martin State, without a plan to retain experienced pilots and maintainers or to replace older systems with advanced aircraft. We are committed to working with our federal partners at the White House and the Pentagon to acquire another flying mission in Maryland this year.

As Maryland's A-10s prepare to deploy later this month to the U.S. Central Command theater of operations in the Middle East, we thank our dedicated service members for their skill, readiness, and valiant service to fulfill their mission—at home and abroad."



FIRST AMPHIBIOUS LANDING



March 3, 1776: Today in Marine Corps history, the Marines descended on Fort Nassau in the Bahamas. The British military had been storing munitions in the

Bahamas for use against the colonies in the Revolutionary War. Initially, more than 200 barrels of gunpowder were moved from Virginia to the Bahamas by the British. Learning of the cache, the newly formed Continental Marines sailed to the Bahamas with 235 Marines and captured not just full stores of gunpowder, but also other weapons. The British surrendered within minutes after the Marines came ashore.



MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) hereinafter referred to as the Memorandum or MOU, entered into on the date signed below, by and between the American Legion Post 175, Severna Park, MD, hereinafter referred to as the "First Party" or the "Post" and the Anne Arundel County Detachment 1049, Marine Corps League, hereinafter referred to as the "Second Party" or the "Detachment", and collectively known as the "Parties", for the purposes of establishing an agreement for the Post to host future monthly meetings and other veterans related business of the Detachment.

Detachment 1049 is a relatively new and small veterans' organization, and currently looking for a permanent home. Since inception Detachment 1049 has relied on the generosity and hospitality of other organizations to host its meetings and other events. Detachment 1049 is pursuing to enter the herein described agreement with AL Maryland Post 175 in which they shall work together to accomplish the goals and objectives set forth.

I. BACKGROUND

The Marine Corps League (MCL) and the American Legion have similar missions to serve the veteran community:

- a. <u>The Marine Corps League</u> was founded in 1923 by MajGen John A. Lejeune. In 1937, the US Congress charted the League as a veterans service organization. The MCL has a current membership of approximately 30,000. The MCL maintains an IRS 501(c)4 non-profit status. The Detachment, which primarily serves the local Anne Arundel County, Maryland area was chartered in 2000 and currently has approximately 100 members.
- b. The American Legion (AL) was formally established on May 10, 1919 in St. Louis Missouri by executive committee comprised of seventeen WWI veterans including Lieutenant Colonel Theodore Roosevelt Jr. And Sergeant Alvin C. York. The AL has a current membership of approximately 2 million members, the Nation's largest wartime veteran service organization. Post 175 has over 575 members, serving veterans in the local community and beyond.

II. PURPOSE

The purpose of this MOU is to establish an agreement between the two Parties where the Post will function as the host location for the various activities of the Detachment. These activities include, but are not limited to the following:

- a. The Detachment's monthly meeting on the third Monday of each month.
- b. The periodic hosting of the MCL Department of Maryland quarterly meeting. This statewide meeting is rotated among the various detachments in the state. This meeting includes a separate smaller meeting space for the MCL Auxiliary.

- A springtime Leadership College. This event draws about 50 participants from throughout the northeast.
- Various fundraising activities such as an annual Bull & Oyster Roast.
- e. The birthday celebration of the US Marine Corps on 10 November.

III. SCOPE

- A. As the host location, the Post agrees to:
 - a. Provide meeting space as discussed above.
 - b. Provide location for Detachment to emplace a secure storage space for the Detachment's property. The purchase, delivery, and maintenance of the storage container/shed will be at the Detachment's expense.
 - c. Provide indoor storage space for the Detachment's Colors
 - d. Provide a location within the Post to display the Detachment's charter, awards, and memorabilia.
 - e. If a display case is required, it shall be at the Detachment's expense.
- B. As the guest organization at the host location, the Detachment agrees to:
 - Work closely with the Post's calendar coordinator to schedule all events and activities.
 - b. Support the activities of the Post to the greatest extent possible.
 - c. Abide by the Post's standards of conduct.
 - d. Provide a representative to attend appropriate meetings of the Post.
- C. Both Parties agree to keep an open and professional dialogue and to exchange appropriate contact information to facilitate the flow of information. At a minimum, the contact information should include the commanders, executive committees or staffs, and calendar coordinators. (Attachment A). The Detachment Commandant and Post 175 Commander will communicate often initially, until recurring Detachment activities are routine and harmonized within the busy schedule of the Post.

IV. COMMON OBJECTIVES

- A. As both Parties share the common goals of supporting veterans and their families and community service through volunteerism, the Parties are encouraged to support each other in the pursuit of these goals.
- B. The Parties shall endeavor to work together to establish policies, procedures, and programs that will promote and sustain membership in both organizations. The Detachment shall encourage its members to frequent the Post and consider membership in the American Legion, if so qualified. Conversely, the Post will permit the Detachment to solicit qualified members for membership in the MCL.

V. MILITARY ORDER OF THE DEVIL DOGS

- A. The Military Order of the Devil Dogs (MODD) is a national independent subsidiary of the MCL. It is the "fun and honor society" of the MCL. Members of the MODD must be regular members of the MCL, nominated by two current MODD members, and approved by their respective detachment commandant. There are about 6,000 members nationally.
- B. The local unit of the MODD is Hound Dog Pound 204. The Pound is comprised of members from several different detachments including the Anne Arundel County Detachment 1049. Presently, Pound 204 meets quarterly on Sunday mornings.
- C. Should Pound 204 also wish to change their base location to Post 175, the Post would give it favorable consideration.

DURATION

This MOU is at-will, but may be modified by mutual consent of authorized officials (undersigned) or their duly elected replacements. This MOU shall become effective upon signature by the authorized officials from the (list partners) and will remain in effect until modified by mutual consent.

AUTHORIZATION AND EXECUTION

The signing of this MOU does not constitute a formal undertaking, and as such it simply intends that the signatories shall strive to reach, to the best of their abilities, the goals and objectives stated in this MOU.


