Officers for 2012

Officers were elected as follows: Charles Backes- President, Chris Sanders- Vice President, Mike Williams-Secretary, Robert McGeehan- Treasurer, Tim Davis- Member At Large.

Old Business

- Discussion of the Annual Meeting
 Recommended that the association accountant be present and answer questions about financial decisions related to the Treasurer's report. Charles sent a letter to Francis Lake Baptist Church with a donation for the use of their fellowship hall for our meeting.
- 2. Discussion of Past Spring Events
 - a. Yard Sale- The board decided to have one yard sale a year in the spring. Charles will post this on the website and in an e-mail to the neighbors stating our decision.
 - b. Sunset Celebration- was a success, although the number of attendees was rather small in number. Several board members were out of town. The group that was there suggested that they bring their own snacks and finger food instead of asking the board for funds for it. The board decided to start it earlier in the evening for the next Sunset Celebration. Also voted to have this event two times per year and will discuss the timing of the event at the next meeting. The board decided to continue placing a port-A-potty at all events.
- 3. Update on Unpaid Assessments. Agreed to send out a final letter to the owners who have not paid their dues to allow payment without legal fees. This letter will inform delinquent account owners that this is their last chance to pay before the account is handed over to an attorney for collection. At that point a \$25 legal fee will be assessed in addition to accrued interest. Robert noted that four property owners are in foreclosure and that he is working with the realtors to collect the dues.

New Business

- 1. Cypress Lakes Trails Membership in Association. The board agreed to send out a letter to the 11 property owners on Cypress Lake Trail that are required in their deeds to participate in the home owners association. The letter will state that this year is transitional. The property owner may join for the remainder of this year by paying a \$50 fee on July 1, 2012. Starting on January 1, 2013 the 11 property owners will be required to join the association. The letter will tell them their privileges of being a member. The board discussed inviting other property owners in Cypress Lakes Trails to join the association but decided against doing so at this time.
- 2. Water Park and Pump Update. Chris Sanders will work on the water park sprinkler head that puts out too much water. Fences are around the pump and water park equipment. Padlacks have been placed on both gates. A dry box with poison to kill ants has been placed within the fence surrounding the pump.

He suggested the board members put poison on ant beds if they see them while using the park to eliminate ants.

- 3. Park Improvements and Additions. Tim Davis will spearhead the work on the path around the park by June 1. He will ask neighbors to help along with Guy and Kirk. The board discussed the benefits of the park, including providing a visual border around the property. Tim will also organize a neighborhood work day to help clear the park grounds of vines and weeds near the trees. Tim asked the board to approve setting up horseshoe pits for the use of the owners. The board agreed and gave Tim permission to purchase the equipment needed to complete the installation. Charles suggested that we consider a 9 hole disc golf course in the park. This was discussed but was tabled. Several events were discussed but the board said that park improvements and maintaining the entrances were our priority. No new events were planned.
- 4. Summer Kids Activity. The board decided that they would not organize an end-of-school activity for children at the park. Charles will send out in an e-mail informing volunteers that if they would like to organize and implement an activity of these type, that the association could fund and publicize it pending approval.

5. Other Items.

- a. The board discussed burning trash and other piles in the neighborhood. Residents will be reminded that the county has laws concerning when yard waste can be burned and that a permit is required. At no time should garbage or other items other than yard waste be burned. Residents are urged to contact the Lowndes County Fire Department if violations are observed.
- b. Charles will pay the website subscription as they are now due.

However, the board discussed ways to help with the shortage and identified areas that would be less including lawn maintenance, legal fees, and insurance.
