**The Charities and Non Profit Organisations (Sark)
(Exemption) Regulations, 2024**

THE POLICY & FINANCE COMMITTEE, in exercise of the powers conferred on it by section 10 of, and paragraph 13B of the Schedule to, the Charities and Non Profit Organisations (Registration) (Sark) Law, 2010^a, and of all other powers enabling it in that behalf, hereby orders: -

Exemption from governance obligations.

1. (1) An international organisation within paragraph 2 is exempt from the governance obligations in Parts II and III of the Schedule to the Charities and Non Profit Organisations (Registration) (Sark) Law, 2010 ("**the Schedule**").

(2) The following international organisations are within this paragraph –

(a) the Royal British Legion (Sark Branch), and

(b) any international organisation that falls within the definition at paragraph 2(5) of the Schedule by reason of the fact that it receives or has received donations, funds or other assets or other forms of assistance from parties outside the Bailiwick, in circumstances where both the conditions at paragraph (3) are satisfied.

(3) The conditions referred to in paragraph (2)(b) are that the organisation in question –

(a) was a registered organisation at the date of the coming into force of these regulations, and

(b) would not constitute an international organisation if it did not receive or had not received the donations, funds or other assets or other forms of assistance referred to in paragraph (2), and the relevant donations, funds or other assets or other forms of assistance are or were not significant donations, funds or other assets or other forms of assistance within the meaning of paragraph 7E(3) of the Schedule.

(4) Expressions in this regulation have the same meanings as in the Charities and Non Profit Organisations (Registration) (Sark) Law, 2010.

Citation and Commencement.

2. These Regulations may be cited as the Charities and Non Profit Organisations (Sark) (Exemption) Regulations, 2024 and shall come into force on 26th April, 2024.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations provide exemptions for certain international organisations from the governance requirements applicable to international organisations under the Charities and Non Profit Organisations (Registration) (Sark) Law, 2010.

The Regulations shall come into force on 26th April, 2024.
