DETAIL:

1) On 11/1/2021 at approximately 1830 hours I along with Sgt. Estes contacted Mack Magill, HOA president for Windmill Ranch, in regards to a security camera that was broken.

2) I along with Sgt. Estes met with Mack at the entrance to Windmill Ranch by the mail boxes. Mack showed us the broken camera that was hanging down in the middle of the covering for the mail boxes. Mack stated to us that he caught on camera before it was broke a black truck pulling an RV. The RV's A/C unit hit the camera as it was being pulled through. Mack was not able to obtain the license plate for the truck pulling the RV but he did get the license plate of the RV. A check of the RV license plate, B542356, through COPsync showed the owner living in San Marcos. Mack did not recognize the name to live in the neighbor hood. Mack stated he was going to go back home and try all the different angles to try and get a good visible image of the truck's plate. Unknown amount to secure camera back up.
