

# FDI Fastener Distributor Index

## Report Based on Monthly Distributor Input

The Fastener Distributor Index has been developed by The FCH Sourcing Network in conjunction with the NFDA (National Fastener Distributor Association) and data is analyzed by David J. Manthey, CFA of R.W. Baird to measure the operating conditions and sentiment within the North American industrial fastener distributor sector. The FDI is compiled monthly from survey input provided by qualified distributors. Results are published on Fully Threaded Radio by Mike McNulty of Fastener Technology International Magazine. A historical graph of the index is provided below.

The seasonally adjusted Fastener Distributor Index (FDI) for November was 54.5, moderating slightly from last month but remaining in growth range. The sales index, however, showed some modest improvement m/m as sales were slightly above normal expectations for the seasonally slower month of November. Looking forward, the Forward-Looking Indicator (FLI) retreated moderately but still remains well above 50, seemingly boding well for future demand conditions. Taking the FDI and FLI together, we believe November fastener market conditions showed continued m/m improvement but at a slightly lower rate than October.

The FDI has been developed as a service to the fastener industry and to the wider business community it serves. All survey data collected is maintained in strict confidence and is compiled for publication in index form by **R.W. Baird & Co.** No information collected or compiled through the **FDI** monthly survey is not shared, sold or otherwise used outside the scope of the index.

This website can be accessed securely by registered users during the monthly open survey period, which occurs during the last week of each month. Registered users receive email reminders at the start of each open survey period.

Anything above 50 indicates growth, below 50 is retraction. With a reading of 54.5, the pace and sentiment of the fastener industry remained strong during the month, but moderated off the 56.5 spike in October, seasonally adjusted. 

Survey responses reflect the change, if any, in the current month compared to the previous month. For each of the indicators measured (New Orders, Backlog of Orders, New Export Orders, Imports, Production, Supplier Deliveries, Inventories, Customers' Inventories, Employment and Prices), the report shows the percentage reporting each response, the net difference between the number of responses in the positive economic direction and the negative economic direction, and the diffusion index. A PMI™ reading above 50 percent indicates that the manufacturing economy is generally expanding; below 50 percent indicates that it is generally declining.
