GENERAL LIVESTOCK RULES AND REGULATIONS

INTERPRETATION AND VIOLATIONS OF RULES

The Austin County Fair Association's Executive Committee reserves the final and absolute right to interpret these rules and regulations and to determine the matters in regard thereto and the right to amend or add to these rules as its judgment may determine. Conduct deemed unacceptable by the Executive Committee may result in the expulsion from the grounds and further Austin County Fair sponsored activities. Any exhibitor who violates any of the following rules will forfeit all privileges and premiums, and he/she shall be subject to such penalty as the Executive Committee may order.

All exhibits will be under the control of the Board of Directors but the organization will in no case be responsible for any loss or damage that may occur. Each exhibitor will be solely responsible for any consequential or other loss, injury or damage done to or occasioned by, arising from any animal exhibited by him/her. He/she shall indemnify the organization against all legal or other proceedings in regard thereto, as well as damage to any of the animals exhibited by him/her or arising out of or in any connection with such exhibitors or any of the animals solely exhibited. All protests must be filed in writing at the Fair Office with a non-refundable fee of \$250 per exhibitor.

ALL ENTRIES IN THE LIVESTOCK AND POULTRY DIVISIONS OF THE AUSTIN COUNTY FAIR MUST COMPLY WITH THE TEXAS ANIMAL HEALTH COMMISSIONS REGULATIONS AND ANY REGULATIONS DEEMED NECESSARY BY THE AUSTIN COUNTY FAIR ASSOCIATION AND ITS BOARD OF DIRECTORS

GOVERNING ADMISSION OF LIVESTOCK INTO SHOWS, FAIRS AND EXHIBITIONS.

INTERFERENCE WITH JUDGES

If an exhibitor or parent in any way, whether in person or by agent or servants, interferes with the judges during their adjudication or as a result of the show, shows any disrespect toward them or the show, the management may demand a proper apology from such exhibitor or it may also withhold from such exhibitor such premiums that may have been awarded or take such steps as they deem necessary. This includes **remarks spoken**, in print or in **electronic format that are deemed derogatory or defaming to Judges**, Livestock Officials and/or committee members

All judge's (including sifting judges) decisions and weights are final.

RULES AND REGULATIONS

1. ENTRY PROCEDURE:

Exhibitors will go to the Austin County Fair's website (www.austincountyfair.com). Click on "Online Entry" tab & follow step by step instructions to complete entry form. Payment must be made online during this transaction. Exhibitors will need their Social Security number and access to some type of payment form to complete entry. Online entries will be open from 8:00 a.m. on August 1st to August 30th, 2024 at 5:00 p.m. Extension Agents & FFA teachers will be granted access to verify exhibitor's eligibility to show in the 2024 Austin County Fair after online entries close.

When completing entry, only <u>MAILING</u> address is needed. In addition, <u>ONLY parent(s)/guardian(s) listed</u> on the entry will be given any Youth Auction Sale/Add-On checks. If either parent or more than one guardian can

pick-up the check, both names need to be listed on online entry. **Phone number** and **email address** listed should be that of **parent(s)/guardian(s)** as this is how the Fair will communicate to Exhibitor families for work assignments or any other necessary communications.

Late entries turned into the fair office from August 31-September 6, 2024 will be charged all standard entry fees and will be assessed an additional \$250 fee per entry.

Entries turned into the fair office from September 7 – September 13, 2024 at 5:00 pm will be charged all standard entry fees and will be assessed an additional \$500 fee per entry. No entries will be accepted after 5:00 p.m. on September 13, 2024.

- All exhibitors must be permanent residents in Austin County or be enrolled in a public school, private school or home school in Austin County and enrolled in a 4-H or FFA Chapter in Austin County and not have graduated high school in order to exhibit at the Austin County Fair.
- 3. If an exhibitor EXHIBITS an animal at an adjacent county fair within A CALENDAR YEAR OF the Austin County Fair, then he/she is ineligible to show or sell another market animal at the Austin County Fair. This does not include major shows.
- 4. All exhibitors and their families will respect judges, committee members, Austin County Fair volunteers, and staff, as well as other exhibitors and their families. No disrespect will be tolerated on the Austin County Fairgrounds.
- 5. Family tagging and tattooing will be allowed in 2024. This will be interpreted as immediate family living in the same household. This rule applies to Market Steer, Halter

Heifer, Commercial Pen of Heifers, Market Lambs, Market Swine, Market Broilers, Market Turkeys, Market Goats, Home Bred & Owned Meat Pen Rabbits, and Horse divisions.

COMMERCIAL PEN OF HEIFERS TAG-IN DATE:

Fri., May 10, 2024, Four County Auction in Industry, 5:00-7:00 p.m. Exhibitors will be charged \$20.00 per animal tagged and a \$55 validation fee per pen.

MARKET STEER & HALTER HEIFER TAG-IN DATE:

Sat., May 11, 2024, Four County Auction in Industry, 7:00-10:00 a.m. Exhibitors will be charged \$20.00 per animal tagged.

MARKET SWINE TAG-IN DATES ARE:

Saturday, June 29, 2024, Fairgrounds in Bellville, 6:00-8:00 a.m. Saturday, July 13, 2024, Fairgrounds in Bellville, 6:00-8:00 a.m. Exhibitors will be charged \$15.00 per animal tagged.

ALL MARKET SWINE MUST BE PROPERLY IDENTIFIED WITH EAR TAGS BY SATURDAY, JULY 13, 2024

MARKET LAMB & GOAT TAG-IN DATES ARE:

Saturday, June 29, 2024, Fairgrounds in Bellville, 7:00-8:30 a.m. **Thursday, July 11, 2024**, Fairgrounds in Bellville, 6:00-7:30 p.m. **Exhibitors will be charged \$20.00 per animal tagged.**

ALL MARKET LAMBS& GOATS MUST BE PROPERLY IDENTIFIED WITH EAR TAGS BY THURSDAY, JULY 11, 2024.

6. All exhibitors of Market Swine, Beef Cattle, Market Lambs, Market Goats, and Market Rabbits will be required to complete a validation form (not an entry card) when the animals are tagged. Exhibitors of Market Broilers and Market Turkeys will be required to complete

an information sheet (not an entry card) when ordering. The form will include a statement as to the physical location of the animal with a release stating that this is for committee use in project visits.

- All families of exhibitors who SHOW OR SELL in the 7. Livestock Division of the Austin County Fair are required to provide two adults to work a minimum of three (3) full hours each (total of 6 hours) at either the entrance gates or refreshment facilities. Families with 3 or more exhibitors showing will be required to work an additional 3-hour shift (one adult only) in addition to the 6 hour shift requirement. Families choosing not to work their full shift(s) will be assessed a fee of \$750.00 per *family.* Work assignments must be fulfilled by at least one parent/guardian and another adult over 18 years of age. You must notify the fair office if you choose not to work in order for the exhibitor to be eligible to show or sell. You may make payment to the Austin County Fair or the fee will be deducted from exhibitor's check. THIS RULE DOES NOT APPLY TO 4-H, FFA CONCESSIONS or YOUTH AUCTION SALE. Funds will be deducted from exhibitor's checks for parents that do not work their FULL scheduled shift.
- 8. All market animal exhibitors will be allowed as many entries as desired, but can only present to the sifting committee a maximum of two sale animals and may only sell one. In the Market Steer, Market Swine, Market Lamb, Halter Heifer, Market Goat and Horse divisions, an exhibitor may have two entries with no back up animal. If an exhibitor shows two entries in a division, he/she will be ineligible to show in any other division, excluding Scramble Heifers and Breeding Rabbits. Market Broiler, Market Turkey and Market Rabbit exhibitors may have one entry in these divisions with one back up entry. No

back up entries are to be unloaded if first animal passes sifting. Exhibitors will only be allowed to enter and show ONE PEN of Commercial Pen of Heifers, therefore exhibitors will be allowed to show an animal in another division if they choose. Market Broiler, Market Turkey and Market Rabbit exhibitors will be eligible to show one other entry in another division. Scramble Heifer and Breeding Rabbits are not considered market animals, therefore an exhibitor may enter two sale animals along with the Scramble Heifer or Breeding Rabbits, but may only sell one market animal. NO ENTRY FEES WILL BE REFUNDED.

- 9. Exhibitors feeding at a location other than their own home must bring it to the attention of the Livestock Superintendent and/or show officials at the time validation sheets are due or any time this changes.
- 10. If an exhibitor has two (2) entries that qualify for the sale, he/she has the right to choose which entry will be sold with the exception of Champion and Reserve in the species, which must sell. In the event that the same exhibitor has Champion or Reserve in the same and/or different species, that exhibitor is only allowed to sell one Champion animal.
- 11. All animals (including poultry and rabbits) leaving the Fairgrounds prior to Sunday move out must obtain a signed release form from the committee chairman unless part of sifting procedure. Forms may be obtained at the Fair Office.
- 12. All Market Steers and Halter Heifers must be halter broken and easy to handle by the Mandatory Progress Show on **Saturday**, **August 10**, **2024**.

- 13. All animals and poultry must be in their assigned place on time according to the daily schedule. They must be kept in their assigned places until designated move-out time on **Sunday, October 13, 2024**, unless released by a division chairman or superintendent. Broilers, Rabbits and Turkey will be released at 8:00 a.m.; all other species must be kept in their assigned places until 11:00 a.m. on **Sunday, October 13, 2024**, unless released by a division chairman or superintendent. Removal of animals without a release from the division chairman or superintendent will result in the possible forfeiture of sales proceeds and/or prizes.
- 14. Livestock exhibitors will be permitted to display a sign over each exhibit advertising the exhibitor's herd; however, they may be no longer than the standard exhibitor stall or pen and must be approved by the species superintendent. NO FOR SALE SIGNS PERMITTED.
- 15. All exhibitors will be required to bring their own feed, hay, water buckets, etc. to the show.
- 16. All cords & hoses not in use need to be buried and not stretched across aisles. No frayed cords allowed. All cords & hoses must be in good condition. Any cords or hoses stretched across aisles or frayed will be disconnected. An attempt will be made to find the owner; but after that, they will go into the Livestock Office to be claimed by the exhibitor by the end of the Fair. All cords & hoses left after the end of the Fair will become the possession of the Austin County Fair Association.
- 17. All exhibit areas are to be kept clean during visitor hours. Animals, including poultry and rabbits, must be fed and cleaned each morning. A \$100.00 fee will be deducted from the exhibitor's sale check if the area is not maintained or cleaned upon move out.

- 18. DRESS CODE All exhibitors must wear appropriate clothing while in the show ring and the sale ring. Any exhibitor whose wardrobe is deemed inappropriate by Committee Chairperson or Livestock Superintendents may be disqualified from the show.
- 19. UNETHICAL FITTING AND SHOWING OF LIVESTOCK: Unethical practices performed on any livestock entry or entry form in order to deceive judges or the sifting and project committee members is prohibited, and the exhibitor shall be barred from this show and all future shows. Unethical practices will be determined by the Executive Committee of the Austin County Fair Association with assistance from anyone deemed necessary.
- 20. All entries will be exhibited and sold by their owners unless he/she is physically unable to do so or if the exhibitor has more than one entry showing in different divisions at the same time. Exhibits to be shown or sold by someone else other than the owner must be approved in writing by the respective committee chairman. It is the responsibility of the exhibitor to obtain and complete the required form. Forms will be available at the Fair Office. The ONLY permissible excuses for "physically unable to do so" are a DOCUMENTED medical or family emergency and/or DOCUMENTED and sanctioned school function of which the exhibitor is a PARTICIPANT.

If an exhibitor is **academically ineligible** to show, the exhibitor AND THEIR PROJECT are ineligible to participate in the Austin County Fair.

21. All animals in this show and sale must have been fed and cared for by the exhibitor in an approved location of the show. If the exhibitor does not meet the qualifications

- above, the exhibitor will be disqualified from the show and sale.
- 22. The feeding and care of all livestock projects are the sole responsibility of the exhibitor and their family from the beginning of the project until the animal leaves the fairgrounds. All livestock exhibitors will continue to feed, water, and clean the stalls/pens of their projects through dismissal on Sunday after the Fair or until delivered per buyer's direction. Any exhibitors not doing so will forfeit their Youth Auction Sale and Add-On checks to the Austin County Fair Association Memorial Scholarship fund.
- 23. Resale list is final.
- 24. No Pass Out (PO) will be allowed in any department.
- 25. All animals will be subject to use during the Livestock Judging Contest on **Saturday, October 12, 2024**.
- 26. All exhibitors must be entered through the fair website by **August 30, 2024 by 5:00 p.m**.
- 27. Quality Counts: In keeping with the Austin County Fair drug residue avoidance policy, ALL exhibitors are now required to pass the Quality Counts Verification test for entry into the 2024 Show. Junior market and breeding show entries will not be accepted without verification code for each exhibitor. Verification codes are not required for Agricultural Mechanics exhibitors and Judging Contest contestants. The Quality Counts training and test can be found at:

- 28. When Youth Auction Sale checks are ready, exhibitors will be contacted. In order to receive their check,

exhibitors must bring <u>STAMPED</u> and <u>ADDRESSED</u> <u>HANDWRITTEN</u> thank you notes to their buyers and add on donors to the Fair Office. Once the Fair Office has checked their thank you notes, exhibitors will seal them and then receive their check. Only parent(s)/guardian(s) listed on the entry form will be allowed to pick up checks for exhibitors.

- 29. In order to cash the Youth Auction Sale checks, the EXHIBITOR must endorse the check. Exhibitor will have 30 days after checks are printed to turn in thank you notes and pick-up checks. After this time period, the Sale and Add-On monies will go to the Austin County Fair Scholarship fund.
- 30. If an exhibitor family owes money to the Austin County Fair Association, their Youth Auction Sale check will be withheld until payment of outstanding balances. This must be handled prior to 30 days after checks are printed. Please refer to rule above.
- 31. These rules are current as of publishing. Any updates will be posted on the Fair website. Please consult www.austincountyfair.com for any changes.

RELEASE OF LIABILITY & INDEMNITY, AND DRUG CERTIFICATION

As valid consideration for entry into and participation in the Austin County Fair, the Exhibitor and his/her Parent or Legal Guardian, enter into this RELEASE OF LIABILITY & INDEMNITY and DRUG CERTIFICATION AGREEMENT.

The owner and/or exhibitor (if a minor, the parent or legal guardian of the minor) acknowledges that there are inherent risks in regard to livestock show activities and equine activities. These inherent risks include the risk of death or bodily injury due to: (1) the propensity of equine or livestock animals to behave in ways that may result in personal injury or death to a person on or around it; (2) the unpredictability of an equine or a livestock animal's reaction to sound, a sudden movement, or an unfamiliar object, person, or other animal; (3) a collision with another animal or object; (4) the potential of a participant to act in a manner that may contribute to injury to the participant or another, including failing to maintain control over the equine or livestock animal or not acting with the participant's ability; (5) with respect to equine activities, certain land conditions and hazards, including surface and subsurface conditions. I, as an owner, participant/exhibitor (or in case of a minor, the parent or legal guardian of a participant or exhibitor) hereby acknowledge that I assume the risk of all injury and/or death or property damage through participation in the show. event, rodeo or fair and as a participant and/or exhibitor, even if the injury or death or property damage is caused in whole or in part by the negligence of the sponsor or the Austin County Fair Association (herein after called the "Fair") or Lisa Lynn Mewis Cannon, including, but not limited to any alleged defects in the premises. (The "Fair" means the Austin County Fair Association,

including its officers, directors, agents, servants and/or employees).

RELEASE

I do hereby agree to fully release (if a minor, the parent or legal guardian do hereby agree) the sponsor of the event, Lisa Lynn Mewis Cannon and the Austin County Fair Association, including its officers, directors, agents, servants and/or employees (hereinafter called the "Fair") from any and all claims of any kind or character for personal injury and/or death arising in any way and/or manner out of my presence on the fairgrounds, Harold Luhn Livestock Barn, Livestock Barn, Koerth Arena, or Horse/Poultry Barn and/or my engaging in participation and/or exhibiting activities. This Release shall apply regardless of whether or not injury and/or death are caused in whole or in part by the negligence of Lisa Lynn Mewis Cannon, the "Fair", or sponsor of the event.

INDEMNITY

I, on behalf of myself, my heirs and representatives (if a minor, the parent or legal guardian of the minor) do hereby agree to fully indemnify and hold harmless the "Fair", Lisa Lynn Mewis Cannon and the sponsor of the event, of and from any and all claims of any kind or character for personal injury and/or death or property damage arising in any way out of participation or presence at the fairgrounds, Harold Luhn Livestock Barn, Livestock Barn, Koerth Arena, or Horse/Poultry Barn and/or as an exhibitor at the Fair or event sponsored on any of the aforesaid properties, regardless of whether or not such injury and/or death or property damage is caused in whole or in part by the negligence or other conduct of the "Fair", Lisa Lynn Mewis Cannon or the sponsor of the event.

DRUG CERTIFICATION AGREEMENT

The undersigned certify that each has read, understands, and will abide by the current Austin County Fair Junior Livestock Rule Book and all rules and regulations of the Austin County Fair Association (ACFA). Furthermore, the undersigned certify that all entries will be FREE OF ALL DRUG AND CHEMCIAL RESIDUES upon arrival to Austin County Fairgrounds and will remain free of all drug and chemical residues while on show grounds. We, the undersigned, understand that the time it takes for drugs and chemicals to be entirely excreted from the body through urine of animals is generally longer than the labeled FDA and USDA withdrawal times for most approved drugs and chemicals.

Veterinarians/Medication: If an animal requires emergency treatment while on show grounds, only the Official ACFA Veterinarian will be allowed to administer any drug, chemical or feed additive and a written medication record must be filed. All treatment costs are the responsibility of the exhibitor. Animals receiving performance-enhancing drugs (e.g. steroids, diuretics, anti-inflammatories, tranquilizers and painkillers, etc.) in this manner are ineligible for competition. Each year, the Austin County Fair Association solicits the services of a licensed veterinarian to serve in the capacity as the "Official Fair Veterinarian". The need for a substitute veterinarian may arise from time to time due to the unavailability of, or conflicts that may arise with the Official Fair Veterinarian. Any actions or decisions of the Official Fair Veterinarian or substitute veterinarian will be considered to be the veterinarian's professional judgment for the

best interest of the animal's health and well-being. An exhibitor may choose a licensed veterinarian other than the Official Show Veterinarian, but the Official Show Veterinarian MUST be notified in advance and he/she MUST be present during treatment.

The Official ACFA Veterinarian, reserves the right to treat any animal if, in the opinion of the Official ACFA Veterinarian, it is in the best interest of the animal's health and well-being to be treated. If an animal is treated by the Official Veterinarian while at the Show then the exhibit must then be held a sufficient time, typically the withdrawal period, by the exhibitor prior to slaughter as recommended by the Official Veterinarian.

ALL GRAND AND RESERVE CHAMPIONS WILL BE DRUG TESTED ALONG WITH ONE RANDOM ANIMAL FROM EACH SPECIES IN THE ACFA JUNIOR LIVESTOCK SHOW.

The Exhibitor agrees to submit any animal, breeding and/or market entered by him/her to inspection by any veterinarian or testing agency appointed by the ACFA and agrees to have such animal submitted to such tests as may be requested at any time. ACFA reserves the right to have ultrasound, D.N.A., blood, tissue, feces and/or urine laboratory analysis made on any animal entered for competition. The Exhibitor, including his/her Parent or Legal Guardian, must be present during the collection for testing. The conclusions reached by the testing agency and analysis shall be final and conclusive without recourse against ACFA or any officer, director, employee, independent contractor or agent thereof, even if the source of the Drug is unknown, including without limitation, any veterinarian or testing agency appointed by the ACFA. ACFA maintains a **ZERO TOLERANCE** policy, therefore the exhibitor waives any right of action or formal protest which he might have for any action taken under these rules.

As breeding animals (Colts, Commercial Heifers and Pen Heifers) are not entering the food chain, the USDA Wholesome Meat Act

does not apply; however, breeding animals will be closely screened for any performance-enhancing compounds. This includes, but is not limited to, steroids, diuretics, anti-inflammatories, tranquilizers and painkillers. All horses must be shown free of a prohibited substance (medication) in accordance with AQHA Rule 441 (H) or forfeit its sale check and all other awards. Non-sale animals will forfeit all awards.

The ACFA reserves the right to condemn and/or disqualify any animal, either live or slaughtered, found in violation of the use of drugs, chemicals, or feed additives as described above.

PENALTY FOR VIOLATION OF DRUG POLICY -

1st violation: In the event any animal is declared by the testing agency to be in violation of the use of drugs, chemicals, or feed additives as described above, the animal shall be disqualified and the exhibitor will forfeit all awards, prizes, auction proceeds, premium money and/or add-on money, as well as recognition associated with placing including, but not limited to, ACFA website for the positive tested animal.

2nd violation: In case of a second violation of the use of drugs, chemicals or feed additives as described above, the animal shall be disqualified and the exhibitor will forfeit all awards, prizes, auction proceeds, premium money and/or add-on money, as well as recognition associated with placing including, but not limited to, ACFA website for the positive tested animal. The exhibitor will also be banned from entering in any ACF Junior Livestock Show activities or awards for the duration of their Junior Show Career.

Animals that were subject to Drug Testing must wait until a negative result is confirmed prior to delivery. Exhibitors will be notified once this has been confirmed.

YOUTH AUCTION SALE

RULES AND REGULATIONS SPONSORED BY THE AUSTIN COUNTY FAIR ASSOCIATION

In order to hold the number of sale lots to one that will encourage good prices for all livestock, poultry and rabbits, and will give every 4-H and FFA member a chance to participate in the sale, the Austin County Fair Association has adopted the following rules for the 2024 4-H and FFA Youth Auction Sale:

All entries not sold in the Youth Auction Sale are eligible for sale on the resale truck, if the exhibitor notifies the Committee Chairman by 5:00 p.m., **Thursday, October 10, 2024**. Otherwise, the exhibitor will be responsible for all animals left.

The Youth Auction Sale Committee will determine the total number of sale lots in the Youth Auction Sale.

- 1. Each 4-H club and FFA member shall be limited to one sale lot. If the exhibitor has more than one entry eligible for the sale, it is the exhibitor's responsibility to let the Species Superintendent know which animal he/she wishes to sell. If the exhibitor does not let the Species Superintendent know which one he/she wishes to sell, the sales committee will select the first one that comes from the following order: 1st Steer, 2nd Halter Heifer, 3rd Horses, 4th Pen of Heifers, 5th Swine, 6th Lamb, 7th Goat, 8th Broilers, 9th Turkey Tom, 10th Turkey Hen and 11th Rabbits.
- 2. Only animals passing sifting and subject to other regulations will be sold in the Youth Auction Sale.

- 3. All sales in the Youth Auction Sale shall be limited to 4-H Club and FFA members. Members must be permanent residents in Austin County or be enrolled in a public, private or home school in Austin County. Exhibitor must be a member in good standing and be in compliance with all rules and guidelines of a 4-H club or FFA chapter in Austin County, and not have graduated high school.
- 4. If an exhibitor EXHIBITS an animal at any county fair within a calendar year of the Austin County Fair, then he/she is ineligible to show or sell at the Austin County Fair. This does not include major livestock shows.
- 5. All animals in this sale must have been fed and cared for by the exhibitor.
- 6. The feeding and care of all livestock projects are the sole responsibility of the exhibitor and their family from the beginning of the project until the animal leaves the fairgrounds. All livestock exhibitors will continue to feed, water, and clean the stalls/pens of their projects through dismissal on Sunday after the Fair or until delivery per Buyer's direction. Any exhibitors not doing so will forfeit their Youth Auction Sale and Add-On checks to the Austin County Fair Association Memorial Scholarship fund.
- 7. There will be a 7% deduction from all sales through the 4-H club and FFA Auction Sale, including the resale animals, donations, and added money which will be used to help defray the expenses of the Youth Auction Sale.
- 8. All Grand Champions and Reserve Champions in the junior market show must be sold in the Auction Sale unless the sale contradicts rule number one (1) above.
- 9. It is absolutely unethical for anyone to ask the buyer of an exhibit to donate or sell back a sale lot to the exhibitor. The

Fair Board will not tolerate exhibitors asking for animals to be donated or sold back. The violation of this rule could result in the forfeiture of any monies and/or prizes earned and be subject to other penalties assessed by the Austin County Fair.

- 10. No request to change the destination of the purchased animal(s) may be made by the exhibitor or parent, the buyers written request is final. Once the buyer submits the written form to the sales clerk, the buyer is the only individual allowed to make changes to delivery or destination.
- 11. All entries will be exhibited and sold by their owners unless he/she is physically unable to do so or if the exhibitor has more than one entry showing in different divisions at the same time. Exhibits to be shown or sold by someone else other than the owner must be approved in writing by the respective committee chairman. It is the responsibility of the exhibitor to obtain and complete the required form. Forms will be available at the Fair Office. The ONLY permissible excuses for "physically unable to do so" are a DOCUMENTED medical or family emergency and/or DOCUMENTED and sanctioned school function of which the exhibitor is a PARTICIPANT.

If an exhibitor is **academically ineligible** to show, the exhibitor AND THEIR PROJECT are ineligible to participate in the Austin County Fair.

- 12. No Pass Out (PO) will be allowed in any department.
- 13. When Youth Auction Sale checks are ready, exhibitors will be contacted. In order to receive their check, exhibitors must bring <u>STAMPED</u> and <u>ADDRESSED HANDWRITTEN</u> thank you notes to their buyers and add-on donors to the Fair Office. Once the Fair Office has checked their thank you notes,

exhibitors will seal them and then receive their check. Only parent(s)/guardian(s) listed on the entry form will be allowed to pick up checks for exhibitors.

- 14. In order to cash the Youth Auction Sale checks, the EXHIBITOR must endorse the check. Exhibitor will have 30 days after checks are printed to turn in thank you notes and pick-up checks. After this time period, the Sale and Add-On monies will go to the Austin County Fair Scholarship fund.
- 15. If an exhibitor family owes money to the Austin County Fair Association, their Youth Auction Sale check will be withheld until payment of outstanding balances. This must be handled prior to 30 days after checks are printed. Please refer to rule above.

2024 RULES AND REGULATIONS

- 1. This project is part of the market division of the Austin County Fair; therefore, an exhibitor CAN sell this project in the Youth Auction Sale.
- 2. All entries in the Commercial Pen of Heifers Show will be subject to the General Rules and Regulations of the Austin County Fair.
- 3. The Commercial Pen of Heifers Project is an opportunity for Junior Exhibitors to learn more about the beef cattle industry. Crossbred heifers are desired but purebred heifers will be permitted to show provided they have not been shown anywhere previous to the Commercial Pen of Heifers Show.
- 4. Each exhibitor is eligible to validate and raise as many heifers as they wish but only two (2) will be entered and exhibited by an exhibitor. The remaining heifers that were tagged in will not be allowed to sell in the Youth Auction Sale or be brought to the fairgrounds.
- 5. Grand and Reserve Champion Commercial Pen of Heifers must sell according to the Youth Auction Sale rules. The

- remaining sale order will be determined by the exhibitors overall placing.
- 6. Heifers entered in the Commercial Pen of Heifers Show must be no older than 30 months at the time of the show.
- 7. All heifers must be tagged in and DNA sample taken on **Friday, May 10, 2024** beginning at 5:00 p.m. and ending at 7:00 p.m. at Four County Auction Barn in Industry.
- 8. All heifers entered in the Commercial Pen of Heifers Show must be polled or dehorned, Brucellosis vaccinated and tested per Texas Animal Health Commission regulations at tag-in.
- 9. Family tagging will be allowed. This is interpreted as immediate family members living in the same household.
- 10. There will be a \$20.00 per head tag in fee and a \$55.00 validation fee per pen at tag-in.
- 11. Heifers tagged in for the Austin County Fair Halter Heifer Show may not be used to make a Commercial Pen of Heifers.
- 12. All heifers must have health papers to present at the Show and must be palpated by a licensed veterinarian no more than 30 days prior to the show. Palpation results must be listed on the health papers.
- 13. Heifers must be bred at the time of the show. Any heifer that is not bred at the time of palpation will not receive any heifer points for that heifer.
 - a. Heifers will NOT be allowed to have calves at their side.
 - b. Any heifer that has a calf is no longer a heifer and will be disqualified.

- 14. Due to space limitations, if we have more exhibitors than we have pens, we will evaluate heifers on October 5th at Four County Auction Barn. The top 32 pens will be brought to the fairgrounds.
- 15. All Exhibitors will be required to turn in an Official Project Record Book.
- 16. Scoring System: 100 Points Total

a.	Live Evaluation of Heifers	40 points
	(20 points per heifer)	

b.	Exhibitor Record Book	10 points
c.	Written Exam	25 points
d.	Exhibitor Interview	25 points

- 17. In case of a tied overall score between two (2) exhibitors, the tiebreakers will be handled in the following order:
 - e. Live Evaluation of Heifers
 - f. Written Exam
 - g. Exhibitor Interview
 - h. Exhibitor Record Book
- 18. Exhibitors will be expected to maintain their pens and care for their animals at all times. Exhibitors that fail to maintain their area will be issued one (1) warning from the Pen of Heifers Committee. If no improvement is made to the condition of the stalls, a fine of \$100.00 will be assessed and deducted from the exhibitor's check. Only pelletized shavings will be used in stalls.
- 19. If the exhibitor qualifies for the Youth Auction Sale and chooses to sell their pen, then the cattle will sell. No PO allowed.
- 20. Exhibitors shall be responsible for the delivery of their projects listed for sale at the time mutually agreed upon between buyer and seller to any destination in Austin County.

Failure to comply with this delivery rules will result in the forfeiture of the money paid by the buyer to the exhibitor. The Austin County Fair Association assumes no responsibility for the delivery or loss of the exhibitor's project. Delivery receipts must be signed for by the exhibitor before the animals will be released by the committee chairman.

- 21. Pens must be clean and free form any feed, manure, hay, and all signs when heifers are loaded out. A fine of \$100.00 will be assessed and deducted from the exhibitor's check for each pen that is not properly cleaned out.
- 22. Drug Testing will be performed on Grand and Reserve Champion and one (1) random. No interfering with testing area and testing official.
- 23. When Youth Auction Sale checks are ready, exhibitors will be contacted. In order to receive their check, exhibitors must bring *STAMPED* and *ADDRESSED HANDWRITTEN* thank you notes to their buyers and add on donors to the Fair Office. Once the Fair Office has checked their thank you notes, exhibitors will seal them and then receive their check.

- 1. This contest will be open to any Austin County 4-H or FFA Member.
- 2. All contestants are subject to the General Rules and Regulations of the Austin County Fair.
- 3. A link to online entry submission will be posted to the Austin County Fair website (www.austincountyfair.com). This link will be separate from the online livestock entry portal.
- 4. Contest Date is to be determined.
- 5. Contestants will be divided into three age divisions, based on contestant's school grade as of September 1, 2024:
 - a. $3^{rd} 5^{th}$ grade b. $6^{th} 8^{th}$ grade

 - c. $9^{th} 12^{th}$ grade
- 6. During the competition, contestants will be further divided into groups and will remain with that assigned group throughout the round of stations. While completing the individual stations, there will be no conferring between contestants or between a contestant and anyone else except as directed by contest officials.
- 7. Conferring among contestants (talking, gestures, etc.) will result in immediate dismissal from the contest. Contestants may not carry any electronic communication device (cell phones, etc.).

Any contestant found in possession of such a device at any time during the contest will be immediately removed from the competition.

- 8. All testing materials required to complete the individual competition stations will be provided, except that contestants will be allowed to bring their own clipboard. The contestants may bring no books, notes, pamphlets, or other reference material into the contest area.
- 9. Contestants are not to pick up or touch any item that is being identified or evaluated in the individual competition stations.
 - 10. No questions concerning the contents of the individual competition stations will be answered during the contest.
 - 11. Parents are invited to review contest materials in the contest area at the conclusion of the contest.
 - 12. The contest will consist of skill stations on the following topics:

2024 GENERAL RULES & REGULATIONS

- 1. All Halter Heifer and Market Steer entries are subject to the General Rules and Regulations of the Austin County Fair and to the rules governing the Youth Auction Sale.
- 2. A validation form must be completed for each Halter Heifer or Market Steer to be tagged in. These validation forms will be available from the Fair Office, Agricultural Science Teachers, or County Extension Agents. In order to speed up the tag-in process, it is advisable to obtain and complete the form prior to arriving at tag-in.
- 3. All Halter Heifers and Market Steers must be weighed, tagged and DNA sample taken on **Saturday**, **May 11**, 2024 from 7:00 10:00 am at the Four County Auction Barn in Industry.

- 4. In addition to being weighed and tagged, Halter Heifers and Market Steers will have hair samples collected for identification purposes.
- 5. Halter Heifers must weigh at least 500 pounds at tag-in. There is no minimum tag-in weight for Market Steers.
- 6. Halter Heifers and Market Steers must be owned by the exhibitor at time of tagging.
- 7. There will be a \$20.00 charge for each animal tagged. Family tagging is allowed. This will be interpreted as immediate family living in the same household.
- 8. Corrections to information on the validation form must be brought to the attention of the committee chairman within 30 days following the date of tag-in.
- 9. You must notify the committee chairman immediately if you have a Halter Heifer or Market Steer that loses an ear tag so that they can issue you a new one.
- 10. Any breed or cross from any of the beef breeds is eligible to enter the show. Halter Heifers and Market Steers will be divided into two (2) divisions: American Breeds & Cross (Brahman influence ABC) and All Other Breeds (exhibiting no Brahman influence AOB).
- 11. A champion and reserve champion will be selected from each division with an overall Grand Champion and Reserve Champion from the entire show.
- 12. A mandatory progress show will be held on **Saturday**, **August 10**, **2024 at 8:00 am** at the Austin County Fairgrounds. Halter Heifers and Market Steers must be present at the progress show in order to be eligible to show at the Austin County Fair. Halter Heifers and Market

Steers should be exhibited by their owners unless he/she is physically challenged and unable to do so. All Halter Heifers and Market Steers must be halter broke and easy to handle. Unmanageable heifers and steers will be required to return to the Fairgrounds on **Saturday**, **September 21**, **2024 at 10:00 am** for a second evaluation.

- 13. Halter Heifers or Market Steers that fail the second evaluation will not be allowed in the show. Any heifer or steer deemed unmanageable by show officials during the Fair will be required to leave the grounds immediately.
- 14. All entries will be exhibited and sold by their owners unless he/she is physically challenged, or if the exhibitor has more than one entry showing in divisions at the same time. Exhibits to be shown or sold by someone other than the owner must be approved in writing by the respective committee chairman. Forms will be available in the Fair Office.
- 15. Animals owned by an exhibitor who is academically ineligible will not be allowed to enter the show.
- 16. A 10-pound tolerance for minimum weight will be allowed. Animals failing to make the required weight will be removed from the scale. The scale will be recalibrated, and the animal will be placed back on the scale. Animals failing to meet their weight requirement will be required to leave the fairgrounds as soon as possible.
- 17. Hay may be fed loose in the barn, but each exhibitor is responsible for clean-up of their area each day.
- 18. Exhibitors will be allowed to use shavings in the barn. Each exhibitor will be responsible for cleaning out shavings prior to load-out on **Sunday, October 13, 2024**.

- 19. No trim chutes will be allowed.
- 20. No Free-Standing Fans will be allowed. Fans must be mounted to a panel.
- 21. No electronic/hydro therapy to be done on the grounds.
- 22. There will be no "pumping" allowed on premises other than by a state licensed veterinarian.
- 23. Unethical Fitting and Show of Livestock Unethical practices performed on any livestock entry in order to deceive the judges or the sifting committee is prohibited, and the exhibitor shall be barred from this show and any future shows. Unethical practices will be determined by the Executive Committee of the Austin County Fair with the assistance of anyone deemed necessary.
- 24. Hair grooming products may be used prior to the start of the show, but the animal must be washed out and free of residue prior to entering the holding area. Animals will be checked for residue prior to entering the holding area. Any animal found with residue will not be allowed to enter the holding area. The use of adhesives, paints, dyes, etc. will be prohibited.
- 25. Every exhibitor will be eligible to participate in the Herdsman Contest (Halter Heifer/Market Steer) Pens will be inspected for Good Housekeeping periodically on Tuesday, Wednesday, Thursday, and Friday. Exhibitors will be judged on timely activities such as daily feeding and watering of exhibits of friendliness and cooperation among exhibitors. Awards will be announced on **Saturday**, **October 12**, **2024** after Livestock Judging Awards.
- 26. Any exhibit requiring medication during the Fair must have treatment made in accordance with the current Release of

Liability & Indemnity, And Drug Certification Agreement. This form must be signed by the exhibitor and parent/guardian prior to submitting entry cards.

- 27. During the show, only the exhibitor and one (1) adult will be allowed in the holding area.
- 28. No animal will be permitted to leave the fairgrounds without the consent of the committee.
- 29. If an exhibitor has two (2) Halter Heifers, two (2) Market Steers, or one (1) heifer and one (1) steer qualifying for the sale, he/she may choose which animal to sell, except for Overall Grand and Reserve Champions. However, the Fair Office must be notified of the decision upon completion of the respective heifer and steer shows. If not, the highest placing animal will sell.
- 30. Non-selling Halter Heifers and Market Steers may move out early. This will take place at 6:00 a.m. on Thursday and Friday. Exhibitor must have a release form signed by the committee chairman. Release forms will be available in the Fair Office. Animals must be walked out through Gate 3, no trailers are to pull through the side of the barn.
- 31. For any non-selling Halter Heifer or Market Steer that the exhibitor wishes to put on resale, it will be the exhibitor's responsibility to deliver that animal directly to the resale buyer, at a time designated by the resale buyer. Resale buyer information will be available in the Fair Office during the Fair.
- 32. Early drop-off of show boxes and tack will be on **Sunday**, **October 6, 2024 at the conclusion of the Bucket Calf Show, after the last Bucket Calf has left.** Vehicles are to enter through Gate 3 (exhibitor parking) on highway 159,

- and exit through Gate 1. Tack arriving prior to the designated move-in time will be removed.
- 33. Show boxes and tack can be removed 5:00 9:30 am on **Sunday, October 13, 2024** or after all animals have been removed from the barn or released by the chairman.
- 34. Exhibitors must be at their stalls by 9:00 am on **Sunday**, **October 13, 2024** in order to clean them out and assist with loading-out at 11:00 am.
- 35. Exhibitors will be expected to maintain their stalls and care for their animals at all times. Exhibitors that fail to maintain their area will be issued one (1) warning from the Halter Heifer and Market Steer committee. If no improvement is made to the condition of the stall or care of the animal, a fine of \$100.00 will be assessed and deducted from the exhibitor's sale check.
- 36. Stalls must be clean and free of hay, manure, shavings, and excess feed prior to the animal's load-out on **Sunday**, **October 13, 2024.** A fine of \$100 will be assessed and deducted from the exhibitor's sale check if committee must clean out stall after exhibitor's departure.
- 37. Exhibitors will be responsible for the delivery of their projects to any destination in Austin County, as designated by the buyer. Failure to comply with this delivery rule will result in forfeiture of the money paid by the buyer to the exhibitor. The Austin County Fair Association assumes no responsibility for the delivery or loss of the exhibitor's project.
- 38. Exhibitors may exhibit two (2) Halter Heifers, two (2) Market Steers, or one (1) heifer and one (1) steer.

- 39. A maximum of two (2) stalls will be assigned to an exhibitor for all beef projects.
- 40. Drug Testing will be performed on Grand and Reserve Champions and one (1) random animal in accordance with the current Release of Liability & Indemnity, And Drug Certification Agreement. No interfering with the testing area and testing official will be allowed.
- 41. When Youth Auction Sale checks are ready, exhibitors will be contacted. In order to receive their check, exhibitors must bring <u>STAMPED</u> and <u>ADDRESSED</u> <u>HANDWRITTEN</u> thank you notes to their buyers and add on donors to the Fair Office. Once the Fair Office has checked their thank you notes, exhibitors will seal them and then receive their check.
- 42. Quality Counts: In keeping with the Austin County Fair drug residue avoidance policy, ALL exhibitors are now required to pass the Quality Counts Verification test for entry into the 2024 Show. Junior market and breeding show entries will not be accepted without verification code for each exhibitor. - 2. All Halter Heifers must be either polled or dehorned, and Brucellosis vaccinated, prior to tag-in on **Saturday, May 11, 2024.**
- 3. Halter Heifers in each division may be split into classes based on the number of heifers in the show at the discretion of the Halter Heifer & Market Steer committee.

- 4. Sub-Junior Halter Heifers must not be bred. Junior heifers may be bred or open. Sub-Junior or Junior heifers that are open should have evidence of palpation noted on the certificate of veterinary inspection (health paper) which states that the animal is a "satisfactory potential breeder". Intermediate heifers must be bred a minimum of 60 days. Senior heifers must be bred a minimum of 120 days. Breeding information and health papers will be required on all Halter Heifers.
- 5. Halter Heifers calving prior to the show date will be ineligible to show.

- 7. Halter Heifers will move in and be weighed and classified into ABC or AOB divisions on Wednesday, October 9, 2024 from 7:00 a.m. 9:00 a.m. See schedule below for move-in process:

5:00 a.m. – Gate 3 opens for Move-In 7:00 – 8:00 a.m. – Paperwork check. Ownership must be declared at this time. 8:00 – 9:00 a.m. – Classification and Weigh-In. Exhibitor will be responsible for delaring ABC or AOB to the classifiers.

8. Judging of Halter Heifers will be on **Thursday, October 10, 2024 at 9:00 a.m.,** followed by showmanship and then sale order.

Ownership must be declared before steer is classified or weighed. Exhibitor will be responsible for declaring ABC or AOB to the classifiers. Official classifiers decision will be final. Minimum weight is set at 1,000 pounds.

Both tagging dates will be at the Austin County Fairgrounds in Bellville. Exhibitors will be charged \$15.00 per animal tagged.

3. All Market Swine must be properly identified with an ear tag by **Saturday**, **July 13**, **2024**. Family tagging will be allowed

- in **2024**. This will be interpreted as immediate family living in the same household.
- 4. Market Swine exhibitors may exhibit two (2) entries in this division and will be allowed no back up animal or be eligible to show in any other division.
- Second animal must move out Tuesday, October 8, 2024 on designated trailer. THIS RULE WILL BE ENFORCED DURING THE 2024 FAIR.
- 6. Weighing and sifting will be done when you unload your Market Swine. Weighing will be from 6:00 a.m. to 8:00 a.m. on Monday, October 7, 2024. Exhibitors must be present to bring their Market Swine to the scale. If the exhibitor has a school related event, their parent, brother or sister may bring the Market Swine. Each exhibitor must declare ownership before each Swine enters the scale. A re-weigh will be conducted only if over or under weight. - 7. All Market Swine in this show and sale must have been fed and cared for by the exhibitor in an approved location for the show. Feeding, fitting and handling of Market Swine will be limited to exhibitor and immediate family member only. - 1. All Market Lamb and Goat entries are subject to the General Rules and Regulations of the Austin County Fair, to the rules governing the Youth Auction Sale and the rules of the Market Lamb and Goat livestock committees. Violation of these rules may result in disqualification or sifting.
- 2. Only wethers may be shown.

- 3. Market Lamb and Goat exhibitors may exhibit two (2) entries in these divisions and will be allowed no back up animal and will be ineligible to show in any other division.
- 4. All Market Lambs and Goats must be properly identified with tattoos and ear tags by **Thursday**, **July 11**, **2024**. Family tagging will be allowed. This will be interpreted as immediate family living in the same household. All Market Lambs and Goats must be in their designated locations by **Thursday**, **July 11**, **2024** (refer to validation form). There will be two (2) tag-in dates **Saturday**, **June 29**, **2024** from **7:00 a.m. 8:30 a.m.** and **Thursday**, **July 11**, **2024** from **6:00 p.m. 7:30 p.m.** at the Austin County Fairgrounds.

In the event of a lamb or goat losing or getting an infected ear tag the exhibitor must notify the chairman and send a picture of the animal and ear tag within one week. The animal must be retagged with the tag before crossing the scale.

5. There will be a Mandatory Progress Evaluation and optional showmanship contest opened to 4-H and FFA exhibitors on **Saturday, August 10, 2024.** Evaluation will be from **7:30 a.m.** – **8:15 a.m.** followed by a Mandatory Meeting at **8:15 a.m.** at the Austin County Fairgrounds. Failure to attend the Mandatory Progress Show will forfeit your eligibility to show at the Austin County Fair. All tagged Market Lambs and Goats must be present at the Mandatory Progress Evaluation to be eligible to show at the Austin County Fair. All Market Lambs and Goats should be exhibited by their owners unless he/she is physically challenged and unable to do so. Showmanship will begin at **8:30 a.m.** NO EXCEPTIONS.

- 6. All Market Lambs and Goats in this show and sale must have been fed and cared for by the exhibitor in an approved location for the show.
- 7. Minimum weight of show **Market Lambs** is 80 pounds. Minimum weight of show **Market Goats** is 60 pounds.
- 8. All **Market Lambs** must be sheared within one (1) week prior to sift date. Boots will be permitted. No shears, blow dryers (with the exception of battery operated dryers), fans or items of a similar nature will be permitted on the fairgrounds.

All **Market Goats** are preferred to be dehorned but are required to have horns tipped blunt and no longer than 1 inch prior to arrival on the show grounds. Tipping or removal of horns on show grounds will result in disqualification.

No artificial paint, powders or coloring may be used on lambs or goats during the shows. Market Goats must be uniformly sheared with no hair longer than 3/8 inch above the knee and hock joints before arrival at the fairgrounds. Market Goats may have longer hair on the end of the tail. No clipping of goats will be allowed on the fairgrounds. No shears, blow dryers (with the exception of battery-operated dryers), fans or items of a similar nature will be permitted on the fairgrounds

All showboxes, supplies and canopies should be dropped off between 8:00 a.m. and 12:00 pm on Saturday, October 5, 2024. Any items dropped off before the designated time will be removed from the grounds.

No unloading of show boxes and supplies will be allowed during the arrival of the lambs and goats. Any additional show boxes and supplies can be brought in after lambs and goats have been checked in and weighed. Unloading of show

supplies after designated drop off time must be done in the exhibitor parking lot due to safety reasons.

Designated areas will be identified and marked to indicate where show boxes and personal items are not allowed. Included in these areas are all roads. Please remember we have new exhibitors each year and limited room so please share space.

10. Market Lambs will move in and be weighed on Monday, October 7, 2024 from 3:00 p.m. until 4:30 p.m. Exhibitors will be allowed to enter the fairgrounds from FM 529 (Gate 2A). After unloading animals, exhibitors must exit the fairgrounds. No vehicles will be allowed on grounds. Committee Members will be able to unload earlier.

All Market Goats will move in and be weighed on Tuesday, October 8, 2024 from 2:00 p.m. until 3:30 p.m. Exhibitors will be allowed to enter the fairgrounds from FM 529 (Gate 2A). After unloading animals, exhibitors must exit the fairgrounds. No vehicles will be allowed on grounds. Committee Members will be able to unload earlier.

Any exhibitor that has both a lamb and goat entered may bring their goat at the same time as the lamb and stall it in its assigned pen and take it across the scale on Tuesday during weigh-in for goats.

11. Ownership must be declared before entering the scales. A re-weigh will be done, only in case of an underweight lamb or goat. In the event an underweight lamb or goat is identified, the lamb or goat will be immediately re-weighed. The animal will be backed off, scale cleaned and rebalanced for re-weigh.

The second weight will become the official and nonchallengeable weight. Market Lambs and Goats will be sifted at scales. The judge's decision will be final. Market Lambs and Goats sifted must be removed from the fairgrounds immediately after sifting.

LAMBS - There will be six (6) weight classes. Classes will be determined after weigh-in.

GOATS -There will be six (6) weight classes. Classes will be determined after weigh-in.

12. All exhibitors must attend a mandatory meeting on:

Tuesday, October 8, 2024 for Lambs @ 9:00 a.m.

Wednesday, October 9, 2024 for Goats @ 9:00 a.m.

Exhibitor numbers will be distributed at the end of the meeting to the **exhibitor only**!

13. JUDGING of the Market Lambs will be on Tuesday, October 8, 2024 at 9:30 a.m.

JUDGING of the Market Goats will be on Wednesday, October 9, 2024 at 9:30 a.m.

- 14. Drug Testing will be performed on Grand and Reserve Champion and one (1) random. No interfering with the testing area or testing official. Animals that are drug tested must be taken home on Sunday, October 13, 2024 and fed and cared for until notified of drug testing results and then delivered as specified by the buyer.
- 15. All Grand & Reserve Champion lambs and goats need to be placed in the designated champion pens immediately following their show! NO EXCEPTIONS!
- 16. If a substitution exhibitor is needed for your second lamb or goat for show purposes, you will be required to complete a

substitution form. Following the show, all second lambs or goats MUST leave the fairgrounds with a RELEASE SLIP from the committee chairperson. The second lamb or goat should be designated for take home or resale immediately following the show. Designation is required no later than 4 **p.m**. that day. Second lambs must be removed from the grounds on Tuesday, October 8, 2024 between the end of the show and 4 p.m. Second goats must be removed from the grounds on Wednesday, October 9, 2024 between the end of the show and 4 p.m. There will not be a resale **truck after the shows.** Exhibitors are to lead lambs and goats off the fairgrounds to the parking area for loading and are not to enter any other livestock building or other buildings with lamb or goats while in route to load their animal. All other lambs and goats will be required to stay on the fairgrounds until **Sunday**, **October 13, 2024** when they can be removed with a RELEASE SLIP after 11:00 a.m.

17. IMPORTANT: Load out designation of the exhibitor's second lamb or goat must be finalized in writing by Tuesday, October 8, 2024 @ 4:00 p.m. for Lambs and Wednesday, October 9, 2024 @ 4:00 p.m. for Goats.

Failure to give destination designation of second lamb or goat will result in default of the lower placing animal to resale on Sunday, October 13, 2024.

18. If an exhibitor shows two (2) animals in these divisions and chooses to sell in the Youth Auction Sale, the Overall Grand Champion and Reserve Champion must sell. The sale order will be Grand Champion, Reserve Champion, Class Grand Champions and Class Reserve Champions, and all other sale lots will be determined by the class placings. Exhibitors must advise the committee in writing by 4:00 p.m. on Wednesday, October 9, 2024 if they choose to sell a lower placing lamb or goat or if they are also showing a second species.

- 19. The Committee suggests after the sale and weather permitting, please remove blankets and sleeves so the public can view the animals.
- 20. Absolutely no feed, water buckets or shavings or any other type of bedding other than what is provided by the Fair Association are allowed in the lamb or goat pens. If in shared pens, animals must be muzzled unless excused by chairman. Market Lambs and Goats are to be fed in designated feeding areas. Lambs and Goats must be fed daily. No feeding or watering in the barn. All Market Lambs and Goats must be in their assigned pens by 7:00 a.m. on Sunday, October 13, 2024.

The barn will be closed down at 7:15 a.m. to sort animals for load out destinations. Volume buyer and resale trucks will load out at 9:00 a.m. and the remaining animals will be released at 11:00 a.m. All lambs and goats must be removed no later than 12:00 p.m. from the fairgrounds on Sunday.

- 21. Show boxes can be removed on Sunday after 11:00 a.m. or after all animals have been removed from the barn or released by chairman.
- 22. Every exhibitor will be eligible to participate in the Memorial Herdsman Contest (Market Lamb/Market Goat) Pens will be inspected for Good Housekeeping periodically on Wednesday, Thursday, and Friday. Exhibitors will be judged on timely activities such as daily feeding and watering of exhibit, removal of feed buckets from designated feeding areas, cleanliness of area around show box and exhibits of friendliness and cooperation among exhibitors. Awards will be announced on **Saturday**, **October 12**, **2024**, with the Livestock Judging Awards.

- 23. Exhibit area must be kept clean, Tuesday Sunday; failure to do so will result in a \$100.00 fee deducted from your sale check.
- 24. All animals are subject to be used during the Livestock Judging Contest on **Saturday** of fair week. If selected, you will be advised, and the animal will need to be fed prior to usage.
- 25. A **LAMB** showmanship contest will be held immediately following the conclusion of the Market Lamb Show. Exhibitors are allowed to bring any lamb that they own and have shown in the fair back for the showmanship competition. The classes will be divided according to the exhibitor's school grade as of **September 1, 2024**. Classes will be Juniors Grades 3-5, Intermediate Grades 6-8, and Senior Grades 9-12. Awards will be given for the first 3 exhibitors placing in each showmanship class.

A **GOAT** showmanship contest will be held immediately following the conclusion of the Market Goat Show. Exhibitors are allowed to bring any goat that they own and have shown in the fair back for the showmanship competition. The classes will be divided according to the exhibitor's school grade as of **September 1, 2024**, classes will be Juniors Grade 3-5, Intermediate Grade 6-8, and Senior Grade 9-12. Awards will be given for the first 3 exhibitors placing in each showmanship class.

- 29. Absolutely no parking is allowed inside the fairgrounds after Monday of fair week.
- 30. Any items put in or above the exhibitor's pen will require advanced approval from the exhibitor sharing the pen and the lamb and goat committee chairman.

- 31. When Youth Auction Sale checks are ready, exhibitors will be contacted. In order to receive their check, exhibitors must bring *STAMPED* and *ADDRESSED HANDWRITTEN* thank you notes to their buyers and add-on donors to the Fair Office. Once the Fair Office has checked their thank you notes, exhibitors will seal them and then receive their check.
- 32. Quality Counts: In keeping with the Austin County Fair drug residue avoidance policy, ALL exhibitors are now required to pass the "NEW" Quality Counts Verification test for entry into the 2024 Show. Junior market and breeding show entries will not be accepted without verification code for each exhibitor. Verification codes are not required for Agricultural Mechanics exhibitors and Judging Contest contestants. The Quality Counts training and test can be found at: https://www.texaslivestockvalidation.com/qc/qcregister.aspx
- 33. It is absolutely unethical for anyone to ask the buyer of an exhibit to donate or sell back a sale lot to the exhibitor. The Fair Board will not tolerate exhibitors asking for animals to be donated or sold back. The violation of this rule could result in the forfeiture of any monies and/or prizes earned and be subject to other penalties assessed by the Austin County Fair.
- 34. No request to change the destination of the purchased animal(s) may be made by the exhibitor or parent, the buyer's written request is final. Once the buyer submits the written form to the salesclerk, the buyer is the only individual allowed to make changes to delivery or destination.

LAMB & GOAT SKILLATHON CONTEST

EARLY REGISTRATION DUE: SEPTEMBER 30, 2024 BY 5:00 P.M. ENTRY FEE: FREE

Any updates for the Skillathon will be given at the mandatory show in August and on the Fair website.

- 1. This contest will be open to any person exhibiting a project at the 2024 Austin County Fair.
- 2. All contestants are subject to the General Rules and Regulations of the Austin County Fair.
- 3. There will be a separate Austin County Fair Entry card to enter the contest. Each individual contestant wishing to participate in the Lamb & Goats Skillathon Contest must complete an entry card and submit it to the Fair Office by the entry date. Early registration due September 30, 2024 by 5:00 p.m. and can register up until one hour before the contest starts.
- 4. Contest will be held on Thursday, October 10, 2024. This year the contest will be held at the American Legion Building.
 - a. 1:00 p.m. Contestant check-in
 - b. 1:15 p.m. Review rules and contest procedures, followed by start of contest.
 - 5. Contestants will be divided into three age divisions, based on contestant's school grade as of September 1, 2024:

 - a. 3rd 5th grade
 b. 6th 8th grade
 c. 9th 12th grade

- 6. During the competition, contestants will be further divided into groups and will remain with that assigned group throughout the round of stations. While completing the individual stations, there will be no conferring between contestants or between a contestant and anyone else except as directed by contest officials.
- 7. Conferring among contestants (talking, gestures, etc.) will result in immediate dismissal from the contest. Contestants may not carry any electronic communication device (cell phones, etc.). Any contestant found in possession of such a device at any time during the contest will be immediately removed from the competition.
- 8. All testing materials required to complete the individual competition stations will be provided, except that contestants will be allowed to bring their own clipboard. The contestants may bring no books, notes, pamphlets, or other reference material into the contest area.
- 9. Contestants are not to pick up or touch any item that is being identified or evaluated in the individual competition stations.
- 10. No questions concerning the contents of the individual competition stations will be answered during the contest.
- 11. Parents are invited to review contest materials in the contest area at the conclusion of the contest.
- 12. The contest will consist of 8 individual stations. Topics covered at the stations will be:

Lamb & Goat Equipment
Disease Identification
Feed Ingredients
Medications and Vaccines

Breeds of Lamb & Goats Anatomy of Lamb & Goats Feed Labels Fair Rules & Current News

- Each individual station will consist of up to 10 questions.
 Question numbers will be based on school grade.
 Contestants will be allowed 5 minutes to complete each individual station.
- 14. In the event of a tied score, the tie will be broken based on having the correct answer for specific questions at specific stations. These questions will be selected by the Committee on the day of the contest. The tie breaker questions will be posted prior to the start of the contest.
- 15. Awards will be given to the top three scoring individuals in each age division. These awards will be presented on Saturday, October 12, 2024 in the entertainment center following livestock judging awards.
 - 16. Contest questions will be created using information obtained from the internet websites. It is the individual contestant's responsibility to access these websites to obtain study materials pertaining to the topics listed in these rules and regulations. 2024 RULES AND REGULATIONS

The below section contains rules that are common to **both Broilers** and Turkeys, later sections will describe species specific Rules.

- 1. All entries are subject to the General Rules and Regulations of the Austin County Fair and to the rules governing the Youth Auction Sale.
- 2. Drug Testing will be performed on Grand and Reserve Champion and one (1) random. No interfering with testing area and testing official. Please see General Rules for more details.
- 3. IMPORTANT NOTICE: The threat of avian influenza and other reportable diseases continues to be of serious concern to poultry in Texas. The situation is being monitored on a continuous basis. Any requirements for testing, limitations on the movement of poultry or other activities related to this or similar matters will be handled under the authority of show officials and/or the Texas Animal Health Commission.

- 4. Any entry showing symptoms of disease or lacking show quality will be excluded from exhibition at the discretion of the Official Judge. *The Official Judge's decisions are final.*No Stock, except in the above instances, will be removed from the exhibition until the close of the fair.
- 5. All birds must be the property of the person entering them but birds from one family may be housed in the same facilities.
- 6. The Committee will provide for each exhibitor two (2) clean, one gallon coffee cans for feed and water. Each exhibitor may bring one (1) plastic or metal container in which to store feed and supplies. No paper containers will be allowed around the cages.
- 7. If a bird dies or is injured after it makes it through sifting, the bird is eligible for the show.
- 8. The Grand Champion and Reserve Champion birds must sell in the Youth Auction Sale unless this contradicts with the General Rules #1. If an exhibitor shows two (2) animals at the Austin County Fair and both animals qualify for the Youth Auction Sale, the exhibitor must notify the Chairman which animal they want to sell by **Wednesday**, **October 9**, **2024** by 5:00 p.m.
- 9. The Committee will assist with the care for the poultry projects (feed and water) on Monday thru Wednesday, so that no exhibitor will be required to miss school on that day for this reason.
- 10. The poultry exhibit area needs to be kept clean during visitor hours. Birds must be fed, watered and pens cleaned by 9:00 a.m. each day. In addition, exhibitors are required to change out shavings sometime between Thursday evening (5:00 p.m.) and sale day, Friday (9:00 a.m.). The Poultry Committee has assigned a group of committeemen to enforce this rule during the Fair. An exhibitor will be first given a YELLOW

WARNING TAG. If the problem is not corrected by the following day, the Housekeeping Committee will then tag the pen with a RED PENALTY TAG; the exhibitor will then be subject to a \$100.00 fee. This fee will be deducted from the exhibitor's sale check should the project make the sale. Tags should only be removed by Poultry Committeemen, and it is suggested that if an exhibitor's pen is tagged, that the exhibitor contact a Poultry Committeeman as soon as possible. This rule will be STRICTLY enforced during the **2024** Fair.

- 11. To qualify for showmanship, the exhibitor must be present and exhibit his/her own birds during the show. Showmanship will start during the show and at the completion; exhibitors interested in showmanship will be required to bring one (1) broiler back to the show ring and possibly answer questions. No parents/guardians are allowed in the ring during showmanship. If the child cannot hold their bird, a poultry committee member will assist them. The classes will be divided according to the exhibitor's school grade as of **September 1, 2024.** Showmanship will be divided into two (2) groups: Juniors 3rd thru 7th grade and Seniors 8th thru 12th grade.
- 12. If your birds dies after the show and before the Sunday move out it must be replaced with another bird.
- 13. Exhibits will move out between 8:00 a.m. and 10:00 a.m., **Sunday, October 13, 2024**. Pens must be clean upon departure. If any birds are not picked up and the Broiler Committee is not notified of their status by 10:00 a.m. on **Sunday, October 13, 2024**, they will become the property of the Poultry Committee.
- 14. Quality Counts: In keeping with the Austin County Fair drug residue avoidance policy, ALL exhibitors are required to pass the Quality Counts Verification test for entry into the 2024

Show. Junior market and breeding show entries will not be accepted without verification code for each exhibitor. Verification codes are not required for Agricultural Mechanics exhibitors and Judging Contest contestants. The Quality Counts training and test can be found at: https://www.texaslivestockvalidation.com/qc/qcregister.aspx

15. It is the responsibility of the exhibitor to have their birds processed (please verify with buyer how they would like the birds processed) and delivered to their buyer within two (2) weeks after the close of the Austin County Fair. Birds that were subject to Drug testing must wait until a negative result was confirmed prior to delivery. Exhibitors will be notified once this has been confirmed.

MARKET BROILERS

- 1. All broiler chicks must be bought from the same place and same hatch through FFA advisors or 4-H agents. Orders must be placed and paid for by **Friday**, **May 10th**, **2024** by 5:00 p.m. There will be no exception to this rule. Exhibitors must use the official order form provided by their 4-H leader or FFA advisor. Each exhibitor is limited to the birds he/she ordered, no replacement birds will be issued.
- 2. Market Broiler exhibitors may have one (1) entry in this division with a backup pen of no more than three (3) broilers allowed at time of sifting.
- 3. At 5:00 p.m. on the day of the Market Broiler Show, Broiler exhibitors will be allowed to enter the fairgrounds from FM 529 (GATE 2A), follow as directed by committeemen to unload their Broilers and then to move their vehicle to the exhibitor's parking lot. No vehicles will be allowed on grounds. The Market Broiler Show will not begin until all vehicles are removed.

- 4. Entries in the Market Broiler Show will move in and sift from 5:00 p.m. until 6:00 p.m. on **Sunday, October 6, 2024**. Judging will immediately follow. No Market Broilers will be allowed on the fairgrounds until 5:00 p.m. on **that day**. All Market Broilers must be in line for sifting at 6:00 p.m.
- 5. Three (3) Market Broilers will constitute one entry. There will be a minimum weight limit of 5.0 lbs. per bird. A scale will be made available to the judge. The Official Market Broiler Judge reserves the right to weigh any bird entered. The **2024** Market Broiler Show will be a straight run show (roosters or hens).
- 6. Only one (1) bird will be allowed in pen after the Market Broiler Show. Exhibitors must remove the remaining two (2) birds after completion of the Market Broiler show.
- 7. All birds will be wing-banded for the **2024** Austin County Fair Market Broiler Show. Only wing-banded birds will be allowed to show. A minimum of 50 birds must be ordered per exhibitor. Additional birds may be ordered in increments of 50 not to exceed 100 birds per exhibitor. The maximum number of birds per exhibitor is 100.
- 8. Family Orders/Tagging will be allowed. Each exhibitor will be assigned a set of consecutive numbered wing-bands. Exhibitors in the family may exchange sets but no intermingling of birds between the sets will be allowed. Each exhibitor MUST choose their pen from separate sets. Once a pen of broilers is selected for show, the wing-band numbers of the entire pen (and alternates) must correspond from within the range of wing-band numbers assigned to the exhibitor at the time of distribution. (Wing-band numbers between family exhibitors cannot be combined to make up a pen and no two pens can come from the same set.)

Example for Family Tagging:

Family -2 exhibitors, order 2 set of birds

At Distribution

Set#1 is assigned wing-band #1-100

Set#2 is assigned wind-band #101-200

Time of Show

Selecting the Pen

One pen must come from Set #1 and the other from Set #2

The family can decide which child shows which pen.

- 9. Birds with missing wing-bands will not be allowed to show. Bands that are not legible will not be allowed to show.
- 10. Evidence of tampering with wing-bands will not be tolerated. The decision of the Official Broiler Judge is final.
- 11. All Broiler wing-bands will be checked when they are brought to the sifting line and are subject to being checked anytime during the Market Broiler Show.

MARKET TURKEYS

- All poults must be bought from the same place and same hatch through FFA or 4-H agents. Orders must be placed and paid for by Friday, March 8th, 2024 by 5:00 p.m. There will be no exceptions to this rule. Exhibitors must use the official order form provided by their 4-H leader or FFA advisor. Each exhibitor is limited to the birds he/she ordered. No replacement birds will be issued.
- 2. Turkeys must be ordered in lots of five (5) birds per exhibitor with a maximum of 20 birds (of each sex). For example five (5) toms and/or five (5) hens. Exhibitors from the same family may purchase poults collectively, however all exhibitors names must appear on the order form.

- 3. Market Turkey exhibitors will be allowed one (1) entry in the Turkey Tom division and/or Turkey Hen division (per General rule). Each exhibitor will be allowed one (1) backup bird per division if their first bird is sifted.
- 4. On the morning of the show, the Market Turkey exhibitors will be allowed at 8:00 a.m. to enter the fairgrounds from FM 529 (GATE 2A), follow as directed by committeemen to unload their Turkeys, and then move their vehicle to the exhibitor's parking lot. No vehicles will be allowed to remain on the grounds. The Market Turkey Show will not begin until all vehicles are removed.
- 5. Entries in the Market Turkey Show will move in and be sifted from 8:00 a.m. until 9:00 a.m. on **Sunday, October 6th, 2024**. All turkeys must be in line for sifting at 9:00 a.m. Judging will immediately follow. No turkeys will be allowed on the fairgrounds until 8:00 a.m. on **that day.**
- 6. Exhibitors who show both a Tom and a Hen will be required to take one of the two home after completion of the Turkey judging. They must be removed immediately following the show, no extra pens will be available, with the exception if both of the birds shown are Champion birds. All Champions birds (Grand and Reserve) for both Toms and Hens must remain for the full fair.

PLEASE SEE RULES FOR BOTH DIVISIONS (HOME BRED AND OWNED DIVISION – AND – PURCHASED DIVISION)

HOME BRED AND OWNED MEAT PEN DIVISION:

1. This is not an A.R.B.A or T.R.B.A sanctioned show. However, it will be governed by the American Rabbit Breeders Association guidelines as outlined by the A.R.B.A Standard of Perfection. All entries are subject to the General Rules and

Regulations of the Austin County Fair. Market Rabbits are also governed by the Youth Auction Sale rules.

- 2. Any entry showing symptoms of disease such as malocclusion, sore bleeding hocks, signs of a cold or sniffles, ear canker, mite or mange, vent disease, sore and runny eyes, mix breeds or other disqualifying features, may be excluded from exhibition at the discretion of the Rabbit Show Director in Charge. No stock, except in the above instances, will be removed from the exhibition until the close of the Rabbit Show.
- 3. All Rabbits must be the property of the person entering them. The exhibitor must own the buck and does before June 5, 2023. Exhibitors must breed their own does to their own bucks & kindle their own kits. Each exhibitor should have at least 2-3 does and a buck.
- 4. Breeding stock is limited to the following meat pen breeds:

A. Californian D. Palomino

B. New Zealand E. Champagne D'Argent

C. Satin F. Rex

- **5.** All entries must be the bona fide property of the exhibitor. Breeding should be done 100 days prior to the show. **No crossbreeds may be bred or shown.**
- 6. All exhibitors of Market Rabbits will be required to fill out a Market Validation Form (not entry card). This form will include a statement as to the physical location of the breeding stock (number of bucks and does with their permanent left ear tattoo) with a release stating that this is for committee use of random checks. Random checks will begin the first of June.

This rule is an enforcement of rule #6 of the General Livestock Rules. The validation form may be acquired at Rabbit Project Meetings, the Fair Office, or the County Extension Office. **The** validation form must be completed and turned in at Fair Office no later than June 3, 2024 at 5pm.

- 7. AFTER VALIDATION FORMS ARE TURNED IN, ALL VALIDATED EXHIBITORS MUST ATTEND AT LEAST ONE RABBIT PROJECT MEETING TO BE ELIGIBLE TO SHOW AT THE 2024 FAIR. Project meetings will be posted on the fair website.
- **8.** Those exhibitors breeding their own stock may also purchase a meat pen in the event their breeding stock does not breed, kindle enough kits, or dies prior to the fair. However, they may only enter in one meat pen division at the fair. The purchased pen will be tattooed separately from any home raised kits.
- 9. All meat pens shown must have the special tattoo in the right ear which will be placed there by an Austin County Rabbit Validation Committee member Monday, September 2, 2024 without exception. Family tattooing will be allowed for the Home Bred & Owned division only for the 2024 fair. Meat pens without this validation tattoo will be disqualified from showing at the Austin County Fair.

Each meat pen kit must have a permanent tattoo in their left ear **prior to tag-in. This permanent tattoo **will not be placed** by Austin County Rabbit Committee during tag-in validation. This tattoo will be noted at tag-in and must match when weighing in at the sift portion of check-in prior to the start of the rabbit show at the fair.

- 10. Tag-in fee must be paid at time of tag-in.
- 11. Exhibitors may have only one (1) entry (pen of 3) in this division but are eligible to exhibit one other entry in another livestock division.

- 12. A meat pen entry will consist of only three (3) rabbits, either sex, not over 70 days old and not exceeding 5 ½ pounds each in weight. Rabbits exceeding 5 ½ pounds at the show day sift will be disqualified from showing.
- 13. Entries in the Rabbit Show will move in on **Monday, October 7, 2024.** Exhibitors MUST enter the fairgrounds from FM 529 (Gate 2A), unload Rabbits under the Brandes Entertainment Pavilion, and then exit vehicle out to the parking lot (See map in Junior Livestock Show Rule Book). If necessary, you will be allowed to bring a vehicle back in after the Rabbit show to pick up Rabbits not staying and/or carrying cages. All exhibitors, parents, and guests must park in the main parking lot.
- **14.** Sifting and judging will be conducted under the Luhn Barn. Meat pens will be sifted starting promptly at 8:00 a.m. and will be judged immediately following. **No exhibitors will be allowed to unload prior to 7:00 a.m.**
- **15.** Youth Auction Sale General Rule #11 still applies if not physically or academically able to show. Forms should be turned in before judging starts.
- 16. The showmanship contest may begin, with a specific showmanship judge, during the meat pen show and continue throughout the rabbit show. There will be 3 classes/divisions. The classes will be divided according to the exhibitor's school grade as of September 1, 2024. Classes will be Juniors: 3rd 5th grade, Intermediate: 6th 8th grade, and Senior: 9th 12th grade. The contest may include a hands-on portion, oral questions and/or written test. This is up to the discretion of the judge.

If checking in or showing another animal, the Director in Charge of the show should be notified so you can show out of order. Exhibitor still must show by the end of the showmanship judging to be eligible for prizes.

17. The exhibitor is responsible for feeding their rabbits before 9am every morning and needs to supply their own feed and water bowls or bottle (can be secured with a zip tie) for all rabbits staying on the grounds overnight. All three (3) meat pen rabbits will be caged together in one pen.

A zip tie should be used to secure the cage doors from being opened. There will be no containers of feed, etc. allowed on top, in or under the cages.

- **18.** Exhibitors will move out at 8:00 a.m. on **Sunday, October 13, 2024**. No rabbits are to leave the fairgrounds before this stated date and time without prior consent from the Rabbit Director in Charge!
- 19. Self-addressed & stamped thank you cards for all buckles, trophies, prizes and cash awards won on Monday at the Rabbit Show MUST be turned into the Rabbit Director in Charge before moving out on Sunday, October 13, 2024 by 8:00 a.m.
- **20.** It is the responsibility of the exhibitor to have their Market Rabbits processed (if applicable) and delivered, dressed or alive to their buyer within two (2) weeks after the close of the Austin County Fair, but not until the drug testing results have returned.
- 21. Drug Testing will be performed on Grand and Reserve Champion and one (1) random pen chosen before the show starts. There will be no interfering with testing area and testing official. The drug tested animals are not allowed to be processed for their prospective buyers until results are back and the exhibitor has been notified.
- **22.** When Youth Auction Sale checks are ready, exhibitors will be contacted. In order to receive their check, exhibitors must bring *STAMPED and ADDRESSED HANDWRITTEN* thank you notes to their buyers and add on donors to the Fair Office.

- Once the Fair Office has checked the thank you notes, exhibitors will seal them and then receive their check.
- 23. Quality Counts: In keeping with the Austin County Fair drug residue avoidance policy, ALL exhibitors are required to pass the Quality Counts Verification test for entry into the 2024 Show. Junior market and breeding show entries will not be accepted without a verification code for each exhibitor. Verification codes are not required for Agricultural Mechanics exhibitors and Judging Contest contestants. The Quality Counts training and test can be found at: https://www.texaslivestockvalidation.com/qc/qcregister.aspx
- 24. It is absolutely unethical for anyone to ask the buyer of an exhibit to donate or sell back a sale lot to the exhibitor. The Fair Board will not tolerate exhibitors asking for animals to be donated or sold back. The violation of this rule could result in the forfeiture of any monies and/or prizes earned and be subject to other penalties assessed by the Austin County Fair.
- 25. No request to change the destination of the purchased animal(s) may be made by the exhibitor or parent. The buyers' written request is final. Once the buyer submits the written form to the sales clerk, the buyer is the only individual allowed to make changes to delivery or destination.

PURCHASED DIVISION:

- **{Rules # 6 #25 above ALSO apply to this division}**
- **26.** This is not an A.R.B.A or T.R.B.A sanctioned show. However, it will be governed by the American Rabbit Breeders Association guidelines as outlined by the A.R.B.A Standard of Perfection. All entries are subject to the General Rules and

Regulations of the Austin County Fair. Market Rabbits are also governed by the Youth Auction Sale rules.

- 27. Any entry showing symptoms of disease such as malocclusion, sore bleeding hocks, signs of a cold or sniffles, ear canker, mite or mange, vent disease, sore and runny eyes, mix breeds or other disqualifying features, may be excluded from exhibition at the discretion of the Rabbit Show Superintendent. No stock, except in the above instances, will be removed from the exhibition until the close of the Rabbit Show.
- **28.** The following meat pen breeds will be allowed:

D. Californian D. Palomino

E. New Zealand E. Champagne D'Argent

F. Satin F. Rex

- 29. Meat Pens are to be 70 days and no older with a breed date of 100 days prior to our show (July1st). A purchased pen will consist of no more than 10 kits. No crossbreeds may be shown.
- **30.** All exhibitors of Market Rabbits will be required to fill out a Market Validation Form (not entry card). This form will include a statement as to the physical location that the project will be raised with a release stating that this is for committee use of random checks. Random checks will be at the discretion of the committee.

This rule is an enforcement of rule #6 of the General Livestock Rules. The validation form may be acquired at 4-H Rabbit Project Meetings, the Fair Office or the County Extension Office. The validation form must be completed and turned in at Fair Office by June 3, 2024 no later than 5pm.

- 31. AFTER VALIDATION FORMS ARE TURNED IN, ALL VALIDATED EXHBITORS MUST ATTEND AT LEAST ONE RABBIT PROJECT MEETING TO BE ELIGIBLE TO SHOW AT THE 2024 FAIR. Project meetings will be posted on the fair website.
- 32. All meat pens shown must have the special tattoo in the right ear which will be placed there by an Austin County Rabbit Validation Committee. Meat pens must be validated/tagged-in at the Austin County Fairgrounds on Monday, September 2, 2024 **without exception**. Meat pens without this validation tattoo will be disqualified from showing at the Austin County Fair.
 - **Each meat pen kit must have a permanent tattoo in their left ear **prior to tag-in**. This permanent tattoo **will not be placed** by Austin County Rabbit Committee during tag-in validation. This tattoo will be noted at tag-in and must match when weighing in at the sift portion of check-in prior to the start of the rabbit show at the fair.
- **33.** Tag-in fee must be paid at time of tag in.
- **34.** Tag-in is per exhibitor, **NO** family tag-in is allowed for purchased pens.
- 35. Limit of (1) tagged pen of 10 or less kits per exhibitor.
- 36. Purchased Kits only will be weighed at time of tag-in and a maximum weight of 2 pounds 8 ounces will be allowed. Any kits weighing more at tag-in will not be allowed to be tagged.
- 37. A meat pen entry will consist of only three(3) rabbits, either sex, not over 70 days old and not exceeding 5 ½ pounds each in weight. Rabbits exceeding 5 ½ pounds at the show day sift will be disqualified from showing.

- **38.** Exhibitors may have only one (1) entry in this division but are eligible to exhibit one other entry in another livestock division.
- **39.** The judge will determine the overall Market Rabbit Champion and Reserve Champion from the two divisions. The sale order will then be allocated giving 65% of the eligible sale slots to the Bred & Owned division and 35% to the purchased division. If all sale lots allotted to a division are not used by that division, any remaining slots will be added to the other division.
- 40. Sifting and judging will be conducted under the Luhn Barn. The Purchased meat pens will be judged immediately following the Home Grown Division Show. The time of the Purchased Meat Pen sift will be published on the fair website once tag in numbers are evaluated in September. No exhibitors will be allowed to unload prior to 7:00 a.m.

- 1. This is not a A.R.B.A or T.R.B.A sanctioned show. However, will be governed by the American Rabbit Breeders Association guidelines as outlined by the A.R.B.A Standard of Perfection. All entries are subject to the General Rules and Regulations of the Austin County Fair.
- 2. Any entry showing symptoms of disease such as malocclusion, sore bleeding hocks, signs of a cold or sniffles, ear canker, mite or mange, vent disease, sore and runny eyes, mix breeds or other disqualifying features, may be excluded from exhibition at the discretion of the Rabbit Show Director in Charge. No stock, except in the above instances, will be removed from the exhibition until the close of the Rabbit Show.
- 3. Home Bred and Grown single fryer will show with Purchased single fryers in this show only.
- 4. Single Fryer breeds are limited to the following commercial breeds:

G. Californian D. Palomino

H. New Zealand E. Champagne D'Argent

I. Satin F. Rex

5. All exhibitors of Single Fryer Rabbits will be required to fill out a Market Validation Form (not entry card). This form will include a statement as to the physical location of the breeding stock (number of bucks and does with their permanent tattoo) with a release stating that this is for committee use of random checks. Random checks will be at the discretion of the committee.

This rule is an enforcement of rule #6 of the General Livestock Rules. The validation form may be acquired at 4-H Rabbit Project Meetings, the Fair Office or the County Extension Office. The validation form must be completed and turned in at Fair Office by June 3, 2024 no later than 5pm.

- 6. All single fryer rabbits shown **must** have the special tattoo in the right ear which will be placed there by an Austin County Rabbit Validation Committee member during mandatory tag-in at the Austin County Fairgrounds Monday, September 2, 2024.
- 7. Entries shall consist of one (1) single meat fryer only not over 70 days old, either sex, be a minimum of 3 ½ pounds and not exceeding 5 ½ pounds in weight. Rabbits exceeding 5 ½ pounds will be re-weighed once and then dis-qualified. Fryers are to possess the same qualities as meat pen rabbits but are judged as a single rabbit on its own merit. No crossbreeds may be shown.
- 8. Exhibitors may have only one (1) entry in this division and it may not be taken from the meat pen that was shown. This is a <u>prize only division</u> and will not be a market animal in the Youth Auction Sale.

Entries in the Rabbit Show will move in on **Monday, October 7, 2024,** no earlier than 9:00 a.m. Exhibitors MUST enter the fairgrounds from FM 529 (Gate 2A), unload rabbits under the Brandes Entertainment Pavilion, and then exit vehicle out to the parking lot (See map in Junior Livestock Show Rule Book). If necessary, you will be allowed to bring a vehicle back in after the Rabbit show to pick up rabbits not staying and/or carrying cages. All guests must park in the main parking lot.

9. Sifting and judging will be conducted under the Luhn Barn. Single Fryer rabbits will be weighed, sifted and judged immediately following the completion of the meat pen show, however no earlier than 9:00 a.m.

- 10. Youth Auction Sale General Rule #11 still applies if not physically or academically able to show. Forms should be turned in before judging starts.
- 11. The Grand and Reserve Single Fryer will stay at the fair on exhibition. The remaining single fryers may be released after the show to go home. These exhibitors are responsible for feeding/watering their rabbits before 9am every morning and need to supply their own feed and water bowls or bottle (can be secured with a cable tie). A zip tie to secure the cage doors from being opened is required. There will be no containers of feed, etc. allowed on top, in or under the cages.
- 12. Exhibitors **MUST** move out at 8:00 a.m. on **Sunday, October 13, 2024**. No rabbits are to leave the fairgrounds before this stated date and time without prior consent from the Rabbit Chairmen or Director in Charge!
- 13. Self-addressed & stamped thank you cards for all buckles, trophies, prizes and cash awards won on Tuesday at the Rabbit Show **MUST** be turned into the Committee Chairman before moving out on **Sunday, October 13, 2024** at 9:00 a.m.

RULES AND REGULATIONS PRIOR TO THE 2024 CALF SCRAMBLE

- 1. **ELIGIBILITY** Any boy/girl who has reached his/her 12th birthday by or on **September 1, 2024, and** has not exceeded his/her junior year in high school, is eligible to participate in the Calf Scramble. The boy/girl must reside in Austin County or be enrolled in a public school, private school or home school in Austin County AND be enrolled in a 4-H Club or FFA Chapter in Austin County. Participants may apply as many times as desired and may receive up to two (2) certificates. For any reason a Scramble project is returned or not completed, he/she may not be eligible to scramble again.
- 2. **PARTICIPANT APPLICATIONS** Application for participation must be submitted by interested persons to the Austin County Fair Office located at 1076 East Hill Street,

Bellville, Texas or the Austin County Extension Office, located at 803 E. Wendt Street, Bellville, Texas. Applications are available online at austincountyfair.com/calf scramble. Applications are available in a fillable format and must be printed and acquire appropriate signatures. All applications for participation are DUE on or before **September 10, 2024, by 5:00 p.m.** The Scramble Committee reserves the authority to determine the number of calves, number of participants and awards to be given based on committed sponsorships.

- 3. **MINOR RELEASES** A complete and notarized minor's release MUST be submitted along with the application. An incomplete minor's release WILL NOT be accepted. All information must be complete, and the form must contain the signature of both parents. However, one (1) signature will be sufficient in the event the parents are divorced or if one parent is deceased. It must be noted if one of the above situations apply.
- 4. **SELECTION OF PARTICIPANTS** Participants will be selected based on the following: Adequate facilities, Availability of resources and Desire to raise and show a beef heifer. The selection process will also include the Review of the Scramble application, If you have scrambled and caught previously and A typed essay prepared by the applicant. The essay will be required to contain information regarding the above mentioned special requirements.
- 5. **SCRAMBLE PARTICIPATION** All participants and at least one (1) parent must be present by 5:30 p.m. or forfeit the right to participate in the Calf Scramble.
- 6. **LIABILITY** The Austin County Fair Association of the State of Texas and any person associated with the Calf Scramble Committee will not be held liable for any accidents which may occur to any participant of the Calf

Scramble, before, during or after this event.

- 7. **CERTIFICATES** The total award for all calf scramble recipients is \$1,200; a \$1,000 of which will be used to purchase the heifer and \$200 of which will be received upon return to the Austin County Fair provided that all obligations are fulfilled. Purchase certificates in the amount of \$1,000 must be used in the purchase of a registered breeding beef heifer or a haltered commercial beef heifer prior to **December 31, 2024**. If you purchase a registered beef heifer and you wish to show, at the major livestock shows, you MUST purchase your animal prior to **November 1, 2024**, and have the registration paper in your name before **November 1, 2024**. Check with the 4-H Extension Agent or FFA Advisor for information on Major Shows and Validation.
 - A. The County Extension Agent, Committee Member or the Ag Science Teacher (the same one that is stated on the original application for participation), MUST sign the certificate once they have inspected the animal to be purchased. The calf must have been born between January 1, 2023, and May 31, 2023. Please refer to the Austin County Fair rules for Commercial Heifer requirements for breeding. The certificate also requires the signature of the Scramble winner. Upon completion of selection, the scramble winner/breeder/seller must present the certificate to the Austin County Fair Office to submit for payment of the animal.
 - B. The payment will not exceed the amount of the certificate which is \$1,000. If a heifer is purchased for less than the certificate amount, a check will be issued to the seller/breeder for the actual cost of the animal. If the heifer purchased is more than the value of the certificate, then the additional cost will be at the expense of the Scramble winner.

- C. The certificate may also be used for a heifer that was purchased by a Calf Scramble participant between
 August 1st and the 2024 Calf Scramble. In this case, the check will be issued directly to the participant.
- D. The completed certificate MUST become the property of the Austin County Fair Association by **January 8**, **2025**. The seller will not receive payment until required documents are in the possession of the Austin County Fair. A copy of the registration paper containing an official stamp of the Austin County Fair Calf Scramble will also be provided to each winner to be used upon entry into any qualifying show in the state of Texas.
- E. The division selected on your scramble certificate will be the division you will show in at the Austin County Calf Scramble Show.
- 8. PURCHASING The beef heifer to be purchased with the certificate MAY BE a purebred or full-blood or any breed recognized by any Texas Major Stock Show. The beef heifer may also include any beef breed or cross eligible to enter the Austin County Fair Halter Heifer Show. Any halter heifer (non-registered or commercial) must be tagged/entered in the Austin County Fair Halter Heifer Show. Commercial Heifers will not be eligible to show at Major Stock Shows.
 - A. The Scramble winner will be allowed to purchase their animal from any breeder offering registered or commercial beef heifers.
 - B. Due to the purchase date requirements for Major Stock Shows, the Scrambler must have a bill of sale and registration papers for the animal.
 - C. The Scramble certificate for the current year can be used to purchase an animal from a family member or themselves for \$1,000.00.

- D. Halter heifers (non-registered or commercial)

 MUST BE TAGGED with the option of entering in the Austin County Fair Halter Heifer Show.

 Scramble/halter heifers are eligible and may be exhibited in the Austin County Fair Halter Heifer Show and are eligible for the Youth Auction Sale. Halter heifers must meet ALL requirements of the Austin County Fair Halter Heifer Show to remain eligible to compete in the Scramble Show.
- 9. VACCINATION/ DEHORNING All heifers MUST be dehorned or polled to be eligible to show. All heifers must be brucellosis vaccinated between the ages of 6 months to 1 year of age and be tattooed with a brucellosis tattoo as well as an identification tattoo or brand. The heifers MUST be dehorned by tag-in, which is held in May. Any growth implants used by the rancher or exhibitor MUST be approved for use in breeding heifers. Heifers should NOT be bred prior to March.
- 10. **HALTER BREAKING** If a Scramble heifer cannot be halter broken, it will become the responsibility of the Scramble winner to notify the breeder and the committee by **January 31, 2025**. The Calf Scramble Committee will determine the course of action.
- 11. **MOVING** Any Scramble winner who moves out of Austin County, withdraws from a school in Austin County or is not in good standing with 4H and/or FFA in Austin County (See Rule #1 of Scramble rules) will be required to pay \$1,000.00 cash to the Austin County Fair Association. A written notification of the move MUST also be presented to the Calf Scramble Committee 30 days prior to the move or as soon as possible.
- 12. **MANDATORY PROGRESS SHOW** The show will be held on **August 10, 2024**, at the Austin County Fairgrounds. Scramble heifers must be present at the

progress show to be eligible to show at the Austin County Fair. Scramble heifers must be exhibited by their owners unless he/she is physically challenged and unable to do so. All Scramble heifers must be broke to lead and easy to handle. Unmanageable Scramble heifers will be required to return to the fairgrounds on the date provided by the Scramble Committee for a second evaluation. If a Scramble heifer is not manageable by the Scramble winner at the second evaluation, the project will be terminated and the \$1,000.00 in cash will be required to be paid to the Austin County Fair within thirty (30) days.

All Scramble heifers and Scramble winners are subject to the General Rules and Regulations of the Austin County Fair Association and the Calf Scramble Program. The Scramble Show at the 2024 Austin County Fair shall be limited to the 2023 Austin County Calf Scramble winners ONLY.

The winner is required to read all correspondence received from the Calf Scramble Committee, abiding by ALL rules and responsibilities set forth by the Committee and the Austin County Fair Association.

13. **MONTHLY REPORTS** – Monthly reports are due by the 10th of each month beginning with the first report in February through September. If the 10th falls on a weekend or holiday, the report is due on the next business day. Monthly reports are due at the Austin County Fair office by 5:00 p.m. The monthly report can be hand delivered or dropped in the drop box at the fair office. Each winner will be required to submit an adequate number of copies for each sponsor, provide self-addressed stamped envelopes and appropriate postage. A copy of the monthly report will then be sent to the Sponsor(s), and a copy will be kept on file by the Calf Scramble Committee for judging.

Monthly reports should include activities for the month,

what you have learned, how much and what type of feed you are feeding, shows attended, challenges, memorable moments, vet visits, etc.

Late reports – If a late report is received the scrambler will receive a written warning. If a late report is received a second time the scrambler will forfeit the \$200.00 bonus incentive at the end of the program. Late reports will not be judged.

14. MANDATORY MEETINGS – All Scramble winners must bring their heifers to the first meeting of the year held in January (date to be determined on an annual basis). Winners and their heifers MUST attend the TAG-IN at Four County Auction Barn in Industry as well as the Mandatory Progress Show (evaluation of manageability) scheduled to be held in August. The heifer will be required to participate in the Austin County Jubilee/Sizzler calf show. If an emergency arises, you must notify the committee IN ADVANCE if you cannot attend.

15. BEEF PROJECT MEETINGS/Advocacy Opportunities

- You can earn extra points for each beef project meeting attended and by participating in Advocacy Opportunity
 Points such as Newspaper Articles (3 points), Referrals (2 points), Facebook posts (2 points), and Speaking Events (5 points).
- 16. **HEIFER DISPLAY PICTURE** —With your final monthly report, 5 x 7 picture must be provided of the heifer to the Scramble Committee to be used at the fair for sponsor recognition. In the picture, the heifer should be clean and clipped with a show halter. The Scramble winner must be dressed in show clothes. It is requested that the picture only contain the scramble winner and their heifer. It is highly recommended that you use a picture taken at a show with a professional backdrop.

- 17. **ENDING ESSAY** A typed Ending Essay with a minimum of 500 words entitled "What My Calf Scramble Project Means to Me", MUST be submitted to the Calf Scramble Committee on or before, the date provided in your Scramble supplemental handbook. You may use stationary. You may include what you have learned, new experiences, plans you have for your calf inthe future, if you will continue to raise cattle, etc. Be creative and be sure and check for grammatical errors.
- 18. **PHOTOGRAPHY** This contest is optional. Once this contest is entered, you MUST participate on a monthly basis. Failure to participate during any one month will result in disqualification from the contest.
 - A. Scramble winner shall submit one (1) 5x7 picture per month due February throughSeptember.
 - B. The photo of the heifer should be taken by the exhibitor. If someone else takes the photo, the pictures should include both the heifer and the Scramblewinner.
 - C. The back of each photo(s) should include labeled with the exhibitor's name and month the photo was taken.
 - D. Photo(s) will be analyzed as a means of promoting the Calf Scramble project as well as the beef cattle industry.
 - E. Any type of enhancement to photographs will be left to the discretion of the Scramble winner.
 - F. Pictures submitted for this contest will be displayed in the Scramble display during the Austin County Fair.
- 19. **SCRAPBOOK** –The scrapbook is optional. If submitting a scrapbook, it must be submitted with the following:

- A. Maximum size being no larger than 14x14, 5"thick and cannot exceed 20lbs.
- B. The Scrapbook should be a minimum of 25 pages.
- C. The cover must be decorated. Please use standard covers.
- D. Scrapbook should contain only scramble project activities and a maximum of 2 pages about the exhibitor.
- E. Electronic Scrapbook programs can be used to generate yourbook.
- F. The Scrapbook should consist of the following: Cover, cover page, table of contents, application, 2 pages of who you are, sponsors correspondence, your calf sponsor thank you note, monthly expense reports, ending essay and fighting heart essay.
- G. The Scrapbook competition will be judged in accordance with the supplemental handbook provided at the first Scramble meeting. Each Scrapbook must be completed and submitted to the Committee by the date provided in your Scramble supplemental handbook.
- 20. **FIGHTING HEART ESSAY** This essay is optional. The essay needs to be your scramble project and must be a minimum of 500 words typed. It is suggested you write about hardships during your project, how you overcame the hardship, and why you think you have a fighting heart.
- 21. **SHOW YOUR CALF** You get 1 point towards the overall point prize for each show you attend. Multiple shows on the same day at the same location will only be awarded 1 point. You must fill out the Points Form and must be signed by a show official or a scramble committee person in attendance.
- 22. HERDSMAN Herdsman will be selected by your peers. One overall Herdsman award will be awarded.

Factors judged on will include but not be limited to: Heifer must be fed and watered by 9:00 a.m. You must be picking up and cleaning your area. Being a good neighbor and being considerate of others. Keeping your animal clean. Helping maintain the scramble area and keeping it neat and clear of trash. Being with your heifer when you are not participating in other fair activities.

- 23. **STALL BOARDS** The stall board should be limited to the front of the stall ONLY and should not contain any lights, electrical or battery-operated features, mirrors and glass or reflection material. The display shall not exceed 3 ft. in width and 3 ½ ft. in height. No decorations should extend past the outside of the 3' x 3 ½' perimeter. Use ¾' plywood and frame it with 1x4's around the border on the backside. Make sure the nails/screws do not stick through the backside. Display should not have legs. Stall boards will be installed prior to the show by the committee. Date and time will be provided. All stall boards must be completed and installed at the stated date and time.
- 24. **STALL SET UP** Scramblers and at least one parent are required to be at the fairgrounds to install the stall boards on a date to be provided. Please be prepared to work on the Scramble area display. At this time, you will need to bring shavings, a rake, and shovel and be dressed and prepared to work.

NO stall dividers will be used except at the discretion of the committee.

Feed and water buckets must not be left in the stall unattended and a neck tie must be on the heifer at all times while in the stall.

The use of a circular fan on an "L" bracket is permissible. Butt fans on a stand are NOT allowed. The Scramble Committee will determine the number and placement of fans.

Scramble winners are responsible for daily care of animals and stall space. Scramble heifers are to be fed, watered, cleaned and in the stall space by 9:00 a.m. and must remain in the stall until 5:00 p.m. each day.

- 25. **SHOWMANSHIP** Showmanship is a very important aspect of presenting your animal. All Scramblers must participate in showmanship. Prizes, cash and points will be awarded.
- 26. **AWARDS** -in the Scramble Program will be presented as follows: Grand Champion Heifer, Reserve Champion Heifer, Division Champions, Reserve Division Champions, Showmanship, Best Monthly Reports, Ending Essay, Photography, Best Scrapbook, Best Stall Board Presentation, one (1) Fighting Heart Award and one (1) Herdsman. Incentive prizes will be awarded per category.
- 27. **OVERALL POINT CHAMPIONS PRESENTATION** We will meet at Sunday 9:00 a.m. to announce the herdsman awards as well as the Overall Point Champion and Reserve Champion. All Scramblers must be present at this meeting.
- 28. All entries will be exhibited and sold by their owners unless he/she is physically unable to do so or if the exhibitor has more than one entry showing in different divisions at the same time. Exhibits to be shown or sold by someone else other than the owner must be approved in writing by the respective committee chairman. It is the responsibility of the exhibitor to obtain and complete the required form. Forms will be available at the Fair Office. If an exhibitor is academically ineligible to show, the exhibitor AND THEIR PROJECT are ineligible to participate in the Austin County Fair.

- 29. No trim chutes will be allowed. This show is a blow and go show so no filling products, adhesives or oils are allowed. All rules regarding grooming of cattle shall comply with Austin County Fair Commercial Heifer show rules.
- 30. Heifers will be shown by their division. Divisions will consist of Registered Heifers: American, British and Exotics and Commercial Heifers.
- 31. Health papers are not required to participate in the Calf Scramble Show. If you are showing in the Halter Commercial Heifer show, you **MUST** obtain health papers.
- 32. **CALF INSPECTIONS -** County Extension Agents, Ag Science Teachers and members of the Calf Scramble Committee reserve the right to inspect these projects at any time.
- 33. **TEAR DOWN** Sunday after the Overall Points presentation we, as a group, (Scrambler and at least one parent) will tear down the Scramble area. This will include taking down stall boards, cleaning up all shavings, etc. Please bring a rake and shovel. Both the Scrambler and a parent must be present and assist in the cleanup in order to receive the final \$200.
 - 34. **THANK YOU NOTES** Final thank you notes to all sponsors must be submitted to the Austin County Fair Office by December 1st. Thank you notes MUST be addressed correctly and the correct postage applied. The project WILL NOT be deemed complete until this requirement has been met. Thank you notes will be reviewed at the fair office, upon completion, the exhibitor will receive the remaining \$200.
 - 35. SPECIAL NOTE **FAILURE TO COMPLY WITH ANY AND ALL OF THE ABOVE STATED CALF SCRAMBLE RULES WILL RESULT IN TERMINATION FROM THE PROGRAM AND

REIMBURSEMENT OF THE 1,000.00. \$1,000 CASH MUST BE PAID TO THE AUSTIN COUNTY FAIR WITHIN THIRTY (30) DAYS OF THE TERMINATION. FOR COMMERCIAL HEIFERS WHO DO NOT COMPLY, THE EXHIBITOR WILL NOT BE ALLOWED TO SHOW OR TO SELLTHE SCRAMBLE CALF AT THE AUSTIN COUNTY FAIR AND WILL BE REQUIRED TO REPAY THE \$1,000.00 WITHIN THIRTY (30) DAYSOF THE TERMINATION. **

- 2. To show one's pride in himself/herself and his/her horse

- 4. To demonstrate sportsmanship, discipline, and responsibility for their horse's care
- 5. To learn and apply sound nutritional, hoof, and health practices
- 6. To provide a continuing program for exercise, fitness, and conditioning
- 7. To instill a knowledge of proper grooming and handling of a horse to assure each horse will reach its ultimate growth potential.
- 8. Exhibitors will also demonstrate knowledge of showmanship to exhibit their horse to its best possibility.

Classes at the Fair will be:

Performance Yearling Filly at Halter Performance Yearling Gelding at Halter Non-Sale Performance Yearlings (if appropriate) Junior Showmanship at Halter 3rd – 5th Grade Intermediate Showmanship at Halter 6th – 8th Grade Senior Showmanship at Halter 9th -12th Grade

The committee will allow one (1) early evaluation with the prior approval of the Committee Chairman.

All meeting times/locations are subject to change at the discretion of the Committee Chairman. We utilize the Remind App to send out reminders and updates. **Please download and ask to be added to Colt Project group!**

If there are two (2) horses or less in a class, the project reserves the right to combine classes.

All exhibitors and their horses will participate in Showmanship Class. The Showmanship exhibitor must be the owner of record.

If a colt is permanently injured or dies before the second mandatory weigh-in, a substitute colt will be accepted for exhibition. This acceptance will be based upon a decision by the project committee and a vet chosen by the committee. This vet will check the colt for verification of permanent disability, which would prevent the colt from being shown or sold at that year's fair. If a colt has a serious injury at any time during the project, the exhibitor is required to inform the committee.

All equine entries are subject to the General Rules and Regulations of the Austin County Fair and to the rules governing the Youth Auction Sale.

RULES AND REGULATIONS

- 1. It is required that a gelding or filly from the performance horse bloodlines be chosen. Exhibitors in the Austin County Colt Project will exhibit colts from the performance/stock horse lineage with qualities that preserve the working American Quarter Horse type (AQHA or APHA). Exhibitors will select well-mannered individuals in the order of their resemblance to the breed ideal and that are the most positive combination of balance, structural correctness (straight legs), and movement with appropriate breed and sex characteristics and adequate muscling. Colts will be judged on quietmindedness and willingness to perform for the exhibitor, as well as his capability to be a good riding horse. The judge will give preference to colts with conformation, structure, balance and quality of movement that is related to the colt's ability to perform under saddle, and who also display a quietminded, willing attitude. This class will be judged as a Performance Horse Halter Class. Colts with 20% or more of non-performance bloodlines will not be eligible to be shown.
- 2. There will be no substitutions after the 1st required evaluation except in the case of the colt's death or permanent injury before the 2nd mandatory weigh-in as explained above. The committee will evaluate and approve this on a case-by-case basis. All stud colts must be gelded by the April weigh-in.

- 3. All horses in the Austin County Fair Colt Show and Sale must have been fed and cared for by the exhibitor in an approved location for the duration of the project. Daily care, fitting and handling of the horses will be limited to the exhibitor and his/her immediate family members classified as a person living in the same household. If notified, the Austin County Fair Colt Project Committee members, Austin County Extension Agents or Bellville, Brazos, Faith Academy or Sealy FFA/Ag Science teachers will be allowed to assist. Rules 20 and 21 in the General Rules and Regulations will be strictly enforced. If the exhibitor does not meet the qualification above, the exhibitor will be disqualified from the show and sale.
- 4. All colts/fillies must have HERDA test results prior to being checked in at the first weigh-in/evaluation.
 - a. Fillies and Geldings with a HERDA test result of HRD/HRD are NOT eligible to be shown.
 - b. Fillies/Geldings with a HERDA test result of N/HRD are eligible to be shown.
 - c. Additionally, if a colt/filly is a descendant of any halter-bred lineage, then he/she must also have a negative HYPP test result prior to being checked in on April 7. If HYPP is not labeled on the colt's registration papers, then the colt/filly must be tested for HYPP. Colts AND/OR fillies with a test result of HYPP H/H or HYPP N/H will NOT be eligible to be shown.

A COPY OF A NEGATIVE COGGINS, HERDA RESULTS AND/OR NEGATIVE HYPP RESULTS and **clearly documented** proof of VEWT, Flu, Rhino, West Nile Virus and Rabies vaccinations MUST BE TURNED IN AT THE APRIL EVALUATION. (We will provide a form for documenting the vaccines.)

Colts must have two (2) rounds of VEWT, Flu, Rhino, and West Nile Virus. There is a 4-week period between initial shot and booster. Strangles vaccines is highly recommended but not mandatory. If giving the Strangles vaccine, be sure to administer booster as well.

- 5. A current Negative Coggins are required for all horse entries and horses must be sound and in good health upon arrival at any venue, including Lequerica Ranch and the Austin County Fairgrounds.
- 6. Each 4-H or FFA member is limited to one (1) horse in each division. Divisions are Performance Yearling Fillies at Halter, Performance Yearling Geldings at Halter, and Non-Sale Performance Yearlings at Halter. A 4-H or FFA member cannot show both a Performance Yearling at Halter and a Non-Sale Performance Yearling at Halter.
- 7. Exhibitor or immediate family member (same household) must own horse(s) on or before the horse's first required evaluation and must continue to own horse(s) throughout the project period.
- 8. The 1st official horse project registration and mandatory weigh-in and evaluation is 1st Sunday of April at Lequerica Ranch. There will be no other registration date. **Horses should be halter broken and manageable.**

- 9. The final mandatory soundness evaluation for all exhibitors will be the 1st Sunday in October at 6 p.m. at Lequerica Ranch on. At this meeting, a soundness exam will be administered by a licensed veterinarian appointed by the Colt Project Committee. The veterinarian will be assisted by the committee. Examination results must be acceptable for the horse to be exhibited and/or sold at the Fair.
- 10. If a substitute showman is needed to show a colt during the Fair due to a conflict with another show animal, the substitute must be chosen from the Colt Project exhibitors. Also, if a substitute is needed, he/she will only show the colt in the appropriate halter class. He/she will not show the colt in a showmanship.
- 11. In keeping with the Austin County Fair drug residue avoidance policy, exhibitors are required to pass the Quality Counts Verification test for entry into the 2024 Show. Entries will not be accepted without a verification code for each exhibitor. The Quality Counts training and test can be found at http://qualitycounts.tamu.edu./verification/.

ENTRY, RELEASE & INDEMNITY FORM, DRUG CERTIFICATION FORM, W-9 AND APPLICABLE FEES ARE DUE IN THE FAIR OFFICE BY AUGUST 30 via the online entry system at www.austincountyfair.com.

- 12. The show will be conducted according to AQHA rules and regulations where applicable and will be judged as a Performance Horse Halter class by AQHA/APHA carded judges. Austin County Fair General Rules and Horse Project Rules take precedence over AQHA rules.
- 13. During the Fair, all horses are subject to blood, urine or saliva tests and re-evaluation conducted by a veterinarian and supervised by the Livestock Superintendent or the Committee Chairman before being administered by a veterinarian.

During the Austin County Fair, all medications must be administered by a Fair veterinarian.

- 14. All horses must be shown free of a prohibited substance (medication) in accordance with AQHA rule 441(h), or forfeit its sales check and all other awards. Non-sale animals will forfeit all awards. A prohibited substance is defined as any stimulate (Example: Epinephrine), depressant (Example: Demerol), tranquilizer (Example: Acepromazine), or local anesthetic (Example: Procaine), which may affect the performance of a horse, or any drug classified as a steroid. Also prohibited are any drugs, regardless how harmless or innocuous they might be, which may interfere with the detection of the aforementioned drugs. Such drugs are masking drugs. Some examples of masking drugs are as follows: Polyethylene glycol, Thiamin, Dipyrone, Furosamide, and other potent diuretics, Sulfa drugs, Benzimidazole Anthelmintics (wormer) and Isoxsuprie.
- 15. Drug Testing will be performed on Grand and Reserve Champion Geldings and Fillies and one (1) random Gelding and Filly. No interfering with testing area and testing official.

DIVISIONS

YEARLINGS

- All yearling horses must be foaled between January 1st and December 31st of the preceding year of the Fair.
- 2. All yearling exhibitors are required to have registration papers showing exhibitor's name or showing an immediate family member (same household) as owner.
- 3. A legible, hard copy of registration papers must be turned in to **Sheila Lequerica** by the April weigh-in.

- 4. The Grand Champion and Reserve Champion mare and gelding in the Yearling division must sell in the Youth Auction Sale. The remaining number of colts to sell will be allocated and established each year by the Austin County Fair Youth Auction Committee. If the exhibitor has another higher placing animal in the sale, the next placed horse of the same gender will move up to sell.
- 5. The winning horse in this division will be designated Grand Champion Performance Yearling Filly, Reserve Champion Performance Yearling Filly, Grand Champion Performance Yearling Gelding and Reserve Champion Performance Yearling Gelding.

We are excited that you have chosen to participate in the 2024 Austin County Fair and Livestock Show Bucket Calf Show. The project was started to expose youth to the basic care and responsibility of caring for a calf.

Guidelines

Eligibility

- Open to Austin County youth ages 4 8 years old, Pre-Kindergarten to 2nd grade. Participants turning 9 as of August 31, 2024 are ineligible.
- Participant must attend 3 Bucket Calf Project meetings between February and September.
- Meetings are held the 3rd Monday of every month.
- Participant must be able to halter break and lead a calf.
- Participant and their calf <u>must attend</u> the mandatory Progress Show in August 2023 (actual date TBD) in order to show at the Austin County Fair. (*The Progress Show attendance does not count towards* the 3 meetings.)

Calf Requirements

Project calf must be born between May 1, 2024 and July 8, 2024 (must be born 6 weeks prior to Progress Show).

- All bucket calves are required to be vaccinated by August 1, 2024 of current year.
- Calf must be bottle fed. No nurse calves.
- Project calves can be any gender/breed.
- If a calf becomes ill and/or dies, a replacement calf can be purchased as long

as it is born before July 8, 2024.

Project Requirements

- Entry Form completed and fee of \$40 due at Progress Show.
- Participant will complete vaccination records as part of their entry form at Progress Show.
- Read and be familiar with the general rules stated in the Rules and Regulations of the Austin County Fair & Livestock Association, including the NO PASS- NO PLAY policies and the Substance Avoidance Program.
