Back in May, I accompanied Bob Richards and Gene Suggs as they led an intrepid group of residents in the annual Take Pride in Smith Mountain Lake Cleanup. By the end of the morning, Gene's pontoon boat was literally filled with shoreline debris, thanks to the help of Robbie Hallock, Woody Gregory, and John Russ. Meanwhile, on shore, Judy Mackey did a splendid job cleaning up the launch area.

As summer has moved into fall, we can be pleased that Village East residents clearly take pride in the attractive appearance of the landscaping on both common areas and privately maintained property. In the maintenance category, we replaced one of the two nets at our tennis court in recent weeks, and the court's surface will be cleaned within the next month. Many thanks to Dave White for his help with the installation of the new net.

The lights at our entrance way have been regularly maintained by Mark White, without whose help we would certainly have needed to pay an electrician on more than one occasion. Please thank Mark when you see him. At Mark's suggestion, we will be replacing the standard lights with LED lighting which should save us in the long run because LED lights are manufactured to last over ten years. We'll see!


