
ROADS STUDY TEAM

Within the next few years Village East will face the major expense of repaving/overlay/repair of Indian Ridge Drive. While we have been planning for this event financially we have also been made aware that a program exists for possibly placing this road under VDOT/Bedford County for long term maintenance responsibility with an initial costsharing protocol that is built into the program A study team consisting of Woody Lewis, Robert Leonard, and myself are obtaining cost estimates from VDOT and others and reviewing additional considerations (both pro and con) so that we get a complete picture to present to the Board of Directors in May. (You may have seen VDOT in our Village East community recently obtaining info for their estimate.)

Whether we proceed with asking VDOT/Bedford to petition for the inclusion of Indian Ridge Drive as a secondary road is a question we should resolve at this time. We plan to attempt that answer in May.

GROUNDS COMMITTEE

After this long and cold winter, the beautiful blossoming trees and shrubs are a welcome sight here in Village East.
Our landscapers, Ruggieri Lawns, LLC., have gotten us off to a great start with trimming trees, pruning shrubs and mulching all the gardens around community property. All is well.

A memorial tree has been planted in honor of the late Melvin (Doc) DeVed, former Grounds Chairman and Board member for many years. The Eastern Redbud tree is located behind the clubhouse amongst other memorial trees in that area. Doc's tree will have rose pink blossoms in early spring with heart shaped leaves to follow the rest of the season.

The road cleanup was held March 29th in spite of the threat of rain. Nine bags of trash were collected along with one tire and a large drain pipe. Aluminum cans were collected and donated to T.E.P. Thanks to our volunteers, Chuck & Chris Dideon, Mona Richards, Geoff Orth, Woody Gregory, Mark & Ellen White, Robbie Hallock, Bob Leonard and Jim Gerhart.

Our Protective Covenants state that all lot owners are responsible for maintaining their lots in a clean, orderly and attractive manner. This includes fallen trees, wood and brush piles and any other unsightly eye sore that impacts your neighbors and the community. Mid March, a large tree fell across Land Harbor Lane. Rick Carroll and Geoff Orth volunteered to clear the roadway. The lot owners were notified and they arranged to have the debris hauled away. Thanks to Rick and Geoff for helping out and also thanks to the lots owners for a timely resolution to this matter.

Our thanks go out to Wade Najjum and friends for mulching the Crown Point cul-de-sac. Also, thanks to June Najjum for agreeing to care for the corner garden at Indian Ridge and Wagon Wheel Trail. What would we do without volunteers!

POOL

Pool season is quickly approaching and with that in mind, I would like to refresh everyone's mind about the pool rules and pass on some other important information as well. Last season we had several rules violations regarding the no smoking and no alcohol policy at the pool. It is the property owner's responsibility to remind all guests and renters about the pool rules. Failure to follow these rules will not be tolerated and could result in loss of privileges or an early closing of the pool for the season.

IMPORTANT POOL INFORMATION

- For the protection of our residents and Village East property, closed circuit security cameras have been installed in the pool and clubhouse area.
- The handrails and ladders in the pool had to have bolts and housings replaced to ensure they were tightly secured. Please ensure there is no unnecessary hanging or swinging on the ladders or handrails. If these fixtures pull out of there housings again, it may be necessary to drain the pool in order to repair and secure them again. We want to enjoy our pool this summer without any interruptions for things that we can help prevent.

POOL RULES

SWIM AT YOUR OWN RISK. No lifeguard service is provided. All persons use the pool and clubhouse at their own risk. Village East Property Owners Association will not be responsible for any accidents, injuries or loss of personal property.

- 1. <u>Everyone</u> must sign in on the sheet in the clubhouse
- 2. Members, guests & renters <u>MUST</u> have membership card to use facilities.
- 3. Members are directly and completely responsible for the actions of their children, guests, and renters while on the premises.
- 4. Children under the age of 16 must be accompanied and supervised by an adult.
- <u>NO</u> alcoholic beverages, glass containers, animals, loud music or boisterous conduct is allowed.
- 6. **NO** Smoking in the pool area.
- 7. Clean your area before you leave.
- 8. Parking is allowed in the lot and on side roads, no parking on the main road (Indian Ridge Drive).
- 9. Member privileges may be suspended for anyone violating these rules.
