emergency operations plan (EOPs). We also work with childcare programs to qualify them as part of our Childcare Disaster Readiness

Certification Program. We have two campaigns designed to prepare children and individuals for disaster.

1. I'm Ready So's Teddy Campaign - At these workshops we are helping pre-school children design "ready bags" to place under their beds

in case they need to leave quickly. We talk with parents about disaster preparedness learning resources. We provide a kids "ID" card

parents can fill out and put in the bag, as well as a list of items recommended "ready bag" supplies / items.

2. Campaign Early Prepare - Earthquakes - Starting in Kitsap County, WA - we provide story time earthquake trainings with song and

practice/drill to children at childcares around the county so that they are prepared for when an earthquake strikes. We are also

working with childcare programs to be better prepared and increase participation in the Great ShakeOut. We trained over 500 children

in 2019.

Line 29 - Office of Emergency Management Integration - We help bridge the gap between emergency management and childcare by providing

resources that integration options that merge both 'cultures.' Some of the items we provide include: EOPS, fact sheets and resource guides.

We speak directly to emergency managers about the importance of planning for childcare preparation and recovery in their own plans.

In 2019 we presented at international conferences and engaged local and state emergency managers on childcare preparedness issues.

Line 30 - Public Information - Our public education programs are designed to do the following: Give Policymakers accurate statistics on

childcare program preparedness and recovery status and obstacles. Provide business continuity planners accurate statistics on childcare

program preparedness and recovery status and obstacles. Inform the public about the need to talk with children about disaster preparedness

and to help childcare programs prepare for disaster. We attended local preparedness and information events in 2019 to talk with families

and professionals about the need to prepare themselves and their families for disaster.
