In consideration of the repairs and improvements, I further hold RTPC, its board, staff, agents, donors, volunteers and other affiliates, collectively and individually, harmless from any suits, liabilities and expense, including but not limited to, attorney's fees, expenses and costs of court arising at any time as a result of the repairs, including, without limitation, any rights or causes of action resulting from personal injury or death, or damage to, diminution of value or loss of my property, directly or indirectly arising from any improperly performed repairs or improvements or defects in material or workmanship. This waiver and release applies to any act of negligence, omission, mistake, delay or failure.
