Attending: Kayla Riek, Annie Swift, Brandon Glaza, Sarah Skinner. Meeting called to order at 7 p.m.

Guests: - John Beck and Sharon Helms — Boundary County Tennis Association. Are curious where we are at with the replacement of the tennis Courts. B. Glaza stated that the bids received for the replacement of the courts far exceeded the anticipated costs (approx.. \$250K estimated with the bids coming in excess of approx.. \$500K.) The proposal was 2 tennis courts and 4 pickleball courts on the footprint of the current tennis courts and removal of the mound to the back board of the baseball field. There was discussion as to what options are available (2 tennis 2 P. ball., no designated P. ball with p-ball overlays on two tennis courts, etc). we are looking at options for facilitating both tennis and pickleball. B. Glaza stated that BCTA may want to discuss the options proposed and get back to us or possible attend a commissioners meeting. Brandon stated there is a great interest as to pickleball courts so they can't be ignored. Sharon Helms stated that she would return with Kim from 9B pickleball. They will work on their proposal and get back to us.

Linda Lederhous: Bonners Ferry rotary. She has a sign that says in several languages "May Peace Previal on Earth". She asked is there a good place along the North fields and / or the walking path to place that. There was discussion as to can we ask the tribe to also put something in their language?? She stated that they asked the tribe and never heard anything back. There was also discussion as to methodology to erect the sign. We will find a place to put the sign by the walking area and T Dougherty will get with Gary Akin on the tribes desire to be included.

Previous Minutes: Sarah motions to approve last month's meeting minutes. Kayla seconds the motion and motion is approved.

Maintenance Report: Kenny has not been very busy given the slow nature of the weather as well as not allot of usage down at the park. He will continue to monitor. He really isn't working that much right now

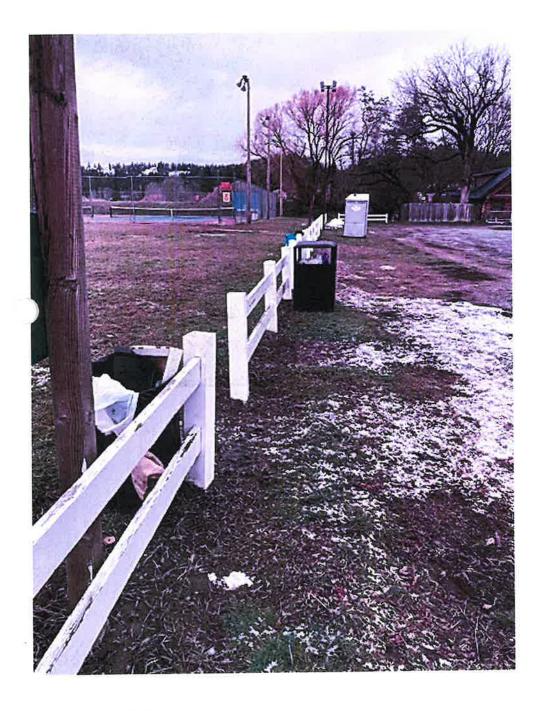

Memorandum of Understanding between Boundary County Skatepark Alliance and Boundary County Parks and Recreation

Boundary County Skatepark Alliance - BCSA is an all-volunteer advocacy group formed for the purpose of providing the youth of Boundary County with a safe well-lit all wheel skatepark facility.

Boundary County Parks and Recreation - BCPR board is the 7-member board under the supervision of the Boundary County Commissioners. Their mission is to enhance the quality of life for those living in Boundary County by providing safe, well-maintained parks and recreation opportunities for people of all ages and abilities to play, to learn and to build community. The current skatepark is under their supervision.

The objective

The project to build a new skatepark facility is slated to take approximately 3-5 years but could in actuality take much longer. The project started in May of 2022. This project is estimated to cost \$500,000 - \$750,000. The proposed facility will replace the current 2000 sq ft slab with an 8,000-10,000 sq ft facility.

Responsibilities

BCSA will be responsible for all fundraising, advertising, purchasing of official blueprints and the writing of grants. BCSA will be responsible for the project until completion, whereby it becomes the responsibility of BCPR. BCSA will keep BCPR updated on the progress of the project through Sarah Skinner who is a member of both groups. BCSA will consult with BCPR for their approval for landscaping and other accessory projects not specifically addressed in design prints.

All funds collected by BCSA for this project will be directed to its completion, with no remuneration to the BCSA members beyond reimbursement for material expenses procured for out-of-pocket project expenses (e.g. marketing materials, promotional event supplies, etc.). All charitable donations are expressly for use in this public project for Boundary County and are thereby tax-deductible under section 170(c)(1) of the Internal Revenue Code.

BCPR will be responsible for all maintenance and upkeep of the skatepark upon its completion. BCPR will allow the new facility to be built on the land where the current facility is located using the entire 8000-10000 sq ft area.

Fund distribution should the project not be completed.

In the event that this project does not reach completion all funds raised will be donated to BCPR for the purpose of funding any ongoing public project.
