Dear Parents:

St. Michael's has been able to offer families who express and demonstrate a need for a reduced lunch rate for several years. Since opting out of the federal program, because of the many regulations it dictates to us, we have continued to keep our Hot Lunch Assistance fund available. We are not able to financially offer free lunch to our students but we also know that our families may struggle for a Christian education and finances may complicate that desire. The Board of Education will continue to offer a reduced price for lunch to those families who qualify based on the Federal income Eligibility Guidelines for this school year.

A table is listed below showing the income guidelines. If your entire family's income falls below the guidelines printed below for the size of your family's household, I would encourage you to fill out an application, provide a copy of your family's most recent 1040 income tax form, and return the completed application to the school office. If your family was considered for reduced lunch last year, you will need to reapply for this school year. Regular priced lunches will be charged to your family account until an application has been received and verified. Please note, you may apply at any time during the school year.

2022-2023 School Hot Lunch Pricing:

- Hot Lunch including a milk = \$4.00
- Reduced Hot Lunch including a milk = \$2.00
- Milk ONLY or extra milk = \$0.75
- Extra Entrée = \$1.50

For each additional family member after 8 in the household, add \$8,288.00 to the annual income of the household.
