- 4. Unfinished Business- David and Board
  - a. Alameda Wash Project: \$150K
    - i. 95% completed with post/cable with locked gates.
    - ii. Deters illegal dumping and off road vehicles, but motorbikes can still access.
    - iii. Some cables being cut for access, please phone BernCo Sheriff's Office (non-emergency) if witnessing vandalism.
  - b. Road Maintenance
    - i. BernCo states their three machines that repair cracks are down. No repairs.
  - c. Crime
    - i. An increase in reported crime in NAA.
    - ii. Crime prevention handouts from Spring 2022 presentation are available on our website.
    - iii. We will include a mini presentation at our annual community meeting in November.
    - iv. Sheriff Substation in NAA
      - 1. Project is on hold after Under Sheriff Koren (who oversaw project) was recently killed in tragic accident.
  - d. PNM-Substation
    - i. Local Government Affairs and Community Relations Manager, Sherrick Roanhorse asked for an informal meeting (8/22/22) with NAACA President, David Neale with Peggy Valencia accompanying (NAACA stated: this meeting in no way condones/supports a future substation in NAA.) PNM Engineer and Lobbyist, Carlos Lucero was also present. Note: Previous PNM lead personnel involved are no longer at PNM.
    - ii. They claim they do NOT have a plan to re-visit this site for substation- yet.
    - iii. They want feedback from neighbors on what they did wrong (including how terrible neighbors were treated and what untruths neighbors were told).

- iv. They want suggested solutions to the energy need (besides not placing it in NAA and trying to break our sector plan). We are not going to back down on zoning.
- v. Another small meeting has been set (end of September) with eight invited neighbors (whom had a direct connection such as member of PNM's community working group etc.) A report on that meeting to follow.
- e. Pre-school/daycare off PDN Frontage Road Between Presbyterian Church and Church of Christ
  - i. SDRO zoned: Residential, office, institutional
  - ii. BernCo Zoning Hearing (9/14/22) requesting "conditional" use for: day care/preschool
  - iii. Completion slated by fall 2023
- f. Treasurer position posting
  - Post position on Nextdoor and big half page ad in Newsletter, inquire at Annual meeting
  - ii. Bylaws require Treasurer Position formally, but we can hire a bookkeeper if necessary
- g. Newsletter advertising
  - i. Tabled until 2023 due to transition of Treasury position.
