## Board of Aldermen

Meets monthly on the first Monday of each month at 6:00 p.m. Individuals or groups wanting to be placed on the agenda should contact City Hall to obtain the form needed. Interested person(s) should complete the form and submit it by 4:00 p.m. the Wednesday prior to the meeting. Once submitted, consideration is made and the name listed as the contact on the form will be contacted prior to the meeting to confirm or deny the request.

### Dog Registration

All dogs must be registered annually. Renewable Jan 1-March 1 with rabies vaccination records & photo. \$15 per dog.

### Business License

New licenses must have board approval 30 days prior to opening. Existing businesses must renew annually.

### General Build Permit

Must obtain permit PRIOR TO construction. Fee schedule is on the form. City ordinances available online.

### Utility Service Agreement

Turn on services for water, sewer and trash. Deposit is required. Renters must have copy of lease agreement and Owners must have copy of deed to property.

## Water, Sewer, Trash

The City mails water, sewer and trash bills the first part of each month. Payments are due upon receipt and become delinquent on the 20th of each month. If payment is not received by the 20th of the month a 10% late fee is assessed. The maintenance crew hangs red door tags approximately one week later as a reminder to pay. The red door tag also gives the specific date of water shutoff if not paid by 1pm on said date. Accounts remaining unpaid following the shutoff will incur a \$35.00 reconnect fee in addition to the delinquent water bill. Forms of payment include cash, check online at [www.dixonmo.gov](http://www.dixonmo.gov).

The City of Dixon has curbside trash pickup service. The City contracts trash service with an outside vendor. Customers are billed monthly for trash pickup as part of the water/sewer bill. Trash is picked up Wednesday (west of Elm Street) and Thursday (east of Elm Street). Trash should be put out at the curb by the night before pickup and must be bagged and in the provided trash bin. A second trash bin may be added for an additional fee. Inclement weather and holidays may impact the regular trash service days and times. The City of Dixon has a city wide clean up in the spring and fall for larger/bulk type trash. Throughout the year, a request may be made to City Hall to open the gates at 406 North Elm to dump larger trash items (excludes appliances and tires). For yard waste, contact City Hall to unlock the gates at the Sewer Plant, 10325 Cottonwood Road.
