**Discussion on Waste water geotextile bags. DNR said one bag should last 1 year. When the bag is full it can be put into a roll-off and taken away. It dissolves. Motion was made by Mary Wiles to purchase 1 bag at \$3,000.00, seconded by Mike Null; roll call vote: Mike Null, Anthony Campbell, Mary Wiles, Trevor Warnol. Motion carried 4-0**

Motion was made by Mary Wiles to advertise for 30 days in the Dixon Pilot, Dixon Facebook page and social media, seconded by Anthony Campbell; roll call vote: Mike Null, Anthony Campbell, Mary Wiles, Trevor Warnol.
