

OLD BUSINESS:


NEW BUSINESS:

Mayor Brown read off the amount for payroll for each department: Police: \$9,426.31; Court: \$1,039.13; Sewer: \$1,834.25; Street: \$4,914.95; Water: \$4,914.25 which came to \$22,128.89 plus taxes \$4,825.46 which comes to: \$26,954.35. Mayor Brown read off the list of what we have brought in so far this month: General: \$2,271.04; Trash: \$4,282.09; Water/Sewer: \$21,933.05; Water Deposit: \$580.00; Court: \$434.50; Total of: \$29,046.18. Mayor Brown read the list of bills: Insurance: \$6,048.29; Sewer Connection: \$774.02; Quarterly Taxes: \$1,500.40; Phone (OOMA): \$240.37; Corporate Warehouse Supply: \$1,379.55; CAN Security Bonds for Marshal, City Clerk, Court Clerk: \$300.00; Summit: \$4,554.56 + \$1,300.00 = \$5,854.37; City Attorney: \$8,967.50 with a total of \$32,563.72. 
