1. CALL TO ORDER

A discussion with the City Attorney Mark Rector on whether or not Paul Watson can continue to serve as an alderman. Mr. Rector stated that State of Missouri laws and City of Dixon ordinance are in agreement in this matter. The law states that a person serving as an alderman must be a resident of the City and that the has two options for handling the situation.

Option one is for the member of the council to file a petition to suspend the Councilman Watson from his position on the council. A hearing would then held and could result in impeachment proceedings

Option two comes into play if Councilman Watson refuses to comply with the decision of the council. This could then result in court proceedings to remove him from office.

Paul Watson had given a letter to the Council citing a law which he interpreted as a law that would allow him to continue to serve on the Council, due to the fact that he owns property within the limits and pays taxes on his property. Mr. Rector stated that the ownership of property does not constitute residence within the City, and that an individual can only have one domicile. Jeff Clark asked what happens if Paul Watson decided to move back to the property that he owns in the City limits. Mr. Rector stated that a person can only have one domicile and must reside daily in the City limits for the duration of his term of the Council. No decision was made at this time.
