**NEW BUSINESS:**

Motion was made to ratify bills by Diane Shultz, seconded by Trevor Warnol; roll call vote: Anthony Campbell, Mary Wiles, Trevor Warnol, Diane Shultz, Mike Null; motion carried 5-1. Mayor Allan Kuehl noted that the Gascosage bill is now on budget billing and would be \$6551.57 every month now.

Mayor Allan Kuehl mentioned engineers, Burdell here a year ago; selling the sewer system who sent information. Empire Electric from Crocker and Richland wanted to come and talk and also Enviro-line wanted to talk.

Mayor Allan Kuehl commented on running the ad for auditor another 2 weeks. Mayor Allan Kuehl suggested getting the City Council to get a committee together and contacting some of the auditors.

Mayor Allan Kuehl commented that there are 4 applicants for City Clerk, to start interviews this week in the evening if the applicants agree. May have to have some interviews during the day with 2 or 3 Council members present. Diane Shultz suggested letting the ad run another 3 weeks, 6 weeks total.

Mayor Allan Kuehl commented on the city computers are all up and running, everyone is able to print; two 24' monitors that were donated are in the Assistants office. Court Clerks monitor is the same but her tower wasn't any good. Went ahead and got a new tower. Software is \$150.00 per tower.
