CALL TO ORDER

5. ADOPT THE AGENDA

The City Clerk sent out 40 + /- letters to area businesses reminding them to renew business licenses. We received about 10 renewals. This was the second set of letters sent out for renewals. The Mayor advised the City will call the businesses needing renewals then fees will be assessed for those not in compliance.

12. RECREATIONAL TRAILS PROGRAM GRANT UPDATE

The grant application has been submitted. The cost estimate from Archer Elgin was modified to fit the parameters of the grant.

13. LIBRARY UPDATE

A Scholastic Book Fair will be hosted by the library in mid-July to help raise funds to continue to improve the library and add materials. Ms. Lacey submitted two grants to assist with expanding large print and non-fiction areas and remote library service. The new assistant librarian is doing very well and patrons love her.

14. POLICE UPDATE

Officer Durbin gave an update on the Dixon Police Department. In the month of February: 276 total calls for service; 2 Unresponsive both resulting in fatalities, presumed to be natural causes; 1 Overdose (Agency Assist for Pulaski County Sherriff's Department); 1 Suicide Attempt (Agency Assist for Pulaski County Sherriff's Department); 2 juvenile referrals to juvenile office; 12 Subject Stops; 18 Suspicious Activity; 11 Nuisance Papers Served; 8 Alarm calls; 3 Warrant Arrests; 6 Requests for Charges; 1 Alleged Child Abuse; 2 Stolen Vehicles (both vehicles have been recovered); 1 Pursuit (resulted in charges for fleeing); 9 Wellbeing Checks. Council encouraged the PD to "Keep the Pressure On!"

The new radios are in and are working well. The tan car received new tires. The ballistic vests should be here tomorrow.

15. MAINTENANCE UPDATE

Culverts should arrive tomorrow for Country Club and Ellen. Cold Patch to repair the streets depends on the weather; hopefully mid March repairs will begin. Alderman Stacey Yoakum suggested "Report Your Pothole" be put on Facebook and the Website so community members can send repairs to one location. Kelli Livengood will put it on Facebook and on the Website.

16. OTHER

Mr. Stacy Ball stated the DCA is doing good work and would benefit from support of the City. The DCA is hosting a Car Show on March 18.
