## DIXON CITY COUNCIL MEETING City Hall 203 South Walnut Street August 5, 2019

### 1. Call to order

### 2. Roll call

Anthony Campbell, Barbara Thomas, Mary Wiles, Diane Shultz, Mike Null, Trevor Warnol, you have a quorum.

### 5. Adopt Agenda

Motion was made by Mike Null to adopt the agenda; seconded by Barbara Thomas; roll call vote: Diane Shultz, Barbara Thomas, Anthony Campbell, Mary Wiles; motion carried 5-0  
Diane Shultz made a statement to clarify that Mike Null can act as Mayor Pro Temp and as Alderman to make motions and vote.

### 6. Approve Minutes

Diane Shultz made a motion to accept the minutes for July 22, 2019; for July 8, 2019 per request of Mary Wiles that item number 6 be amended for the names of the votes be added plus the vote tally; Anthony Campbell seconded the motion; roll call vote: Mary Wiles, Mike Null, Anthony Campbell, Diane Shultz yes for July 22 and abstained for July 8 for being absent; motion carried 3-3; Barbara Thomas and Trevor Warnol abstained, wasn't present.

### 7. OLD BUSINESS:

Discussion on Ordinance 563 which is an update for the Nuisance ordinance; we have a direct path as to what we need to do.

Discussion on the Elm street project. Diane gave recognition to Mike Null, Josh Lachowitz for their volunteer work on the project. Only one (1) employee was paid for the work.

Discussion on Municipal Judge. When Judge John Ward passed away, he had asked Less Hansmann to step in for him. The city didn't have \$5,000.00 to \$10,000.00 for an election.

Mayor Allan Kuehl talked to Judge Hickle and City Attorney Jeff Thomas. Judge Hickle approved Less Hansmann per a letter that Less Hansmann is the Judge but will be up for election in April. Jeff Thomas stated the State Statute that the Council cannot appoint a Judge but the Mayor can make a recommendation.

**8. NEW BUSINESS:**

Motion was made by Mike Null to look over the expenditures, seconded by Anthony Campbell; roll call vote: Anthony Campbell, Mary Wiles, Trevor Warnol, Diane Shultz, Mike Null, Barbara Thomas; motion carried 6-0. Mike Null made the comment that we had \$180,000.00 of back debt and now we are around \$120,000.00. Says that in about 6 months we should be able to save a little money.
