Diane Shultz made a motion to adopt the agenda, seconded by Mike Null; roll call vote: Anthony Campbell, Mike Null, Trevor Warnol, Diane Shultz; motion carried 4-0

7. NEW BUSINESS:

Mayor Kuehl informs the Council of Ordinance 573: Internet Tax. This ordinance will allow the City to obtain a percentage of tax already collected by the State for online purchases. Diane Shultz motioned for the first reading of the Ordinance, seconded by Anthony Campbell; roll call vote: Anthony Campbell, Mike Null, Trevor Warnol, Diane Shultz; first reading approved 4-0

Second reading of Ordinance 573 motion made by Anthony Campbell, seconded by Mike Null; roll call vote: Anthony Campbell, Mike Null, Trevor Warnol, Diane Shultz; 2nd reading carried 4-0

Trevor Warnol motioned to have the Internet Use Tax Ordinance to be put on the April ballot for voter approval, seconded by Mike Null; roll call vote: Anthony Campbell, Mike Null, Trevor Warnol, Diane Shultz; motion carried 4-0

Mike Null made a motion to increase the City Marshal's Pay to \$38,000 per year, seconded by Anthony Campbell; roll call vote: Anthony Campbell, Mike Null, Trevor Warnol, Diane Shultz; motion carried 4-0

Motion was made by Mike Null to read Ordinance 574 regarding the City Marshal's Pay, seconded by Diane Shultz; roll call vote: Anthony Campbell, Mike Null, Trevor Warnol, Diane Shultz; motion to read Ordinance 574 carried 4-0

Motion for a second reading of Ordinance 574 made by Diane Shultz, seconded by Anthony Campbell; roll call vote: Anthony Campbell, Mike Null, Trevor Warnol, Diane Shultz; carried 4-0

Mike Null made a motion to pass Ordinance 574 to increase the City Marshal's Pay to \$38,000 per year, seconded by Anthony Campbell; roll call vote: Anthony Campbell, Mike Null, Trevor Warnol, Diane Shultz; Ordinance passed 4-0

Motion for the first reading of Ordinance 575: Half Cent Tax for Law Enforcement Purposes made by Diane Shultz, seconded by Trevor Warnol; roll call vote: Anthony Campbell, Mike Null, Trevor Warnol, Diane Shultz; carried 4-0

Second reading of Ordinance 575 motion made by Diane Shultz, seconded by Mike Null; roll call vote: Anthony Campbell, Mike Null, Trevor Warnol, Diane Shultz; carried 4-0

Diane Shultz made a motion to add Ordinance 575: Half Cent Tax for Law Enforcement Purposes to the next General Election on April 7, 2020 ballot, seconded by Trevor Warnol; roll call vote: Anthony Campbell, Mike Null, Trevor Warnol, Diane Shultz; carried 4-0

Motion was made to table Chapter 700: Water & Sewerage System until December by Diane Shultz, seconded by Anthony Campbell; roll call vote: Anthony Campbell, Mike Null, Trevor Warnol, Diane Shultz; carried 4-0

The Mayor had addressed the Council for approval to amend the budget. The amount of \$92,916 was added to the Trash budget under line item 01-30-6130 and \$300 was moved from Old Debt for Street into Old Debt for Water. Legal Expenses was also divided between Administration (70%) and Court (30%). Motion to adopt the changes was made by Mike Null, seconded by Diane Shultz; roll call vote: Anthony Campbell, Mike Null, Trevor Warnol, Diane Shultz; motion carried 4-0

At 7:33 P.M., the Council adjourned for a short break, they resumed and a motion was passed at 7:44 P.M. to go into Closed Session to discuss legal matters.

Session was reopened and adjourned unanimously at 8:12 P.M.
