1. **CALL TO ORDER**

5. **ADOPT THE AGENDA**

Patrick Ryan with Dump It Disposal, LLC and Max Murray with GFL formerly known as WCA. Both clients spoke on behalf of each of their companies and answered any questions the council had concern about. The council discussed a possible workshop in the future to talk about both bids and which one is more beneficial to the citizens and the city.

9. ARPA UPDATE

ARPA Update was given by Stacey Yoakum. Slideshow & Contract were provided to the council for review. **See Attached Documentation** State of MO expects to tentatively receive funding for this grant at the end of July and can start distributing soon after. Grant is given in 2 portions, 50% for the first and 50% for the second. Each project that the city does will require administration monitoring and those fees are covered by the grant money. Stacey checked to see if the sewer project we are currently working on is covered under this grant and confirmed that it is indeed covered.

10. PLANNED MAINTENANCE- FRONT DOORS

Flyer provided for planned maintenance on front doors by Doormakabob, the company that installed the doors, Trevor Warnol distributed it to the council members for review. Barbara Thomas commented and said she would like to reach out to other vendors or maintenance companies for pricing of planned maintenance as well.

Motion Carried 5-0


14. OPEN SESSION @7:46PM


