



Ozark Testing is holding on to all tests at the moment. Need to get supplies or have DNR come in. We would pay out \$1,000.00 for backhoe tires, \$1,358.75 to Enviro-line, total of \$3,907.23. Barbara Thomas made a motion to pay for the following item: Hach bod pillows/\$37.95, GGA/\$87.18, Sludge judge/\$141.95, Tss filters/\$38.00, Backhoe tires x 2/\$1,000.00, 3 inch clamps x5/\$344.75, 2 inch clamps x 5/\$279.75, 2 inch half clamps x 5/\$139.75, 3 inch half clamps x5/ \$179.75, solar lights x6/\$300.00. Plus the past due amount of \$1,358.75 payable to Enviroline. Grand total of \$3,907.23. Betty Thilges seconded the motion; motion carried 5-1 with a roll call vote Betty Thilges, Dawna Fleming, Marlene Blackburn, and Barbara Thomas; dissented voting Paul Watson NO. Paul Watson questioned the payroll, overtime killing us. Barbara Thomas commented that the sanitation employees need the supplies and it would save us money in the long run. Audience asked what kind of fine if not paid. Mayor Brown said no more comments, moving on.



Jeff Thomas suggested calling Summit and see what it costs or if it is already in the system.


Facebook rules
