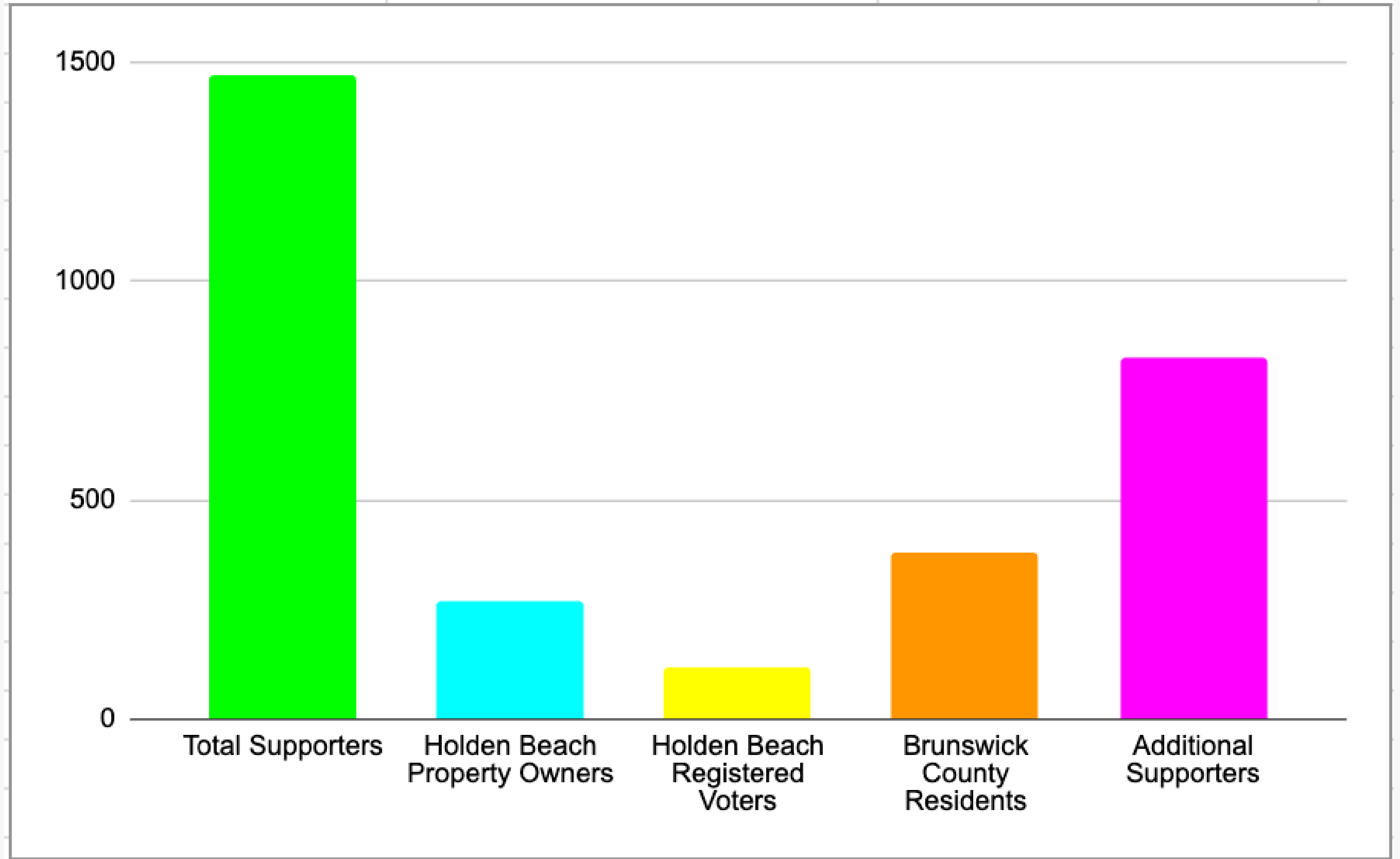

WHAT ARE THE VIABLE OPTIONS?

- Request bids for more accurate cost estimates to safely repair, restore, or rebuild the pier and the pier house.
- Request proposals for a public-private partnership agreement and objectively review the benefits of this type of operations plan.
- Have a bond referendum on the November election ballot to receive approval for a special tax assessment of homeowners, like the sewer assessment, which is about to expire.
- Keep the \$1.1M currently in the budget for pier restoration instead of moving to another budget item for next year.
- Make a public commitment to accept contributions from our organization and other private or public entities to offset the cost of repairs and get the pier and pier house reopened within the next 2 years.
