- A single swing set remains.
- This once very used play area is not being utilized
 - 2,094 Sq Ft of empty space






Toddler Park Subcommittee






Two Swing Sets

(Saddle & Toddler)






Explorer Dome



Layout Footprint of New Play Equipment

- Existing upper play area
 - 2,094 Sq Ft
- Expansion
 - Adding to the upper play area (2,112 Sq Ft)
 - Additional 24' x 26' area near the lower play area for toddler swings near the existing 2-5year-old play area at the front of the park (24' x 26')
- New Layout
 - 4,206 Sq Ft



Financials

Financial Impact to the Association

- Highwire Play Equipment (\$128,096.95)
- Engineered Wood Fiber (EWF) Playchips (\$12,958)
- Construction (\$65,000)
 - Removal and disposal of existing swing set and tire swing
 - Installation of new equipment
 - Modification of border near the Explorer Dome
 - New bordered 24' x 26' area for toddler swings near the existing 2–5-year-old play area (624 Sq ft)
- Volunteer involvement can reduce these costs
- Total Cost \$206,055

Preparation for Potential Inflationary Impact

As we all know, over the last few years we have seen costs increase.

- Equipment quotes may be subject to a slight increase between now and March of 2024, when funds will be available to put a 50% down payment on the equipment.
 - Some of the EFW should be reusable
- In preparation, an additional 10% will be added to the budget ensure completion with uncertain future economic conditions.
 - \$227,205
- <u>Impact/Homeowner</u> \$151.47

Communication

Funding

- This project will be funded with a special assessment added as a separate line item to the 2023-2024 budget
 - Payment can be made in full with January dues
 - Two payments of ½ the amount can be made with dues in January and July
 - Failure to pay special assessment and regular assessment payment on time will be subject to current FGHA payment policies
- A 50% down payment is required to secure the equipment
- Volunteer involvement could reduce the overall cost in removal and disposal of existing equipment
- Any remaining funds will be placed in an account for future replacement of the 2–5-year-old play equipment
