To purchase a club membership you must **first obtain the memberships of the representatives** or contacts that will be listed on the club application. Club membership is not renewable. You may purchase for 1, 2 or 3 years.

For Level 3 clubs, please use the same EIN number used last year.

**The AAU Membership year runs from September 1 to August 31.**  
AAU Membership is required to participate in all AAU licensed events.

### To start a club:

1. Purchase AAU non-athlete membership of the club contacts.  
After application and background screen has been approved, member will receive an email with an AAU membership ID.
2. Purchase AAU club membership (must have AAU membership ID to complete this club application).  
At the end of this process, you will receive your AAU club code.
3. Instruct parents to purchase an individual athlete membership for their child.  
Give parents your AAU club code – the parents will then enter this code during the athlete application process.
4. Print the club's Verification of Insurance to secure a practice facility or request a Certificate of Insurance.

**Eligible to participate in events**

**Eligible to vote at appropriate district biennial meetings**

**Eligible to apply for practice insurance certificate**

**Level 1** is for incorporated or unincorporated clubs who wish to participate in AAU events, vote at the appropriate district meetings and receive a practice license. This level club will not be able to host an AAU licensed event. Level 1 Clubs may not use trademarks of the AAU except to say the club is a member of the AAU.

#### CLUB MEMBERSHIP LEVEL 2

**\$60 / year**

Adult Club or Both Youth and Adult Club Per Membership Year

**Eligible to participate in events**

**Eligible to vote at appropriate district biennial meetings**

**Eligible to apply for practice insurance certificates**

**Eligible to apply for a license to host an event**

**Eligible to use the AAU logo & Name in AAU licensed events**

**Level 2** is for incorporated or unincorporated clubs and has the same benefits a Level 1. In addition the Level 2 Club may host an AAU licensed event, other than practice, and may use the AAU name and trademarks for licensed events only.

**Level 3** clubs have the choice of being unincorporated nonprofit entities OR nonprofit corporations. Level 3 clubs enjoy same benefits as Level 1 and Level 2, in addition, Level 3 clubs can become a subordinate under the AAU's group exemption program, making the entity a tax-exempt organization. Level 3 Clubs are eligible to accept tax-exempt donations directly. Level 3 Clubs must register online.
