After a discussion with the public on road signage and repairing Winterton road it was explained that the paving of Winterton road and the signage would be addressed in early spring.

Mayor's report:

- Mayor Wood provided a report regarding the Village sewer plant.
 - Sewer violations are provided to the village on December 13th. Problems were discussed between Mayor Wood and the DEC.
 - One piece of the filter system is offline. Scheduled to be repaired on March 21, 2024, causing the daily alerts.
 - Other miscommunication between the village and the operators (H2O) has been resolved.
 - The Sewer plant is being checked more frequently by Village officials for better communication with the plant.
 - Two out of Three SBR or repaired and up and running
 - The bar screen has been repaired. Rack type of system to clean out sludge and rags.
 - Online since February 9th, 2024
 - Factory rep coming to inspect the sewer plant March 12,2024
 - On March 21, 2024, a company will be repairing the last of our filter system.

- Question on the size of Sewer Plant handling the amount of citizens
 - o The Sewer plant is designed for 325,000 gallons a day. Approved by the DEC.
- January DMR (Discharge monitoring report) average flow was 44,200 gallons per day.
 - Problems at sewer plant are not from usage, it was a Maintenace and communication issue that has been resolved.
- Queston on educating the residents on the disposable towel problem.
 - Warnings are posted on the Bloomingburg Platform and signage posted at the village hall.
- Quality of water flowing into the Shawangunk Kill
 - The Village meets the requirements of the Speedys Permit monthly. This is the parameter the DEC puts out that we must meet.
 - Series of test run daily
 - Monitor Computers
 - Monitor the flow
 - Clean bar screen
 - General house keeping
 - · Ect.
