WHEREAS, the Annual Budget for the Pittsgrove Township Fire District No. 3 (the "Fire District") for the fiscal year beginning January 1, 2020 and ending December 31, 2020 has been presented before the Board of Commissioners of the Fire District at its open public meeting of December 2, 2019; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$297,644.00, which includes an amount to be raised by taxation of \$296,682.00, and Total Appropriations of \$297,644.00; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 2, 2019 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2020 and ending December 31, 2020 is hereby approved; and



The increase in the tax levy will be included in the maintenance and repair of buildings line item to help cover the costs of an aging building. The 2020 budget also include the reallocation of funds from future capital outlay to the maintenance & repair – buildings line to also help cover costs.

The amount to be raised by taxation in the proposed 2020 of \$296,682.00 is an increase of \$6,338.00 over the 2019 budget amount of \$290,344.00. The 2020 tax rate is expected to increase by \$0.004 from \$0.159 in 2019 to \$0.163 in 2020. The proposed 2020 budget does not utilize any unrestricted or restricted fund balance.
