   Motion made by Mario to approve the new website as recommended for \$550.00 annually with a one-time fee of \$100.00 for set up was seconded by Chris; motion passes.

Motion made by Mario to allow electronic voting and follow the Planned Communities Act was seconded by Chris; motion passes.

   Management was directed to have the CCAA review options and will discuss with the Men's Coffee Group whether they would have issue with dismantling the Bocce Ball court should the CCAA want to look at that area as an option.
