NEWS FROM HUDSON BEND

TAXES - HBCNA will attempt to coordinate tax valuations coming from County Tax Assessor. Rates are going up; we must work together to get valuations down to a fair amount and your cooperation with the Board will save money for us all.

LAWSUITS - "Lakeside Launches" in Pool Canyon filed in bankruptcy while the lawsuit enjoining their operation is on appeal to the higher court. Mariners Point at Lake Travis Lodges is embroiled in lawsuit with InterFirst Bank on the development of the condos. Further expansion of the property or the marina seems on hold.

CITY OF HUDSON BEND? Have you signed the petition yet?

Members present at the HBCNA annual meeting and picnic in June 1986 approved a motion to get the second step completed toward incorporating the Hudson Bend area. This step is to gather names on a petition asking for annexation of the land in the proposed area of The Village of Hudson Bend into the City of Austin for all purposes. As a practical matter, the City of Austin cannot annex this area because they cannot provide city services within a reasonable period of time, as required by the legislature. Six months after the petitions have been served on the City Council and they have rejected the request, we may proceed to the third step if the members of HBCNA so desire. The third step is to hold an election "for" or "against" incorporation.

If you have not been contacted for your signature on this petition, please called Martin Holeman at 266-2092. At the present time, less than 50 signatures have been obtained. Because so many of you do not live in Hudson Bend permanently, it has been difficult to contact you. Petitions will be available for you to sign at the annual picnic this year, so y'all come.

P.S.: the first small city, "Bee Cave", recently moved ahead - election date now set for August 1987.

DEANNEXATION: Bowing to strong legislative pressure, the City of Austin deannexed the bed of Lake Trayis. Such action will not directly affect HBNCA, except to indicate a retrenchment of the policy of the City of Austin.

ROADS - When, when is Hudson Bend going to be paved and finished? Highway 620 is going forward - but when is the intersection of $\underline{620}$ and Hudson Bend going to be done?

MAJOR FIRE ALERT - Recent near tragedies prompt us to pass along good advice from the Hudson Bend Fire Department:

- (1) Burn only tree limbs, shrub and grass clippings. It is not allowed to burn construction material.
- (2) If you plan to burn, please call the Dispatcher at 261-6161 first.
- (3) Fire must be out by dark.
- (4) Don't burn trash if it is windy.
- (5) It is best to burn trash when the ground is damp and there is high humidity.
