NCNB Texas, HBCNA and LTLMA COLLABORATE TO IMPROVE OURAREA**********

Signs have been installed by your neighborhood association on the point of land adjacent to the marina at the end of Hudson Bend Road in an effort to reduce some of the traffic and abuse of the land that is currently held by the bank. NCNB has granted the Hudson Bend Colony Neighborhood Association members "use of the boat launch, the road, and the land" in exchange for our installing the signs that appear around the beach and parking areas. The Lake Travis Lodges Marina Association has chained and locked the boat ramp to reserve its use for only authorized persons. All HBCNA members who are current with their dues for 1989-90 will be issued the combination to the lock on the cable. The combination number will be changed each year.

The "Marina point" project was voted at the 1988 annual meeting which was held at the Cook's home last June. Arthur Boon and Carole Sikes worked with Allen Clark at NCNB Texas. Clark determined the location and wording on the signs. Arthur Boon raised all but \$ 40. to cover the cost of the project by contacting neighbors for donations. If you would like to contribute to this project, please mail your checks to him or to treasurer, Erma Campbell.

Randy Beck organized the work committee to install the signs. Beck, Holeman and Taylor experienced blatant interference over the placement of a sign near the vacant building at the entrance to the "point". The sign was removed and posts knocked down. The incident was reported to the Sheriff. Jack Lairsen, who owns the commercial spaces on the marina, had expressed objections to that particular sign in a letter to the bank last November. The position of the board and these men is that they were locating the signs as specified in the proposal adopted by the bank. They have exhibited extreme tolerance for an irresponsible act.

Our goals of stopping some of the transient traffic and public use of this land is a shared one. Boat slip owners have experienced break-ins of their cars and boats as well as inconvenience and parking problems on the point leading to the marina. Our member Bob Campbell serves the LTIMA as a board member and is the liason between our two groups for this project. The marina directors and the manager, Jim Chapman, are responsible for installing the cable across the boat ramp. Boat launching from the LCRA park near the dam will require a fee this year, so there will be much pressure from the public to use the launch in our area.

THANKS TO ALL OF YOU WHO HAVE MADE DONATIONS OF TIME AND MONEY and especially to NCNB Texas bank. Only with continued cooperation can we hope to improve a problem which has gone unattended too long.

IMPORTANT PROJECT TO UPDATE PROPERTY RESTRICTIONS*****************

A document will be delivered to you for your signature by June. Please give it your immediate attention.



Dear Property Owner:

Recently the legislature has passed laws which encourage and enable organized property owner's associations such as ours to help in the interpretation of restrictions which apply to the property located in the subdivision concerned. Our subdivision was one of the earliest platted on Lake Travis. While the restrictions utilized by the organizers and developers were very clear and to the point at that time, it may seem to some to be outdated and inconsistent. We hope to use this law to enable us all to take some of the confusion out of the restrictions and to create greater value in our collective properties by doing so.

Documents will be sent to you soon giving you and every property owner the opportunity to participate in the clarification of the property restrictions in Hudson Bend Colony. Our neighborhood, while it is already attractive and desirable, can be more so for years to come.

In some of the Hudson Bend Colony areas where trailers and mobile homes were restricted, there was confusion as to the definition of a mobile home. We hope that the new interpretation by the association will remove some of that confusion. We have also recognized that the mobile homes that are currently existing in the subdivision should be "grandfathered" and permitted to remain so long as they are not moved to other areas in the subdivision or substantially modified. The new restrictions will restrict trailers and mobile homes but not modular homes throughout the subdivision. We have all done extensive research on this project so that we are certain that we are proceeding according to the law as it now exists in Texas. We have taken what we hope to be a giant step forward in increasing the value of our lots in the subdivision. ...Conrad Werkenthin
