

# SCAM ALERT!

Recently some Galena residents have been victim to a scam claiming to be Delmarva Power and falsely claiming their electric or gas service will be disconnected unless payment is made. These impersonators instruct customers to buy a prepaid credit card and call back to a different phone number with the personal identification number (PIN) or other personal information. They also use a tactic called "spoofing" to manipulate the Caller ID displayed phone number so that it appears as a Delmarva Power number. Delmarva Power also cautions customers to be mindful of individuals who try to gain access to their homes by posing as utility workers. Utility impostors may carry "official" looking credentials and often work in pairs.

## TOWN PROJECTS



A submission was made to the Stories of the Chesapeake Small Grant in the amount of \$2500. The purpose of the application was to catalog items in our collection for the museum. We hope we are awarded this grant to assist us in making our history more accessible to residents and visitors.



The Town of Galena Park & Tree committee has submitted a grant application to continue work on town beautification and the composting project at Galena Elementary School. The request included supplies for Galena Clean-up days, 25 trees, as well as, additional compost bins, metal planters, and two public ecology presentations. Awards will be announced in March 2024.

#### **DHCD Facade**

The Town of Galena has been awarded a \$50,000 grant to continue DHCD Facade improvements for FY25. Letters of Intent to Apply are DUE ON OR BEFORE January 31, 2024, AT 3:00 PM. They may be mailed, dropped off or sent to

aerschen@townofgalena.com. A link to the form can be found on the Town of Galena website homepage. This is the first step in the process, so we can get an idea of how many will apply to help determine the award ratio as we would like to assist as many residents as we can.

The Façade Improvement Program supports exterior facade projects to recover and promote the integrity of the buildings and improve the visual characteristics of the community. The program is administered through the Town of Galena under the guidance of the State of Maryland's **Department of Housing and Community** Development (DHCD). The Town of Galena Façade Improvement Program has been funded by Maryland's DHCD Community Legacy Program for six (6) years. Over that period of time, 32 projects have been funded for a total grant amount of \$265,000. The application Review Committee will be selected by the Town of Galena.

# **SEPA Lead & Copper Rule**

The Maintenance Department of Galena would like to advise all Town Residents that we will be doing a mandatory inventory of our water mains as well as the service line to the meter pits. The Town ordinance states that the Town is responsible for the water mains and the service lines up to the Water Meter. The Resident is responsible for the line coming from the meter to the building/residents.


Under the Lead and Copper Rule Revisions (LCRR) of the National Primary Drinking Water Regulations, effective on December 16, 2021, all Community and Non-Transient Non-Community water systems must develop a lead service line (LSL) inventory to identify the materials of service lines connected to the water distribution system.

The inventory required under the LCRR must meet the requirements set forth in the Code of Federal Regulations (40 CFR 141.84(a)). All CWS and NTNCWS must develop an initial inventory by October 16, 2024, and submit it electronically to MDE no later than October 16, 2024.

In the coming months the Maintenance Department may need to contact the owner of the residence to gather information for the report. The type of information we will be looking for could be: When was this structure built (What Year). We may need a picture of the waterline that comes from the meter into the house. There will be more information forthcoming.

## 1871 GALENA (KENT COUNTY) ITEMS.

Galena. - In soliciting news items from the several localities in your county you show a determination to make *The Whig*, a live paper, [to keep it a live paper.] — Galena, as you are aware, is distant from the Sassafras river, which separates the two counties of Kent & Cecil, about one mile, is a flourishing village, with a population of some four hundred; supports seven stores, two drug stoics, one hotel, two restaurants, a stove store, a bakery, a machine shop, and a carriage manufactory.

Schools—We have also a first class public school building, which is occupied by Professor Yates as principal and Miss Anna Scott assistant. The Galena Seminary is under the principalship of Miss Kenney, a lady "worthy and well qualified" to instruct, and whose disciplinary qualifications are, we think, above some who make larger pretensions, in short no parent, in our neighborhood need send their daughters from home to be educated, while they can be so well instructed, in the higher branches, and adornments at home, where their morals are so closely watched, and all on such moderate terms.

Religious. —The M. E. Church is under the pastorate of Rev. E. B. Newman, as pastor in charge, and J. E. Kidney assistant. Mr. Newman is considered, by good Judges, equal, in power and eloquence, to many of the clergy who sit in the upper seats. Rev. Mr. Miskimon, pastor of the M. P. Church, is also very popular, as is evidenced by his 3<sup>rd</sup> year in charge at this place. Improvements. —Seven new houses were built in our village during the year, and the prospect is that the present year will excel last.

Building Association. —The Galena Mutual Building Association has been in operation nearly eighteen months. The average amount paid in on each share, by the members who first joined, at close of the eighteen months, will be about thirty-seven dollars, while the actual amount due him will be about sixty dollars; twenty-two dollars profits, on thirty-seven invested, we call pretty good.
