The board also discussed the glare shield for 63S for which we have the part, but have decided not to put it in at this time. There is a "hard roll tendency" squawk reported on 88L, but we are still investigating it. We have alerted the next members flying the plane and will continue to monitor it. Alan noted 63S might be a candidate for the Cleveland brakes as he likes what it did to 9MA.

John noted the ELT battery records are out of date and have already been done.

We don't know where we are on the magnetos for 88L, John will follow up with Florin.

Scott asked about a strong fuel vapor smell in 117 the last time he flew it. He thinks we are getting a vapor smell when the tanks are full.

Richard was absent, but John noted he has been digging into the wing repair. John distributed Richard's notes regarding various shops that might do the work.
