# Valley Fliers January Board Meeting

Meeting Called to Order at: 6:30

## **Approval of December Minutes**

Alan moved to approve as corrected. Scott seconded. Motion approved unanimously

## Treasurer's Report

See Alan's handouts. December was down significantly. The fuel surcharge remained the same because fuel prices remained the same. There were a huge number of minimum flying hours for the month. One membership turned over. Alan reminded us that the monthly numbers are always preliminary, the final numbers for the year are provided at the annual meeting. The rents shown are at last year's rate and will go up in the January report. Maintenance was relatively low, but our maintenance costs will jump when 63S gets out of annual. December was a positive financial month. Accounts Payable is negative due to pre-paid fuel and rent. The net cash increase during December was \$3421. The financials do not reflect the aircraft registration costs incurred in December of \$260.

## Maintenance Officer's Report

**727** went in for annual today. It will get the strobes fixed while it is annual. The door won't be fixed until after annual due to parts not having arrived.

**9MA** the rib collapsed because people pushed down on the elevator to try to pivot the plane. Please don't do that. We got new brakes and repaired the brake lines as well. The cracked seat panel was fixed. The muffler was replaced. Jonathan's handout includes a full list.

117 will get an oil change tomorrow. Alan noted he doesn't know how to reset the fuel status on the new fuel totalizer and that it is very bright. He also noted the fuel flow rate doesn't look right. He also believes the outside air temperature is indicating lower than the actual temperature. Jonathan is a little concerned about the report of gunk around the right wheel bearing and will investigate that. Jonathan will likely wait until 63S gets back online to deal with most of those issues.

**63S** should be back online by Monday. The LED lights will be installed and the dash leather will also be installed when it gets back on line. The engine cowling was adjusted to allow the engine to better come to a temperature that will burn the moisture out of the oil. The long list of squawks has largely been taken care of. The stabilator play was repaired. Two ADs with limited documentation of performance were performed and well documented.

117 will come down for annual when the engine arrives. We think the engine will arrive around April, but we may delay installing it until after the flying season. Sean pointed out that Jonathan has moved our annuals to a schedule out of the flying season.

Sean suggested we may need to get some stickers telling users not to push down on the tail to pivot the planes. He suggested we may want to send an email to the members letting them know not to do it too.

Jonathan asked members to send him a reminder when ADs are near to due so he can get those things scheduled without it requiring next day or very quick response from out mechanics.

Comment from the floor: 727 has hit something and has bent metal on the tail. It doesn't look like it could have happened in our hangar. Jonathan says it might come up during the annual.

#### **New Business**

**Annual Meeting** Sean noted that Kelsey did some work to investigate moving the annual meeting to the Museum of Flight. Sean's perspective is it may be too complicated.
