- I agree that all program material I produce using Brockton Community Access equipment and facilities is intended for cablecast and/or webcast by Brockton Community Access.
- I agree that I will not use the Brockton Community Access channel, equipment, facilities, or program material produced with Brockton Community Access equipment and/or facilities, for any financial gain or commercial purposes.
- I agree that I am responsible for obtaining all necessary approvals, clearances, licenses and releases for use of all program materials, including, but not limited to, approvals by broadcast stations, networks, sponsors, music licensing organizations, copyright owners, performer's representatives, and persons appearing in all program material.
- I agree that any program material I produce and/or sponsor for cablecast and/or webcast by Brockton Community Access **will not** include content prohibited by Brockton Community Access Member Policies and Procedures, including, but not limited to,
 - Any commercial advertising or programming
 - Unlawful use of any material that is copyrighted or trademarked
 - Any material which is intended to defraud the viewer
 - Programming that does not have the necessary licenses from copyright holders, or other releases
 - Programming that does not fall under constitutionally protected speech, including, but not limited to, libel, slander, obscenity or invasion of privacy
 - Any information concerning any lottery, gift enterprise or similar operation
 - Solicitation of funds, except as permitted and authorized by Brockton Community Access
- I agree that any program material I produce and/or sponsor for cablecast and/or webcast by Brockton Community Access **will** include all disclaimers, warnings, titles and credits required by Brockton Community Access Member Policies and Procedures.
- I agree that I will notify Brockton Community Access when any program material I produce and/or sponsor for cablecast and/or webcast by Brockton Community Access contains generally offensive material as defined in the Brockton Community Access Member Policies and Procedures.
- I agree that I will not represent myself or any other person involved in program production as an employee, representative, or agent of Brockton Community Access, or represent my program as an Brockton Community Access production, unless specifically authorized by Brockton Community Access staff to do so.
- I understand that I may be liable for the costs of any repair or replacement of equipment resulting from loss, theft, misuse, or damage beyond normal wear and tear, while such equipment is in my possession or control. I indemnify Brockton Community Access against any damage or liability incurred while I am using Brockton Community Access equipment or facilities
- I understand and agree to the penalties that apply if equipment is not returned on time.
- I have been instructed on how to safely and correctly handle any Brockton Community Access equipment I borrow, including the storage and lifting of equipment in and out of my vehicle and/or dwelling.
- I understand that Brockton Community Access is an independent, non-profit tax-exempt private corporation, and I will not engage in actions inconsistent with Brockton Community Access's tax exempt status and I understand that this is a contract with a private non-profit corporation.
- I agree to indemnify and hold harmless Brockton Community Access (and its officers, directors, employees and agents) from any claims, causes of action, liability, and/or damages, including legal fees and expenses, arising out of any use of the program material I produce or sponsor, or any breach of this Access User Agreement; including, but not limited to, any claims in the nature of libel, slander, invasion of privacy or publicity rights, non-compliance with applicable laws and unauthorized use of copyrighted material, or any claims incurred as a result of my own negligent act, or omission, or intentional act.
