Privacy Policy

We hope that you enjoy using our website, safe in the knowledge that we are committed to protecting your privacy and security online.

The Alpine Garden Society Victorian Group is committed to protecting your privacy and understand that our members and those that we provide support and services to are concerned about the privacy, confidentiality and security of their personal information.

This policy outlines our ongoing obligations to you in respect of how we manage your Personal Information.

We have adopted the Australian Privacy Principles (APPs) contained in the Privacy Act 1988 (Cth) (the Privacy Act). The NPPs govern the way in which we collect, use, disclose, store, secure and dispose of your Personal Information.

What is Personal Information and why do we collect it?

Personal Information is information or an opinion that identifies an individual. Examples of Personal Information we collect includes names, addresses, email addresses and phone numbers if you provide them to us.

This Personal Information is obtained in many ways including by correspondence, telephone, email, our website www.agsvicgroup.org, from cookies and from third parties. We don't guarantee website links or policy of authorised third parties.

Your details are used to contact you about your membership; or about grants and scholarships that you have applied for or received; or about other services or matters that you have expressed an interest in; or events or lectures or workshops that you have booked or bought a ticket for; or any other inquiry that you may have made through the contact form on the website or through any other method.

We will not share your email, telephone number or address with other organisations for marketing purposes without your prior consent.

Our website uses cookies to enhance your visiting experience. The cookies we use do not store personally identifiable information nor can they harm your computer. We want our website to be informative, personal, and as user friendly as possible and cookies help us to achieve that goal. Your online payments are handled by Square and PayPal. Both these companies have their own privacy policies. The Square privacy policies can be found <u>here</u> and, if you provide information to Square in order to receive a digital receipt and email marketing messages, <u>here</u>. PayPal's privacy policy can be found <u>here</u>. In person payments are handled in a variety of ways including direct bank transfer, cash and Square.

We collect your Personal Information for the primary purpose of providing our services to you and marketing. We may also use your Personal Information for secondary purposes closely related to the primary purpose, in circumstances where you would reasonably expect such use or disclosure. You may unsubscribe from our mailing lists at any time by contacting us in writing, including email.

When we collect Personal Information, we will, where appropriate and where possible, explain to you why we are collecting the information and how we plan to use it.

Sensitive Information

Sensitive information is defined in the Privacy Act to include information or opinion about such things as an individual's racial or ethnic origin, political opinions, membership of a political association, religious or philosophical beliefs, membership of a trade union or other professional body, criminal record or health information.

Sensitive information will be used by us only:

- For the primary purpose for which it was obtained
- For a secondary purpose that is directly related to the primary purpose
- With your consent; or where required or authorised by law.

Third Parties

Where reasonable and practicable to do so, we will collect your Personal Information only from you. However, in some circumstances we may be provided with information by third parties. In such a case we will take reasonable steps to ensure that you are made aware of the information provided to us by the third party.

Disclosure of Personal Information

Your Personal Information may be disclosed in a number of circumstances including the following:

• Third parties where you consent to the use or disclosure; and

• Where required or authorised by law.

Security of Personal Information

Your Personal Information is stored in a manner that reasonably protects it from misuse and loss and from unauthorized access, modification or disclosure.

When your Personal Information is no longer needed for the purpose for which it was obtained, we will take reasonable steps to destroy or permanently de-identify your Personal Information. However, most of the Personal Information is or will be stored in client files which will be kept by us for a minimum of 7 years.

Access to your Personal Information

You may access the Personal Information we hold about you and to update and/or correct it, subject to certain exceptions. If you wish to access your Personal Information, please contact us in writing.

The Alpine Garden Society Victorian Group will not charge any fee for your access request, but may charge an administrative fee for providing a copy of your Personal Information.

In order to protect your Personal Information we may require identification from you before releasing the requested information.

Maintaining the Quality of your Personal Information

It is an important to us that your Personal Information is up to date. We will take reasonable steps to make sure that your Personal Information is accurate, complete and up-to-date. If you find that the information we have is not up to date or is inaccurate, please advise us as soon as practicable so we can update our records and ensure we can continue to provide quality services to you.
