REAL ESTATE TAXES

You may have received your Fairfax County Real Estate form recently. It appears that over the past two years, the assessments have increased by over 20% +/- in our area. Annual taxes are now over \$9000 +/-. Residents may file appeals with the Fairfax County Department of Tax Administration (Real Estate Division), with an appeal to the Board of Equalization. Appeals must be filed no later than April 3, 2023. DOGS

Please make sure your dog is leashed when in the park

In Fairfax County, dogs are required to be on a leash at all times in public areas unless they're in a designated off-leash area.

Section 41.1-2-4. Unrestricted dogs prohibited; leash law.

(a) No dog shall run unrestricted, as defined in Section 41.1-1-1, in the County. Any person who is the owner of a dog found unrestricted in the County shall be in violation of this Section. This Section shall not apply to any person who uses a dog under his direct supervision while lawfully hunting, while engaged in a supervised formal obedience training class or show, during formally sanctioned field trials, while

a dog is in an area owned, leased, controlled, or operated by Fairfax County designated by resolution of the Board of Supervisors as an off-leash dog exercise area (our parkland is NOT an off-leash area.)

It is a violation of this Section for any owner of a dog to place such dog or allow it to be placed into custody of any person not physically capable of maintaining effective control of restricting such dog.

FYI - Violations of the above are subject to issuance of a summons for violation of this Section. (26-04-41.1; 10-11-41.1.)
