Shandong Province issued the "2024 Policy List to "Promote Economic Consolidation and Improvement and Accelerate Green, Low-carbon and High-Quality Development" (First Batch)"

Luwang reported on January 2 (Reporter Zhao Jiahao) This afternoon, the provincial government's regular policy briefing was held to interpret the "2024 Policy List of "Promoting Economic Consolidation and Improvement and Accelerating Green, Low-carbon and High-Quality Development" (First Batch). The reporter learned from the meeting that the "Policy List" contains two parts:

The first part includes new policies launched in 2024, with a total of 50 items in 7 aspects. Among them, a total of 6 items have been strengthened to assist and benefit enterprises, and further reduce the production and operation costs of enterprises through subsidy support, tax reduction and fee reduction, ensuring enterprise employment, optimizing the business environment, etc. Efforts will be made to expand effective demand, with a total of 9 items, including optimizing assessment rewards, strengthening energy consumption, coal consumption, and land use guarantees, expanding information consumption, promoting the application of new energy vehicles, expanding used car exports, and supporting the attraction of foreign investment projects. Accelerate the development of new industrialization, a total of 10 items, including supporting technological transformation, promoting patent industrialization, subsidizing R&D investment, strengthening the comprehensive utilization of industrial resources, strengthening credit support, etc. Cultivate and strengthen the digital economy, a total of 9 items, including building digital economic parks, supporting the development of integrated circuits, accelerating digital transformation, and subsidizing the construction of digital infrastructure. Support the development of modern service industries, a total of 7 items, including supporting key projects in the service industry, accelerating the development of key industries such as information technology, road transportation, and multimodal transport, and cultivating the inland shipping market. Promote comprehensive rural revitalization, a total of 4 items, including creating a Qilu model demonstration area for rural revitalization, launching a pilot project for the entire industry chain of advantageous and characteristic agriculture, and supporting work-for-relief. Accelerate the green transformation of energy, a total of 5 items, including guiding small coal power units to shut down and exit in advance, and supporting the development of nuclear energy, offshore photovoltaics, geothermal energy, energy storage, etc.

The second part includes 29 policies that will be continued in the 2023 policy list. The main ones are to continue to implement high-speed toll discounts, cultivate innovation carriers, subsidize offshore photovoltaic and wind power projects, support small, medium and micro enterprises, strengthen factor protection, and increase financial support. The other 304 policies in the 2023 policy list will be promoted in four categories: First, 48 policies whose implementation period has expired or completed designated tasks, such as the phased support policy for extremely difficult industries formulated in response to the impact of the epidemic, will be implemented in accordance with national and provincial policies. Relevant arrangements will no longer be implemented; secondly, the 215 policies that have completed phased tasks, such as simple enterprise cancellation, "one license, multiple addresses" and other institutional reforms, as well as the selection of strong agricultural counties and strong quality counties, have been transferred to Normalization work



will no longer be included in the policy list management, and relevant departments will continue to implement it; thirdly, for the 32 policies that need to be further optimized and improved, such as expanding the coverage of patent navigation, adjusting international freight subsidies, etc., the original policies will be withdrawn and the demonstration will be improved. It is included in the policy list as new policies; fourth, 9 policies that need to be further refined and demonstrated according to the requirements of the new situation, such as supporting the cultivation of characteristic industrial clusters of small and medium-sized enterprises, farmland protection incentive measures, etc., will be included in the follow-up after specific deployment by the country and the province. 
