**Pulse of Life Kids Care Center** ("childcare center") and the undersigned parents ("Parents"), by entering into this tuition agreement to enroll their child listed below ("Child") for the 2023 Fall semester, executed by the parents on the signed date below, agree as follows:

- 1. **Consent:** This agreement is entered into with mutual consent of Parents and the childcare center.
- Enrollment deposit: The childcare center requires a \$100 non-refundable enrollment deposit ("Deposit") to reserve a spot for the child in the 2023-2024 year. The Deposit is not credited towards paymen of tuition or fees.
- 3. **Tuition and charges:** Parents agree to pay the full amount for tuition and fees. The tuition and fees may be modified if Parents receive tuition assistance from the childcare center. Any such modifications are only effective if set forth in a written amendment of this agreement, signed by Parents and the childcare center.

the monthly pay tuition plan. If Parents select the monthly plan, equal monthly installments will be paid. Bi-monthly installments must be paid by the **1st and 15th** of every month based on the previous 2 weeks.

- 4. Late fees: Parents understand and agree that a \$5 late fee will be assessed for each business day that payment is not current.
- 5. Additional fees: Parents agree that additional fees for Childcare services may be charged during the 2023-2024 year. Additional fees are due when charged and will be billed and payable through MyBrightwheel.com or paid directly to the Pulse of Life Kids Care Center or a third party designated by Pulse of Life Kids Care Center.
- 6. **Payment obligation:** Parents have an individual and joint obligation to pay all tuition and fees under this agreement. Parents' failure to pay any amount when due pursuant to the terms of this Agreement, may, at the childcare center's sole discretion, result in the suspension or dismissal of the Student from the childcare center. Parents shall pay any costs and attorney's fees the childcare center incurs in collection of Parents' outstanding balance.
- 7. **Early withdrawal/removal:** Parents must provide at least fourteen (14) day signed WRITTEN NOTICE to the Head of the childcare center to withdraw the Child(ren) from the childcare center during the 2023-2024 year. Tuition will be collected during the 14-day notice period, and after the 14-day notice period, Parents will no longer be responsible for tuition payments pursuant to this Agreement.
- 8. **Payment agreement:** Parents understand and agree that the majority of the childcare center's expenses and obligations are incurred on an annual basis, that financial commitments for childcare enter services are made based upon anticipated enrollment, and that the educational operating expenses of childcare center do not diminish with the departure of some students over the course of the childcare center year. Parents understand and agree that, regardless of Student's absence, withdrawal, or dismissal from the childcare center, Parents remain obligated to pay the amount of tuition set forth in sections 3 and 5 of the Agreement, consistent with the 14-day notice period, as liquidated damages and assume full responsibility for payment.
