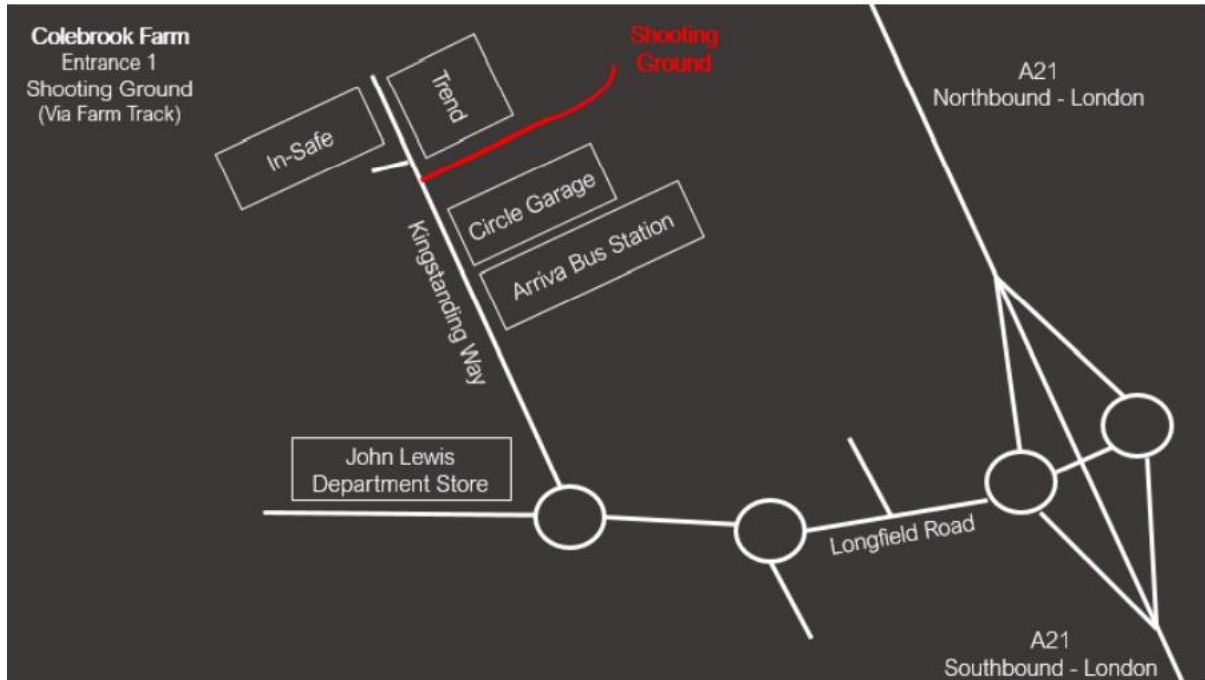

# Direction Maps

## Colebrook – 1

Kingstanding Way, Royal Tunbridge Wells, Kent. TN2 3UP

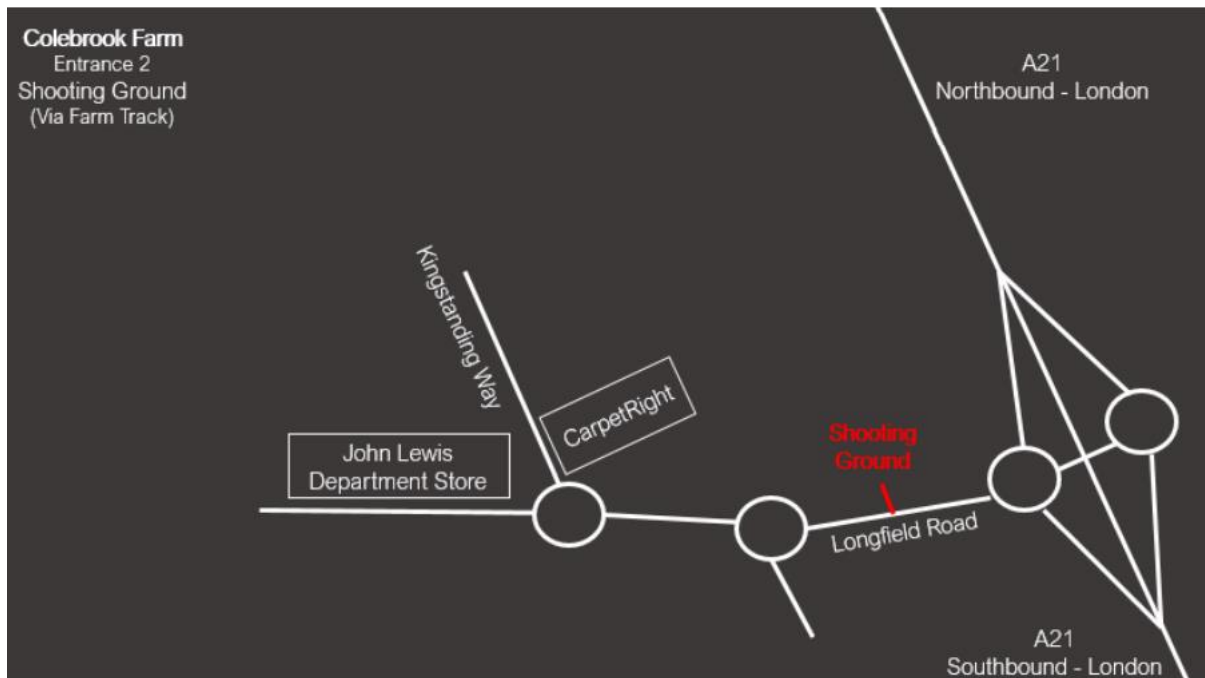


The shooting ground entrance is on the right-hand side of Kingstanding Way. There is a private track 250 yards past the Arriva bus garage and just past the Circle C garage. We shoot at several locations here – Please follow the track and you will find us.



## Colebrook – 2

Longfield Road, Royal Tunbridge Wells, Kent. TN2 3UE

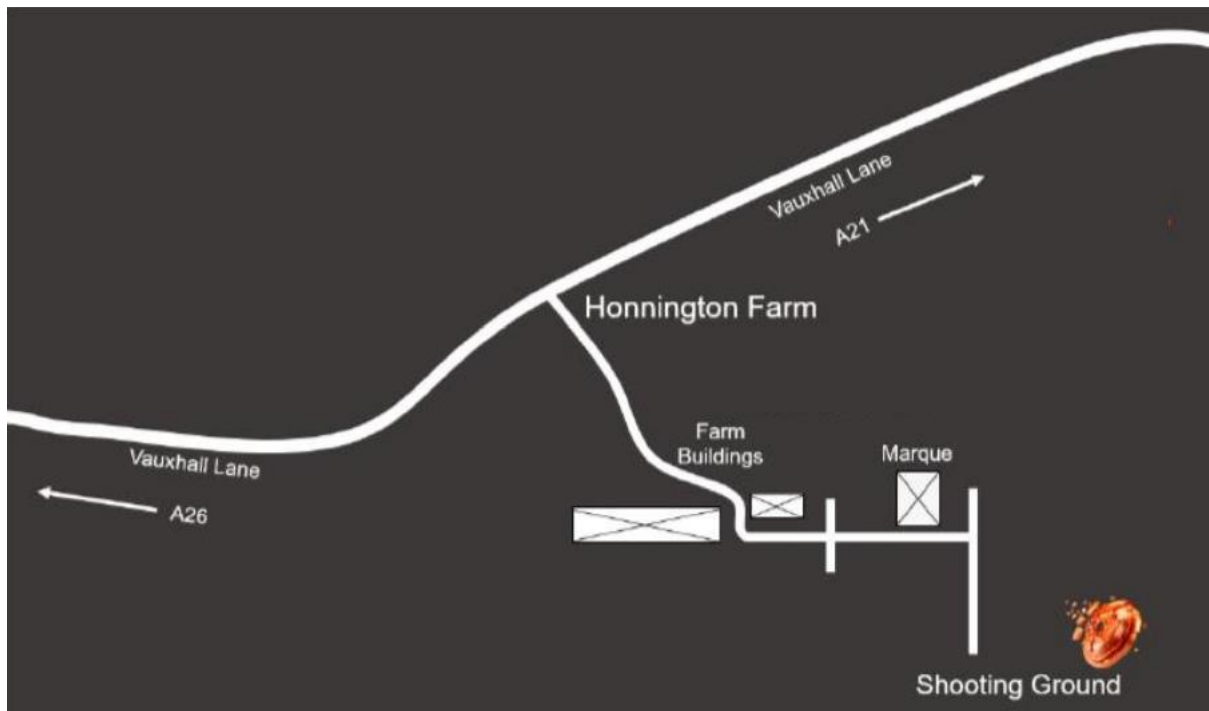


The shooting ground is on the left-hand side of the dual carriageway heading up from Longfield Road towards the A21, approximately 80m from the roundabout.



## Honnington Farm

Vauxhall Lane, Southborough, Kent. TN4 0XD



The Honnington Farm entrance is on the right-hand side of Vauxhall Lane from the A26. When entering though the farm, please keep following the track to the left. Please note that this is a working farm.



We advise that you park somewhere with the main area car park when entering Honnington and walk to the shooting area which is sign posted. This walk is around 500m.

## Bourne Mill

Vauxhall Lane, Southborough, Kent. TN4 0XD.



The Bourne Mill entrance is on the left-hand of Vauxhall Lane (within 30 yards) after the junction with the A21 before you cross the railway line and reach Tonbridge Cottage Hospital.



## Vehicles on Site

Kent & Sussex Shooting School take no liability for your travel on site, car parking and or contents associated with your vehicle. Please note that access to the sites are via farm tracks which are all accessible with care and slow speed.

## Arrival Time

We kindly request that you aim to arrive to your session 15 minutes before you planned session. Please note that if you are late for your session that we may have to reduce your number of shots as we have other sessions planned. No refunds or alternative dates will be offered if late and we can no longer accommodate you and your party.

## Weather

We aim to shoot regardless of the weather, and it is essential that you wear the right clothes for the event. There is no such thing as bad weather only a poor choice of clothes! We shoot from a grass base and therefore we advise the use of strong sturdy footwear for the event with a second set of footwear for the return journey.

## Toilet Facilities

Our shooting ground covers 900 acres and therefore we do not have any toilet facilities, but plenty of bushes.

## Alcohol & Drugs

We want everyone to have a good time, but if we smell alcohol or suspect any persons to be under the influence of alcohol or drugs then they will not be permitted to shoot, and no refund or alternative date will be offered.

## Can I Bring My Shotgun?

You can of course bring your own shotgun, but you must present a valid shotgun certificate when arriving to the ground. Kent & Sussex Shooting School will take over the management of your shotgun whilst on site.

## Legality to Shoot

On arrival to the shooting ground you (and your party) will be asked to sign a declaration statement relating to Section 21 of the Firearms Act 1968. Section 21 applies to anybody who has been sentenced to imprisonment or to youth custody or detention in a young offenders' institution for three months or more.

If the sentence was three months or more but less than three years, the prohibition lasts for five years from the date of their release. If the sentence was greater than three years, then the prohibition extends for life.

It is an offence for a person to transfer, let or hire, give or lend a firearm or ammunition to someone whom he/she knows has reasonable grounds for believing to be prohibited by Section 21. Section 21 of the Firearms Act 1968 covers persons who are banned from being in possession of firearms or ammunition. It is an offence for a shooting range operator to knowingly allow persons who are banned under section 21 from using guns at the range.

## Cancellation/Change of Date

**Over 14 days:** Cancellation charge payable to you is the deposit payment minus an administration charge of 25% of the deposit paid.

**Under 14 days:** Cancellation charge payable by you is 100% of the event fee.

**Change of Date:** If you wish to change the date you must provide more than 14 days' notice. If under 14 days, then this will be classed as a cancellation.
