## MINUTES OF THE MONTHLY MEETING MASTER BOARD OF DIRECTORS VALHALLA MANAGEMENT ASSOCIATION JANUARY 17, 2017

I. <u>Roll Call & Call to Order</u>. The meeting of the Master Board of Directors was held January 17, 2017 at the Valhalla Recreation Center. Brian Kroeger, President called the meeting to order at 7:00 p.m.

- II. <u>Violation Hearings</u>. 4 closed smoking violation hearings were discussed. A motion was made and second to approve proposed fines. No further discussion. Motion carried. Majority Sealed Vote named Wayne Jasperson for Treasurer for 2017. A motion was made and second to approve vote. No further discussion. Motion carried.

Nominations for Secretary – Linda Castiglioni. Castiglioni accepted nomination. A motion was made and second to approve nomination. No further discussion. Motion carried.

V. <u>TREASURER'S REPORT</u>: J. Ohly reported delinquency report is pending for January 2017. There were HOA monthly dues increases in every building except for Building 11. Special assessments were approved in Associations 3, 5, 8 and 9. Reserve requirements of the Master Board have been met for every building. The total for 2017 annual reserves is \$192,502 for the entire complex.

- VII. MANAGER'S REPORT: Judy Ohly has given her resignation effective May 4, 2017. There is a new caretaker for Building 7 effective 12/2016. Garage vacancies no report. Security camera project buildings 6, 7 & 8 approved cameras for 2017 All buildings except building 15 will have security cameras.

Building 5 has been approved for financing by the Department of Veterans Affairs and is now eligible for VA Loan Guaranty. This recognition is a direct result of the owners of Valhalla improving the financial health of Valhalla Condos over this past 2.5 years through increasing reserve funds for capital expenditures.

Ohly requested a one-time exception to process the February 2017 ACH for HOA fees (265 total) be transacted on February 15<sup>th</sup> versus February 9<sup>th</sup>. A motion was made and second to approve. No further discussion. Motion carried.

Ohly reported letters to owners at the end of December 2016 giving notice of changes in HOA monthly dues and special assessments did not include the Master Board's decision to change the day of the month the monthly HOA dues payment is due (5th of the month). A request to reverse this decision and keep the current due date (9th of the month) for 2017 was requested. A motion was made and second to approve keeping due date the 9th of the month for 2017. No further discussion. Motion carried.

- VIII. MAINTENANCE DEPARTMENT REPORT: Judy Ohly reporting for Matt Brown Supervisor; new employee Matt Craft. Training continues with all new hires. Maintenance crew has been working overtime to keep up with ice and snow removal. Leadership is requesting owners are patient with snow and ice removal on Valhalla property. Valhalla has had some recent repairs on equipment. Matt Brown will be on vacation from February 16<sup>th</sup> for approximately 1 week. A motion was made and second to approve \$25 gift cards as a thank you for all maintenance staff. No further discussion. Motion carried.
