- VII. <u>MAINTENANCE DEPARTMENT REPORT</u>: Judy Ohly reporting for Matt Brown Supervisor; Matt Brown is on vacation.

VIII. <u>UNFINISHED BUSINESS</u>:

- A. Owners of a Unit previously assessed a \$50 smoking violation fine are requesting the removal of this fine. Owners have evicted the Tenant violating the smoking ban. A motion was made and seconded to approve the removal of this \$50 smoking violation fine. Motion carried.
- B. Report from General Manager (GM) Search Committee. (See attached Search Committee minutes dated January 23, 2017)
 - 1. Approve revised GM Job Description. The search committee made a few minor changes to the job description. Discussion followed. A motion was made and seconded to approve these minor changes to the GM Job Description. Motion carried.
 - 2. Status on GM search Committee met on January 23rd and February 20th. Committee received several applications and selected six candidates to phone screen. Thus far, two candidates have been selected to interview in-person with Search Committee on Saturday

February 25, 2017. A special Master Board Meeting will be scheduled in early March 2017, if a candidate is selected by the Search Committee.

- IX. NEW BUSINESS: Judy Ohly presented proposed policy changes for Valhalla.
 - A. Proposal to change Article II Valhalla Policy
 - 2.1 The units shall be used and occupied solely for residential purposes, but no Unit shall be used or occupied by more than one family. (Current language in Policy)

Proposal is to delete the following; "but no Unit shall be used or occupied by more than one family."

Proposal is to replace with the following; "and unit owners must abide by the State Housing Code as defined in Section 34: 28-36 for occupancy,"

A motion was made and seconded to approve the above proposal to delete and replace the language as indicated above. Discussion followed. Motion carried.

- B. Proposal to add the following to Article II Valhalla Policy
 - 2.16 Reimbursements to an Owner, or contractor hired by the Owner, for work done within a unit at Valhalla must first be approved, in writing by the General Manager, prior to work beginning.

A motion was made and seconded to approve the above proposal as indicated above. Discussion followed. Motion carried.
